3 (a) DEFINITIONS.—Section 8331 of title 5, United
4 States Code, is amended—

5 (1) by striking "and" at the end of paragraph
6 (24);

7 (2) by striking the period at the end of para-8 graph (25) and inserting "; and"; and

9 (3) by adding at the end the following new10 paragraphs:

11 "(26) 'revenue officer' means an employee of 12 the Internal Revenue Service, the duties of whose 13 position are primarily the collection of delinquent 14 taxes and the securing of delinquent returns, includ-15 ing an employee engaged in this activity who is 16 transferred to a supervisory or administrative posi-17 tion;

18 "(27) 'customs inspector' means an employee of
19 the United States Customs Service, the duties of
20 whose position are primarily to—

21 "(A) enforce laws and regulations govern22 ing the importing and exporting of merchan23 dise;

24 "(B) process and control passengers and25 baggage;

1	"(C) interdict smuggled merchandise and
2	contraband; and
3	"(D) apprehend (if warranted) persons in-
4	volved in violations of customs laws,
5	including an employee engaged in this activity who
6	is transferred to a supervisory or administrative po-
7	sition;
8	''(28) 'customs canine enforcement officer'
9	means an employee of the United States Customs
10	Service, the duties of whose position are primarily to
11	work directly with a dog in an effort to—
12	"(A) enforce laws and regulations govern-
13	ing the importing and exporting of merchan-
14	dise;
15	"(B) process and control passengers and
16	baggage;
17	"(C) interdict smuggled merchandise and
18	contraband; and
19	"(D) apprehend (if warranted) persons in-
20	volved in violations of customs laws,
21	including an employee engaged in this activity who
22	is transferred to a supervisory or administrative po-
23	sition; and
24	"(29) 'Immigration and Naturalization inspec-
25	tor' means an employee of the Immigration and Nat-

uralization Service, the duties of whose position are
primarily the controlling and guarding of the boundaries and borders of the United States against the
illegal entry of aliens, including an employee engaged in this activity who is transferred to a supervisory or administrative position.".

7 (b) DEDUCTIONS, CONTRIBUTIONS, AND DEPOS8 ITS.—Section 8334 of such title is amended—

9 (1) in subsection (a)(1), by striking "a law en-10 forcement officer," and inserting "a law enforcement 11 officer, a revenue officer, a customs inspector, a cus-12 toms canine enforcement officer, an Immigration 13 and Naturalization inspector,"; and

14 (2) in the table in subsection (c), by striking "and firefighter for firefighter service." and insert-15 ing ", firefighter for firefighter service, revenue offi-16 17 cer for revenue officer service, customs inspector for 18 customs inspector service, customs canine enforce-19 ment officer for customs canine enforcement officer 20 service, and Immigration and Naturalization inspector for Immigration and Naturalization inspector 21 22 service".

23 (c) MANDATORY SEPARATION.—Section 8335(b) of
24 such title is amended by striking "law enforcement officer
25 or a firefighter" and inserting "law enforcement officer,

a firefighter, a revenue officer, a customs inspector, a cus toms canine enforcement officer, or an Immigration and
 Naturalization inspector''.

(d) IMMEDIATE RETIREMENT.—Section 8336(c)(1)
of such title is amended by striking "law enforcement officer or firefighter," and inserting "law enforcement officer,
a firefighter, a revenue officer, a customs inspector, a customs canine enforcement officer, or an Immigration and
Naturalization inspector,".

10 SEC. 2. EFFECTIVE DATE.

The amendments made by this Act shall apply with respect to all persons employed as revenue officers of the Internal Revenue Service, customs inspectors and canine enforcement officers of the United States Customs Service, and inspectors of the Immigration and Naturalization Service upon or after the expiration of the 90-day period which begins on the date of the enactment of this Act.
