## A BILL

To direct the President to reorganize the intelligence agencies of the Government in order to reduce duplication and inefficiency and to require that the number of intelligence personnel be reduced by 25 percent over the next five fiscal years.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Intelligence Agencies
- 5 Reorganization Act of 1993".

#### SEC. 2. INTELLIGENCE COMMUNITY REORGANIZATION AND

- 2 **PERSONNEL REDUCTION.**
- 3 (a) Intelligence Community Reorganization.—
- 4 The President shall reorganize the United States Intel-
- 5 ligence Community to reduce redundancy and overlapping
- 6 jurisdiction of intelligence components and to centralize
- 7 (to the extent determined appropriate by the President)
- 8 responsibility and authority for intelligence activities.
- 9 (b) Personnel Reductions.—(1) In implementing
- 10 the reorganization required by subsection (a), the Presi-
- 11 dent shall, for each of fiscal years 1993 through 1997,
- 12 reduce the total number of military and civilian personnel
- 13 employed by, or assigned or detailed to, elements of the
- 14 Intelligence Community by not less than 4 percent of the
- 15 baseline number specified in paragraph (2). The President
- 16 shall direct how such reductions are to be allocated among
- 17 the elements of the Intelligence Community.
- 18 (2) For purposes of paragraph (1), the baseline num-
- 19 ber is the total number of military and civilian personnel
- 20 employed by, or assigned or detailed to, elements of the
- 21 Intelligence Community as of September 30, 1992.
- 22 (3) Reductions in personnel carried out pursuant to
- 23 this subsection for any fiscal year may also be counted
- 24 for that fiscal year for purposes of section 907(b) of Public
- 25 Law 101–510 (104 Stat. 1622).

- 1 (4) Functions and personnel may not be reassigned
- 2 in order to avoid, or reduce the effect of, the reductions
- 3 required by this subsection. Reductions pursuant to this
- 4 section in the number of members of the Armed Forces,
- 5 or the number of civilian personnel, in the Intelligence
- 6 Community shall be matched with corresponding reduc-
- 7 tions in the overall number of members of the Armed
- 8 Forces or of civilian employees of the Government, as the
- 9 case may be.
- 10 (c) Intelligence Community Defined.—For pur-
- 11 poses of this section, the Intelligence Community consists
- 12 of those agencies (and elements of agencies) performing
- 13 intelligence and intelligence-related activities for which
- 14 funds were authorized to be appropriated in Public Law
- 15 102-183.
