## A BILL

To provide for the retrocession of the District of Columbia to the State of Maryland, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "District of Columbia
- 5 Retrocession Act of 1993".
- 6 SEC. 2. RETROCESSION OF DISTRICT OF COLUMBIA TO
- 7 **MARYLAND.**
- 8 (a) In General.—Upon the issuance of a proclama-
- 9 tion by the President under section 7 and except as pro-
- 10 vided in subsection (b), the territory ceded to Congress

- 1 by the State of Maryland to serve as the District constitut-
- 2 ing the permanent seat of the Government of the United
- 3 States is ceded and relinquished to the State of Maryland.
- 4 (b) Continuation of Federal Control Over
- 5 NATIONAL CAPITAL SERVICE AREA.—Notwithstanding
- 6 subsection (a), Congress shall continue to exercise exclu-
- 7 sive legislative authority and control over the District of
- 8 Columbia, which shall consist of the National Capital
- 9 Service Area described in section 4.
- 10 SEC. 3. EFFECT ON JUDICIAL PROCEEDINGS IN DISTRICT
- 11 **OF COLUMBIA.**
- 12 (a) CONTINUATION OF SUITS.—No writ, action, in-
- 13 dictment, cause, or proceeding pending in any court of the
- 14 District of Columbia on the effective date of this Act shall
- 15 abate as a result of the enactment of this Act, but shall
- 16 be transferred and shall proceed within such appropriate
- 17 court of the State of Maryland as established under the
- 18 laws or constitution of the State of Maryland.
- 19 (b) APPEALS.—An order or decision of any court of
- 20 the District of Columbia for which no appeal has been filed
- 21 as of the effective date of this Act shall be considered an
- 22 order or decision of a court of the State of Maryland for
- 23 purposes of appeal from and appellate review of such order
- 24 or decision in an appropriate court of the State of Mary-
- 25 land.

### 1 SEC. 4. NATIONAL CAPITAL SERVICE AREA.

2	(a) Description.—The National Capital Service
3	Area referred to in section 2(b) is comprised of the prin-
4	cipal Federal monuments, the White House, the Capitol
5	Building, the United States Supreme Court Building, and
6	the Federal executive, legislative, and judicial office build-
7	ings located adjacent to the Mall and the Capitol Building
8	(but shall not include the District Building), and is more
9	particularly described as the territory located within the
10	following boundaries:
11	Beginning at the point on the present Virginia-
12	District of Columbia boundary due west of the
13	northernmost point of Theodore Roosevelt Island
14	and running due east of the eastern shore of the Po-
15	tomac River;
16	thence generally south along the shore at the
17	mean high water mark to the northwest corner of
18	the Kennedy Center;
19	thence east along the north side of the Kennedy
20	Center to a point where it reaches the E Street
21	Expressway;
22	thence east on the expressway to E Street
23	Northwest and thence east on E Street Northwest to
24	Nineteenth Street Northwest;
25	thence north on Nineteenth Street Northwest to
26	F Street Northwest;

1	thence east on F Street Northwest to Eight-
2	eenth Street Northwest;
3	thence south on Eighteenth Street Northwest to
4	Constitution Avenue Northwest;
5	thence east on Constitution Avenue to Seven-
6	teenth Street Northwest;
7	thence north on Seventeenth Street Northwest
8	to H Street Northwest;
9	thence east on H Street Northwest to Madison
10	Place Northwest;

14	midchannel of the Washington Channel to a point
15	due west of the northern boundary line of Fort Les-
16	ley McNair;
17	thence due east to the side of the Washington
18	Channel;
19	thence following generally south and east along
20	the side of the Washington Channel at the mean
21	high water mark, to the point of confluence with the
22	Anacostia River, and along the northern shore at the
23	mean high water mark to the northernmost point of
24	the Eleventh Street Bridge:

1	thence generally south and west along such
2	shore at the mean high water mark to the point of
3	confluence of the Anacostia and Potomac Rivers;
4	thence generally south and east along the
5	northern side of the Eleventh Street Bridge to the
6	eastern shore of the Anacostia River;
7	thence generally south along the eastern shore
8	at the mean high water mark of the Potomac River
9	to the point where it meets the present southeastern
10	boundary line of the District of Columbia;
11	thence south and west along such southeastern
12	boundary line to the point where it meets the
13	present Virginia-District of Columbia boundary;
14	thence generally north and west up the Poto-
15	mac River along the Virginia-District of Columbia
16	boundary to the point of beginning.
17	(b) Streets and Sidewalks.—The National Cap-
18	ital Service Area shall include any street (and sidewalk
19	thereof) that bounds such Area.
20	(c) Affronting or Abutting Federal Real
21	Property.—
22	(1) IN GENERAL.—The National Capital Serv-
23	ice Area shall include any Federal real property af
24	fronting or abutting such Area as of the effective
25	date of this Act.

1	(2) Property included.—For purposes of
2	paragraph (1), Federal real property affronting or
3	abutting the National Capital Service Area shall—
4	(A) include the Department of Housing
5	and Urban Development Building, the Depart-
6	ment of Energy Building, Fort Lesley McNair,
7	the Washington Navy Yard, the Anacostia
8	Naval Annex, the United States Naval Station,
9	Bolling Air Force Base, and the Naval Re-
10	search Laboratory; and
11	(B) not include any portion of Rock Creek
12	Park, any portion of Anacostia Park east of the
13	northern side of the Eleventh Street Bridge, or
14	any territory not located in the District of Co-
15	lumbia on the day before the date of the enact-
16	ment of this Act.
17	SEC. 5. TRANSITION PROVISIONS RELATING TO HOUSE OF
18	REPRESENTATIVES.
19	(a) Temporary Increase in Apportionment.—
20	(1) IN GENERAL.—Until the taking effect of the
21	first reapportionment occurring after the effective
22	date of this Act—
23	(A) the individual serving as the Delegate
24	to the House of Representatives from the Dis-
25	trict of Columbia shall serve as a member of

the House of Representatives from the State of 1 2 Maryland; 3 (B) the State of Maryland shall be entitled 4 to 1 additional Representative until the taking effect of such reapportionment; and 5 6 (C) such Representative shall be in addi-7 tion to the membership of the House of Rep-8 resentatives as now prescribed by law. 9 (2) Increase not counted against total 10 NUMBER OF MEMBERS.—The temporary increase in 11 the membership of the House of Representatives provided under paragraph (1) shall not operate to ei-12 13 ther increase or decrease the permanent membership 14 of the House of Representatives as prescribed in the 15 Act of August 8, 1911 (37 Stat. 13; 2 U.S.C. 2), 16 nor shall such temporary increase affect the basis of 17 reapportionment established by the Act of November 18 15, 1941 (55 Stat. 761; 2 U.S.C. 2a), for the 82nd 19 Congress and each Congress thereafter. 20 (b) Repeal of Laws Providing for Delegate FROM THE DISTRICT OF COLUMBIA.—Sections 202 and 21 204 of the District of Columbia Delegate Act (Public Law

91–405; sections 1–401 and 1–402, D.C. Code) are re-

pealed, and the provisions of law amended or repealed by

- 1 such sections are restored or revived as if such sections
- 2 had not been enacted.
- 3 SEC. 6. EFFECT ON OTHER LAWS.
- 4 No law or regulation which is in force on the effective
- 5 date of this Act shall be deemed amended or repealed by
- 6 this Act except to the extent specifically provided in this
- 7 Act, or to the extent that such law or regulation is incon-
- 8 sistent with this Act.
- 9 SEC. 7. PROCLAMATION REGARDING ACCEPTANCE OF RET-
- 10 ROCESSION BY MARYLAND.
- Not later than 30 days after the State of Maryland
- 12 enacts legislation accepting the retrocession described in
- 13 section 2(a), the President shall issue a proclamation an-
- 14 nouncing such acceptance and declaring that the territory
- 15 ceded to Congress by the State of Maryland to serve as
- 16 the District constituting the permanent seat of the Gov-
- 17 ernment of the United States has been ceded back to the
- 18 State of Maryland.
- 19 SEC. 8. EFFECTIVE DATE.
- The provisions of this Act and the amendments made
- 21 by this Act shall take effect on the date the President is-
- 22 sues a proclamation under section 7 or the date of the
- 23 ratification of an amendment to the Constitution of the
- 24 United States repealing the twenty-third article of amend-
- 25 ment to the Constitution, whichever comes later.
