AN ACT

To amend the Public Health Service Act to extend the program of grants regarding the prevention and control of sexually transmitted diseases.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Sexually Transmitted
5 Diseases Amendments of 1993”.

1 **SEC. 2. EXTENSION OF PROGRAM OF GRANTS REGARDING**
2 **PREVENTION AND CONTROL OF SEXUALLY**
3 **TRANSMITTED DISEASES.**

4 (a) EXTENSION OF PROGRAM.—Section 318(d)(1) of
5 the Public Health Service Act (42 U.S.C. 247c(d)(1)) is
6 amended in the first sentence by striking “there are au-
7 thorized” and all that follows and inserting the following:
8 “there are authorized to be appropriated \$80,000,000 for
9 fiscal year 1994, and such sums as may be necessary for
10 each of the fiscal years 1995 through 1998.”.

11 (b) TECHNICAL CORRECTIONS.—Section 318 of the
12 Public Health Service Act (42 U.S.C. 247c) is amended—

13 (1) in subsection (b)(3), by striking “, and”
14 and inserting “; and”; and

15 (2) in subsection (d)(5)—

16 (A) in subparagraph (A), by striking
17 “form, or” and inserting “form, or;” and

18 (B) in subparagraph (B), by striking “pur-
19 poses,” and inserting “purposes;”.

20 **SEC. 3. EXTENSION OF PROGRAM REGARDING PREVENT-**
21 **ABLE CASES OF INFERTILITY ARISING AS RE-**
22 **SULT OF SEXUALLY TRANSMITTED DISEASES.**

23 (a) TECHNICAL CORRECTIONS.—

24 (1) AMENDATORY INSTRUCTIONS.—Section 304
25 of Public Law 102–531 (106 Stat. 3490) is amend-
26 ed—

1 (A) by striking “Part A of title III” and
2 inserting “Part B of title III”; and

3 (B) by striking “241 et seq.” and inserting
4 “243 et seq.”.

5 (2) CROSS-REFERENCE.—Section 318A of the
6 Public Health Service Act (42 U.S.C. 247c–1), as
7 added by section 304 of Public Law 102–531 (106
8 Stat. 3490), is amended in subsection (o)(2) by
9 striking “subsection (s)” and inserting “subsection
10 (q)”.

11 (b) EXTENSION OF PROGRAM.—Section 318A of the
12 Public Health Service Act (42 U.S.C. 247c–1), as added
13 by section 304 of Public Law 102–531 (106 Stat. 3490),
14 is amended—

15 (1) in subsection (q), by striking “and 1995”
16 and inserting “through 1998”; and

17 (2) in subsection (r)(2), by striking “through
18 1995” and inserting “through 1998”.
