## AN ACT

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 1994, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*  
3       That the following sums are appropriated, out of any  
4       money in the Treasury not otherwise appropriated, for the  
5       Legislative Branch for the fiscal year ending September  
6       30, 1994, and for other purposes, namely:

1 TITLE I—CONGRESSIONAL OPERATIONS  
2 HOUSE OF REPRESENTATIVES  
3 SALARIES AND EXPENSES (PRIOR YEAR)  
4 (RESCISSION)

5 Of the funds appropriated in the Legislative Branch  
6 Appropriations Act, 1991, for the House of Representa-  
7 tives under the heading “SALARIES AND EXPENSES”,  
8 there is rescinded a total \$730,037.41, in the amounts  
9 specified for the following headings and accounts:

10 (1) “HOUSE LEADERSHIP OFFICES”,  
11 \$24,988.44, as follows: (A) “Office of the Speaker”,  
12 \$5,245.00; (B) “Office of the Majority Leader”,  
13 \$4,743.44; (C) “Office of the Minority Leader”,  
14 \$5,000.00; (D) “Office of the Majority Whip”,

14        Of the funds appropriated in the Legislative Branch  
15    Appropriations Act, 1993, for the House of Representa-  
16    tives under the heading “SALARIES AND EXPENSES”,  
17    there is rescinded a total of \$1,500,000 in the amounts  
18    specified for the following heading: “STANDING COMMIT-  
19    TEES, SPECIAL AND SELECT”.

20                                   SALARIES AND EXPENSES

21        For salaries and expenses of the House of Represent-  
22    atives, \$686,318,000, as follows:

23                                   HOUSE LEADERSHIP OFFICES

24        For salaries and expenses, as authorized by law,  
25    \$5,871,000, including: Office of the Speaker, \$1,395,000,  
26    including \$25,000 for official expenses of the Speaker; Of-

1 fice of the Majority Floor Leader, \$1,003,000, including  
2 \$10,000 for official expenses of the Majority Leader; Of-  
3 fice of the Minority Floor Leader, \$1,383,000, including  
4 \$10,000 for official expenses of the Minority Leader; Of-  
5 fice of the Majority Whip, \$1,235,000, including \$5,000  
6 for official expenses of the Majority Whip and not to ex-  
7 ceed \$539,600, for the Chief Deputy Majority Whips; and  
8 Office of the Minority Whip, \$855,000, including \$5,000  
9 for official expenses of the Minority Whip and not to ex-  
10 ceed \$97,980, for the Chief Deputy Minority Whip.

11 MEMBERS' CLERK HIRE

12 For staff employed by each Member in the discharge  
13 of official and representative duties, \$225,004,000.

15 For professional and clerical employees of standing  
16 committees, including the Committee on Appropriations  
17 and the Committee on the Budget, \$70,445,000.

18 COMMITTEE ON THE BUDGET (STUDIES)

19 For salaries, expenses, and studies by the Committee  
20 on the Budget, and temporary personal services for such  
21 committee to be expended in accordance with sections  
22 101(c), 606, 703, and 901(e) of the Congressional Budget  
23 Act of 1974, and to be available for reimbursement to  
24 agencies for services performed, \$389,000.

1           STANDING COMMITTEES, SPECIAL AND SELECT

2           For salaries and expenses of standing committees,  
3 special and select, authorized by the House, \$52,662,000.

4                       COMMITTEE ON HOUSE ADMINISTRATION

5                               HOUSE INFORMATION SYSTEMS

6           For salaries, expenses and temporary personal serv-  
7 ices of House Information Systems, under the direction  
8 of the Committee on House Administration, \$22,885,000,  
9 of which \$14,557,000 is provided herein: *Provided*, That  
10 House Information Systems is authorized to receive reim-  
11 bursement for services provided from Members of the  
12 House of Representatives and other Governmental entities  
13 and such reimbursement shall be deposited in the Treas-  
14 ury for credit to this account: *Provided further*, That  
15 amounts so credited for fiscal year 1993 and not obligated  
16 shall be available for obligation in fiscal year 1994.

17                               ALLOWANCES AND EXPENSES

18           For allowances and expenses as authorized by House  
19 resolution or law, \$220,812,000, including: Official Ex-  
20 penses of Members, \$76,545,000; supplies, materials, ad-  
21 ministrative costs and Federal tort claims, \$11,328,000;  
22 net expenses of purchase, lease and maintenance of office  
23 equipment, \$7,196,000; net expenses for telecommuni-  
24 cations, \$5,960,000; furniture and furnishings,  
25 \$1,720,000; stenographic reporting of committee hearings,  
26 \$1,055,000; reemployed annuitants reimbursements,

1 \$933,000; Government contributions to employees' life in-  
2 surance fund, retirement funds, Social Security fund,  
3 Medicare fund, health benefits fund, and worker's and un-  
4 employment compensation, \$115,314,000; and miscellane-  
5 ous items including purchase, exchange, maintenance, re-  
6 pair and operation of House motor vehicles,  
7 interparliamentary receptions, and gratuities to heirs of  
8 deceased employees of the House, \$761,000.

9 CHILD CARE CENTER

10 For salaries and expenses of the House of Represent-  
11 atives Child Care Center, such amounts as are deposited  
12 in the account established by section 312(d)(1) of the Leg-  
13 islative Branch Appropriations Act, 1992 (40 U.S.C.  
14 184g(d)(1)), subject to the level specified in the budget  
15 of the Center, as submitted to the Committee on Appro-  
16 priations of the House of Representatives.

17 COMMITTEE ON APPROPRIATIONS (STUDIES AND  
18 INVESTIGATIONS)

19 For salaries and expenses, studies and examinations  
20 of executive agencies, by the Committee on Appropria-  
21 tions, and temporary personal services for such committee,  
22 to be expended in accordance with section 202(b) of the  
23 Legislative Reorganization Act of 1946, and to be avail-  
24 able for reimbursement to agencies for services performed,  
25 \$6,431,000.



## 1 OFFICIAL MAIL COSTS

2 For expenses necessary for official mail costs of the  
3 House of Representatives, as authorized by law,  
4 \$40,000,000.

## 5 SALARIES, OFFICERS AND EMPLOYEES

6 For compensation and expenses of officers and em-  
7 ployees, as authorized by law, \$50,147,000, including: Of-  
8 fice of the Clerk, including not to exceed \$1,000 for official  
9 representation and reception expenses, \$11,947,000; Of-  
10 fice of the Sergeant at Arms, including not to exceed \$500  
11 for official representation and reception expenses,  
12 \$1,384,000; Office of the Doorkeeper, including overtime,  
13 as authorized by law, \$10,101,000; Office of Director of  
14 Non-legislative and Financial Services, \$14,402,000; for  
15 the salaries and expenses of the Office of General Counsel,  
16 \$674,000; Office of the Chaplain, \$123,000; Office of the  
17 Parliamentarian, including the Parliamentarian and  
18 \$2,000 for preparing the Digest of Rules, \$898,000; for  
19 salaries and expenses of the Office of the Historian,  
20 \$310,000; for salaries and expenses of the Office of the  
21 Law Revision Counsel of the House, \$1,453,000; for sala-  
22 ries and expenses of the Office of the Legislative Counsel  
23 of the House, \$4,071,000; six minority employees,  
24 \$738,000; the House Democratic Steering and Policy  
25 Committee and the Democratic Caucus, \$1,474,000; the

1 House Republican Conference, \$1,474,000; and other au-  
2 thorized employees, \$1,098,000.

3 ADMINISTRATIVE PROVISIONS

4 SEC. 101. (a) Upon the transfer of any function to  
5 the Director of Non-legislative and Financial Services by  
6 the authority of the Committee on House Administration  
7 pursuant to rule X of the House of Representatives and  
8 upon the commencement of operation of the Office of In-  
9 spector General, the applicable amounts appropriated by  
10 the Legislative Branch Appropriations Act, 1992, or by  
11 this Act, for the purposes specified in subsection (b) shall  
12 be available to the Director and the Office of Inspector  
13 General for the carrying out of such function or operation,  
14 upon the approval of the Committee on Appropriations of  
15 the House of Representatives. In no case shall the transfer  
16 of any function referred to in the preceding sentence in-  
17 clude the transfer of any function of the Capitol Guide  
18 Service.

19 (b) The purposes referred to in subsection (a) are sal-  
20 aries and expenses of the House of Representatives under  
21 the headings "ALLOWANCES AND EXPENSES" and "SALA-  
22 RIES, OFFICERS AND EMPLOYEES".

23 SEC. 101A. (a) House Resolution 1238, Ninety-first  
24 Congress, agreed to December 22, 1970 (as enacted into  
25 permanent law by chapter VIII of the Supplemental Ap-

1 appropriations Act, 1971, and supplemented by the Act enti-  
2 tled "An Act relating to former Speakers of the House  
3 of Representatives" (88 Stat. 1723)) (2 U.S.C. 31b-1 et  
4 seq.) is amended by adding at the end the following new  
5 section:

6 "SEC. 8. The entitlements of a former Speaker of the  
7 House of Representatives under this resolution shall be  
8 available—

9 "(1) in the case of an individual who is a  
10 former Speaker on the effective date of this section,  
11 for 5 years, commencing on such effective date; and

12 "(2) in the case of an individual who becomes  
13 a former Speaker after such effective date, for 5  
14 years, commencing at the expiration of the term of  
15 office of the individual as a Representative in Con-  
16 gress.".

17 (b) The amendment made by subsection (a) shall take  
18 effect on October 1, 1993.

22 For salaries and expenses of the Joint Economic  
23 Committee, \$3,980,000, to be disbursed by the Secretary  
24 of the Senate.

## 1 JOINT COMMITTEE ON PRINTING

2 For salaries and expenses of the Joint Committee on  
3 Printing, \$1,377,000, to be disbursed by the Secretary of  
4 the Senate.

## 5 JOINT COMMITTEE ON TAXATION

6 For salaries and expenses of the Joint Committee on  
7 Taxation, \$5,701,000, to be disbursed by the Clerk of the  
8 House.

9 For other joint items, as follows:

## 10 OFFICE OF THE ATTENDING PHYSICIAN

11 For medical supplies, equipment, and contingent ex-  
12 penses of the emergency rooms, and for the Attending  
13 Physician and his assistants, including (1) an allowance  
14 of \$1,500 per month to the Attending Physician; (2) an  
15 allowance of \$500 per month each to two medical officers  
16 while on duty in the Attending Physician's office; (3) an  
17 allowance of \$500 per month each to two assistants and  
18 \$400 per month each to not to exceed nine assistants on  
19 the basis heretofore provided for such assistance; and (4)  
20 \$1,002,000 for reimbursement to the Department of the  
21 Navy for expenses incurred for staff and equipment as-  
22 signed to the Office of the Attending Physician, which  
23 shall be advanced and credited to the applicable appropria-  
24 tion or appropriations from which such salaries, allow-  
25 ances, and other expenses are payable and shall be avail-

1 able for all the purposes thereof, \$1,502,000, to be dis-  
2 bursed by the Clerk of the House.

3                                   CAPITOL POLICE BOARD

4                                   CAPITOL POLICE

5                                   SALARIES

6           For the Capitol Police Board for salaries, including  
7 overtime, and Government contributions to employees'  
8 benefits funds, as authorized by law, of officers, members,  
9 and employees of the Capitol Police, \$62,255,000, of  
10 which \$29,453,000 is provided to the Sergeant at Arms  
11 of the House of Representatives, to be disbursed by the  
12 Clerk of the House, and \$32,802,000 is provided to the  
13 Sergeant at Arms and Doorkeeper of the Senate, to be  
14 disbursed by the Secretary of the Senate: *Provided*, That  
15 of the amounts appropriated for fiscal year 1994 for sala-  
16 ries, including overtime, and Government contributions to  
17 employees' benefits funds under this heading, such  
18 amounts as may be necessary may be transferred between  
19 the Sergeant at Arms of the House of Representatives and  
20 the Sergeant at Arms and Doorkeeper of the Senate, upon  
21 approval of the Committee on Appropriations of the House  
22 of Representatives and the Committee on Appropriations  
23 of the Senate.

## 1 GENERAL EXPENSES

2 For the Capitol Police Board for necessary expenses  
3 of the Capitol Police, including motor vehicles, commu-  
4 nications and other equipment, uniforms, weapons, sup-  
5 plies, materials, training, medical services, the employee  
6 assistance program, not more than \$2,000 for the awards  
7 program, postage, telephone service, travel advances, relo-  
8 cation of instructor and liaison personnel for the Federal  
9 Law Enforcement Training Center, and \$85 per month  
10 for extra services performed for the Capitol Police Board  
11 by an employee of the Sergeant at Arms of the Senate  
12 or the House of Representatives designated by the Chair-  
13 man of the Board, \$1,977,000, to be disbursed by the  
14 Clerk of the House of Representatives: *Provided*, That,  
15 notwithstanding any other provision of law, the cost of  
16 basic training for the Capitol Police at the Federal Law  
17 Enforcement Training Center for fiscal year 1994 shall  
18 be paid by the Secretary of the Treasury from funds avail-  
19 able to the Department of the Treasury.

## 20 ADMINISTRATIVE PROVISION

21 SEC. 102. Amounts appropriated for fiscal year 1994  
22 for the Capitol Police Board under the heading "CAPITOL  
23 POLICE" may be transferred between the headings "SALA-  
24 RIES" and "GENERAL EXPENSES", upon approval of the

1 Committees on Appropriations of the Senate and the  
2 House of Representatives.

3                                   CAPITOL GUIDE SERVICE

4       For salaries and expenses of the Capitol Guide Serv-  
5 ice, \$1,628,000, to be disbursed by the Secretary of the  
6 Senate: *Provided*, That none of these funds shall be used  
7 to employ more than thirty-three individuals: *Provided fur-*  
8 *ther*, That the Capitol Guide Board is authorized, during  
9 emergencies, to employ not more than two additional indi-  
10 viduals for not more than one hundred twenty days each,  
11 and not more than ten additional individuals for not more  
12 than six months each, for the Capitol Guide Service.

13                                   SPECIAL SERVICES OFFICE

14       For salaries and expenses of the Special Services Of-  
15 fice, \$363,000, to be disbursed by the Secretary of the  
16 Senate.

17                                   OFFICE OF TECHNOLOGY ASSESSMENT

18   SALARIES AND EXPENSES

19       For salaries and expenses necessary to carry out the  
20 provisions of the Technology Assessment Act of 1972  
21 (Public Law 92-484), including official reception and rep-  
22 resentation expenses (not to exceed \$5,500 from the Trust  
23 Fund), and expenses incurred in administering an em-  
24 ployee incentive awards program (not to exceed \$2,500),  
25 rental of space in the District of Columbia, \$20,815,000:

1 *Provided*, That none of the funds in this Act shall be avail-  
2 able for salaries or expenses of any employee of the Office  
3 of Technology Assessment in excess of 143 staff employ-  
4 ees: *Provided further*, That no part of this appropriation  
5 shall be available for assessments or activities not initiated  
6 and approved in accordance with section 3(d) of Public  
7 Law 92-484: *Provided further*, That none of the funds in  
8 this Act shall be available for salaries or expenses of em-  
9 ployees of the Office of Technology Assessment in connec-  
10 tion with any reimbursable study for which funds are pro-  
11 vided from sources other than appropriations made under  
12 this Act, or shall be available for any other administrative  
13 expenses incurred by the Office of Technology Assessment  
14 in carrying out such a study.

#### 15 CONGRESSIONAL BUDGET OFFICE

#### 16 SALARIES AND EXPENSES

17 For salaries and expenses necessary to carry out the  
18 provisions of the Congressional Budget Act of 1974 (Pub-  
19 lic Law 93-344), including not to exceed \$2,500 to be ex-  
20 pended on the certification of the Director of the Congres-  
21 sional Budget Office in connection with official representa-  
22 tion and reception expenses, \$22,317,000: *Provided*, That  
23 none of these funds shall be available for the purchase or  
24 hire of a passenger motor vehicle: *Provided further*, That  
25 none of the funds in this Act shall be available for salaries



1 or expenses of any employee of the Congressional Budget  
2 Office in excess of 226 staff employees: *Provided further,*  
3 That any sale or lease of property, supplies, or services  
4 to the Congressional Budget Office shall be deemed to be  
5 a sale or lease of such property, supplies, or services to  
6 the Congress subject to section 903 of Public Law  
7 98-63.

## 8 ARCHITECT OF THE CAPITOL

### 9 OFFICE OF THE ARCHITECT OF THE CAPITOL

#### 10 SALARIES

11 For the Architect of the Capitol; the Assistant Archi-  
12 tect of the Capitol; and other personal services; at rates  
13 of pay provided by law, \$8,762,000.

#### 14 TRAVEL

15 Appropriations under the control of the Architect of  
16 the Capitol shall be available for expenses of travel on offi-  
17 cial business not to exceed in the aggregate under all  
18 funds the sum of \$20,000.

#### 19 CONTINGENT EXPENSES

20 To enable the Architect of the Capitol to make sur-  
21 veys and studies, and to meet unforeseen expenses in con-  
22 nection with activities under his care, \$100,000, to remain  
23 available until expended.

## 1                   CAPITOL BUILDINGS AND GROUNDS

## 2                                   CAPITOL BUILDINGS

3           For all necessary expenses for the maintenance, care  
4 and operation of the Capitol and electrical substations of  
5 the Senate and House office buildings, under the jurisdic-  
6 tion of the Architect of the Capitol, including furnishings  
7 and office equipment; including not to exceed \$1,000 for  
8 official reception and representation expenses, to be ex-  
9 pended as the Architect of the Capitol may approve; pur-  
10 chase or exchange, maintenance and operation of a pas-  
11 senger motor vehicle; and attendance, when specifically  
12 authorized by the Architect of the Capitol, at meetings or  
13 conventions in connection with subjects related to work  
14 under the Architect of the Capitol, \$23,978,000, of which  
15 \$4,663,000 shall remain available until expended.

## 16                                   CAPITOL GROUNDS

17           For all necessary expenses for care and improvement  
18 of grounds surrounding the Capitol, the Senate and House  
19 office buildings, and the Capitol Power Plant, \$5,289,000,  
20 of which \$225,000 shall remain available until expended.

## 21                                   HOUSE OFFICE BUILDINGS

22           For all necessary expenses for the maintenance, care  
23 and operation of the House office buildings, including the  
24 position of Superintendent of Garages as authorized by  
25 law, \$32,287,000, of which \$2,400,000 shall remain avail-  
26 able until expended.

## CAPITOL POWER PLANT

1  
2 For all necessary expenses for the maintenance, care  
3 and operation of the Capitol Power Plant; lighting, heat-  
4 ing, power (including the purchase of electrical energy)  
5 and water and sewer services for the Capitol, Senate and  
6 House office buildings, Library of Congress buildings, and  
7 the grounds about the same, Botanic Garden, Senate ga-  
8 rage, and air conditioning refrigeration not supplied from  
9 plants in any of such buildings; heating the Government  
10 Printing Office and Washington City Post Office; and  
11 heating and chilled water for air conditioning for the Su-  
12 preme Court Building, Union Station complex, Thurgood  
13 Marshall Federal Judiciary Building and the Folger  
14 Shakespeare Library, expenses for which shall be ad-  
15 vanced or reimbursed upon request of the Architect of the  
16 Capitol and amounts so received shall be deposited into  
17 the Treasury to the credit of this appropriation,  
18 \$32,777,000, of which \$665,000 shall remain available  
19 until expended: *Provided*, That not to exceed \$3,200,000  
20 of the funds credited or to be reimbursed to this appro-  
21 priation as herein provided shall be available for obligation  
22 during fiscal year 1994.

1 LIBRARY OF CONGRESS  
2 CONGRESSIONAL RESEARCH SERVICE  
3 SALARIES AND EXPENSES

4 For necessary expenses to carry out the provisions  
5 of section 203 of the Legislative Reorganization Act of  
6 1946, (2 U.S.C. 166) and to revise and extend the Anno-  
7 tated Constitution of the United States of America,  
8 \$56,718,000: *Provided*, That no part of this appropriation  
9 may be used to pay any salary or expense in connection  
10 with any publication, or preparation of material therefor  
11 (except the Digest of Public General Bills), to be issued  
12 by the Library of Congress unless such publication has  
13 obtained prior approval of either the Committee on House  
14 Administration of the House of Representatives or the  
15 Committee on Rules and Administration of the Senate:  
16 *Provided further*, That, notwithstanding any other provi-  
17 sion of law, the compensation of the Director of the Con-  
18 gressional Research Service, Library of Congress, shall be  
19 at an annual rate which is equal to the annual rate of  
20 basic pay for positions at level IV of the Executive Sched-  
21 ule under section 5315 of title 5, United States Code.

22 GOVERNMENT PRINTING OFFICE  
23 CONGRESSIONAL PRINTING AND BINDING

24 For authorized printing and binding for the Congress  
25 and the distribution of Congressional information in any

1 format; printing and binding for the Architect of the Cap-  
2 itol; expenses necessary for preparing the semimonthly  
3 and session index to the Congressional Record, as author-  
4 ized by law (44 U.S.C. 902); printing and binding of Gov-  
5 ernment publications authorized by law to be distributed  
6 to Members of Congress; and printing, binding, and dis-  
7 tribution of Government publications authorized by law to  
8 be distributed without charge to the recipient,  
9 \$88,404,000: *Provided*, That this appropriation shall not  
10 be available for printing and binding part 2 of the annual  
11 report of the Secretary of Agriculture (known as the Year-  
12 book of Agriculture) nor for copies of the permanent edi-  
13 tion of the Congressional Record for individual Represent-  
14 atives, Resident Commissioners or Delegates authorized  
15 under 44 U.S.C. 906: *Provided further*, That this appro-  
16 priation shall be available for the payment of obligations  
17 incurred under the appropriations for similar purposes for  
18 preceding fiscal years.

19 This title may be cited as the “Congressional Oper-  
20 ations Appropriations Act, 1994”.

## 21 TITLE II—OTHER AGENCIES

### 22 BOTANIC GARDEN

#### 23 SALARIES AND EXPENSES

24 For all necessary expenses for the maintenance, care  
25 and operation of the Botanic Garden and the nurseries,

1 buildings, grounds, and collections; and purchase and ex-  
2 change, maintenance, repair, and operation of a passenger  
3 motor vehicle; all under the direction of the Joint Commit-  
4 tee on the Library, \$3,008,000.

5 LIBRARY OF CONGRESS

6 SALARIES AND EXPENSES

7 For necessary expenses of the Library of Congress,  
8 not otherwise provided for, including development and  
9 maintenance of the Union Catalogs; custody and custodial  
10 care of the Library Buildings; special clothing; cleaning,  
11 laundering and repair of uniforms; preservation of motion  
12 pictures in the custody of the Library; operation and  
13 maintenance of the American Folklife Center in the Li-  
14 brary; preparation and distribution of catalog cards and  
15 other publications of the Library; hire or purchase of one  
16 passenger motor vehicle; and expenses of the Library of  
17 Congress Trust Fund Board not properly chargeable to  
18 the income of any trust fund held by the Board,  
19 \$201,231,000, of which not more than \$7,500,000 shall  
20 be derived from collections credited to this appropriation  
21 during fiscal year 1994 under the Act of June 28, 1902  
22 (chapter 1301; 32 Stat. 480; 2 U.S.C. 150): *Provided*,  
23 That the total amount available for obligation shall be re-  
24 duced by the amount by which collections are less than  
25 the \$7,500,000: *Provided further*, That of the total

1 amount appropriated, \$8,127,000 is to remain available  
2 until expended for acquisition of books, periodicals, and  
3 newspapers, and all other materials including subscrip-  
4 tions for bibliographic services for the Library, including  
5 \$40,000 to be available solely for the purchase, when spe-  
6 cifically approved by the Librarian, of special and unique  
7 materials for additions to the collections.

8 COPYRIGHT OFFICE

9 SALARIES AND EXPENSES

10 For necessary expenses of the Copyright Office, in-  
11 cluding publication of the decisions of the United States  
12 courts involving copyrights, \$26,244,000, of which not  
13 more than \$14,500,000 shall be derived from collections  
14 credited to this appropriation during fiscal year 1994  
15 under 17 U.S.C. 708(c), and not more than \$2,333,000  
16 shall be derived from collections during fiscal year 1994  
17 under 17 U.S.C. 111(d)(2), 119(b)(2), and 1005: *Pro-*  
18 *vided*, That the total amount available for obligation shall  
19 be reduced by the amount by which collections are less  
20 than \$16,833,000: *Provided further*, That \$100,000 of the  
21 amount appropriated is available for the maintenance of  
22 an “International Copyright Institute” in the Copyright  
23 Office of the Library of Congress for the purpose of train-  
24 ing nationals of developing countries in intellectual prop-  
25 erty laws and policies: *Provided further*, That not to exceed

1 \$2,250 may be expended on the certification of the Librar-  
2 ian of Congress or his designee, in connection with official  
3 representation and reception expenses for activities of the  
4 International Copyright Institute.

5 BOOKS FOR THE BLIND AND PHYSICALLY HANDICAPPED  
6 SALARIES AND EXPENSES

7 For salaries and expenses to carry out the provisions  
8 of the Act of March 3, 1931 (chapter 400; 46 Stat. 1487;  
9 2 U.S.C. 135a), \$43,144,000, of which \$10,377,000 shall  
10 remain available until expended.

11 FURNITURE AND FURNISHINGS

12 For necessary expenses for the purchase and repair  
13 of furniture, furnishings, office and library equipment,  
14 \$3,939,000: *Provided*, That of those funds that remain  
15 available until expended, up to \$593,000 may be trans-  
16 ferred to the Architect of the Capitol appropriation “Li-  
17 brary Buildings and Grounds, Structural and Mechanical  
18 Care” to complete renovation and restoration work on the  
19 Thomas Jefferson and John Adams Buildings.

20 ADMINISTRATIVE PROVISIONS

21 SEC. 201. Appropriations in this Act available to the  
22 Library of Congress shall be available, in an amount not  
23 to exceed \$175,690, of which \$54,800 is for the Congres-  
24 sional Research Service, when specifically authorized by  
25 the Librarian, for attendance at meetings concerned with



1 the function or activity for which the appropriation is  
2 made.

3 SEC. 202. (a) No part of the funds appropriated in  
4 this Act shall be used by the Library of Congress to ad-  
5 minister any flexible or compressed work schedule which—

6 (1) applies to any manager or supervisor in a  
7 position the grade or level of which is equal to or  
8 higher than GS-15; and

9 (2) grants such manager or supervisor the right  
10 to not be at work for all or a portion of a workday  
11 because of time worked by the manager or super-  
12 visor on another workday.

13 (b) For purposes of this section, the term “manager  
14 or supervisor” means any management official or super-  
15 visor, as such terms are defined in section 7103(a) (10)  
16 and (11) of title 5, United States Code.

17 SEC. 203. Appropriated funds received by the Library  
18 of Congress from other Federal agencies to cover general  
19 and administrative overhead costs generated by perform-  
20 ing reimbursable work for other agencies under the au-  
21 thority of 31 U.S.C. 1535 and 1536 shall not be used to  
22 employ more than 65 employees and may be expended or  
23 obligated—

1           (1) in the case of a reimbursement, only to such  
2           extent or in such amounts as are provided in appro-  
3           priations Acts; or

4           (2) in the case of an advance payment, only—

5                 (A) to pay for such general or administra-  
6                 tive overhead costs as are attributable to the  
7                 work performed for such agency; or

8                 (B) to such extent or in such amounts as  
9                 are provided in appropriations Acts, with re-  
10                spect to any purpose not allowable under sub-  
11                paragraph (A).

12         SEC. 204. Not to exceed \$5,000 of any funds appro-  
13         priated to the Library of Congress may be expended, on  
14         the certification of the Librarian of Congress, in connec-  
15         tion with official representation and reception expenses for  
16         the Library of Congress incentive awards program.

17         SEC. 205. Not to exceed \$12,000 of funds appro-  
18         priated to the Library of Congress may be expended, on  
19         the certification of the Librarian of Congress or his des-  
20         ignee, in connection with official representation and recep-  
21         tion expenses for the Overseas Field Offices.

22         SEC. 206. (a) Effective for fiscal years beginning with  
23         fiscal year 1995, no amount may be disbursed for any ac-  
24         tivity of the Library of Congress, except to the extent and  
25         in the amount provided (1) in the annual regular appro-

1 priations Act making appropriations for the legislative  
2 branch, or (2) in a supplemental appropriations Act that  
3 makes appropriations for the legislative branch.

4 (b) Subsection (a) applies to disbursement of  
5 amounts derived from any source, including (1) amounts  
6 from library and bibliographical services performed on a  
7 reimbursable basis, under agency agreement or otherwise,  
8 for any public or private entity, (2) amounts from grants  
9 or similar payments for any purpose, and (3) amounts  
10 from gifts, whether such amounts are in the form of trust  
11 funds administered by the Library of Congress Trust  
12 Fund Board or otherwise.

13 ARCHITECT OF THE CAPITOL

14 LIBRARY BUILDINGS AND GROUNDS

15 STRUCTURAL AND MECHANICAL CARE

16 For all necessary expenses for the mechanical and  
17 structural maintenance, care and operation of the Library  
18 buildings and grounds, \$9,543,000, of which \$1,060,000  
19 shall remain available until expended: *Provided*, That, sub-  
20 ject to approval by the Committee on Appropriations of  
21 the House of Representatives and the Committee on Ap-  
22 propriations of the Senate, the Librarian of Congress may  
23 transfer from any appropriation under the heading “Li-  
24 brary of Congress” amounts not to exceed in the aggre-  
25 gate \$3,200,000 to the appropriation “Architect of the

1 Capitol, Library buildings and grounds, Structural and  
2 mechanical care, No Year” to complete the renovation and  
3 restoration of the Thomas Jefferson and John Adams  
4 buildings.

5           COPYRIGHT ROYALTY TRIBUNAL

6                           SALARIES AND EXPENSES

7           For necessary expenses of the Copyright Royalty Tri-  
8 bunal, \$1,028,000, of which \$900,000 shall be derived by  
9 collections from the appropriation “Payments to Copy-  
10 right Owners” for the reasonable costs incurred in pro-  
11 ceedings involving distribution of royalty fees as provided  
12 by 17 U.S.C. 807.

13           GOVERNMENT PRINTING OFFICE

14                   OFFICE OF SUPERINTENDENT OF DOCUMENTS

15                           SALARIES AND EXPENSES

16           For expenses of the Office of Superintendent of Doc-  
17 uments necessary to provide for the cataloging and index-  
18 ing of Government publications and their distribution to  
19 the public, Members of Congress, other Government agen-  
20 cies, and designated depository and international exchange  
21 libraries as authorized by law, \$29,082,000: *Provided,*  
22 That travel expenses, including travel expenses of the De-  
23 pository Library Council to the Public Printer, shall not  
24 exceed \$130,000: *Provided further,* That funds, not to ex-  
25 ceed \$2,000,000, from current year appropriations are au-

1 thorized for producing and disseminating Congressional  
2 Serial Sets and other related Congressional/non-Congres-  
3 sional publications for 1991 and 1992 to depository and  
4 other designated libraries.

5 GOVERNMENT PRINTING OFFICE REVOLVING FUND

6 The Government Printing Office is hereby authorized  
7 to make such expenditures, within the limits of funds  
8 available and in accord with the law, and to make such  
9 contracts and commitments without regard to fiscal year  
10 limitations as provided by section 104 of the Government  
11 Corporation Control Act as may be necessary in carrying  
12 out the programs and purposes set forth in the budget  
13 for the current fiscal year for the "Government Printing  
14 Office revolving fund": *Provided*, That not to exceed  
15 \$2,500 may be expended on the certification of the Public  
16 Printer in connection with official representation and re-  
17 ception expenses: *Provided further*, That the revolving  
18 fund shall be available for the hire or purchase of pas-  
19 senger motor vehicles, not to exceed a fleet of twelve: *Pro-*  
20 *vided further*, That expenditures in connection with travel  
21 expenses of the advisory councils to the Public Printer  
22 shall be deemed necessary to carry out the provisions of  
23 title 44, United States Code: *Provided further*, That the  
24 revolving fund shall be available for services as authorized  
25 by 5 U.S.C. 3109 but at rates for individuals not to exceed

1 the per diem rate equivalent to the rate for level V of the  
2 Executive Schedule (5 U.S.C. 5316): *Provided further,*  
3 That the revolving fund and the funds provided under the  
4 paragraph entitled “OFFICE OF SUPERINTENDENT OF  
5 DOCUMENTS, SALARIES AND EXPENSES” together may not  
6 be available for the full-time equivalent employment of  
7 more than 4,850 workyears: *Provided further,* That the re-  
8 volving fund shall be available for expenses not to exceed  
9 \$500,000 for the development of plans and design of a  
10 multi-purpose facility: *Provided further,* That activities fi-  
11 nanced through the revolving fund may provide informa-  
12 tion in any format: *Provided further,* That the revolving  
13 fund shall not be used to administer any flexible or com-  
14 pressed work schedule which applies to any manager or  
15 supervisor in a position the grade or level of which is equal  
16 to or higher than GS-15: *Provided further,* That expenses  
17 for attendance at meetings shall not exceed \$75,000.

18 SEC. 207. (a) Subsection (b) of section 309 of title  
19 44, United States Code, is amended—

20 (1) in the matter before paragraph (1), by  
21 striking out “shall be:” and inserting in lieu thereof  
22 “shall be—”;

23 (2) in paragraph (1), by inserting “and” after  
24 the semicolon at the end;

1           (3) in paragraph (2), by striking out “; and”  
2           and inserting in lieu thereof a period; and

3           (4) by striking out paragraph (3).

4           (b) The first undesignated paragraph of section 1708  
5 of title 44, United States Code, is amended by striking  
6 out the third sentence.

7           (c) The amendments made by subsections (a) and (b)  
8 shall take effect on October 1, 1993.

##### 10                   SALARIES AND EXPENSES

11           For necessary expenses of the General Accounting  
12 Office, including not to exceed \$7,000 to be expended on  
13 the certification of the Comptroller General of the United  
14 States in connection with official representation and recep-  
15 tion expenses; services as authorized by 5 U.S.C. 3109 but  
16 at rates for individuals not to exceed the per diem rate  
17 equivalent to the rate for level IV of the Executive Sched-  
18 ule (5 U.S.C. 5315); hire of one passenger motor vehicle;  
19 advance payments in foreign countries in accordance with  
20 31 U.S.C. 3324; benefits comparable to those payable  
21 under sections 901(5), 901(6) and 901(8) of the Foreign  
22 Service Act of 1980 (22 U.S.C. 4081(5), 4081(6) and  
23 4081(8)); and under regulations prescribed by the Comp-  
24 troller General of the United States, rental of living quar-  
25 ters in foreign countries and travel benefits comparable

1 with those which are now or hereafter may be granted sin-  
2 gle employees of the Agency for International Develop-  
3 ment, including single Foreign Service personnel assigned  
4 to AID projects, by the Administrator of the Agency for  
5 International Development—or his designee—under the  
6 authority of section 636(b) of the Foreign Assistance Act  
7 of 1961 (22 U.S.C. 2396(b)); \$430,815,000: *Provided*,  
8 That not more than \$1,600,000 of reimbursements re-  
9 ceived incident to the operation of the General Accounting  
10 Office Building shall be available for use in fiscal year  
11 1994: *Provided further*, That this appropriation and ap-  
12 propriations for administrative expenses of any other de-  
13 partment or agency which is a member of the Joint Finan-  
14 cial Management Improvement Program (JFMIP) shall be  
15 available to finance an appropriate share of JFMIP costs  
16 as determined by the JFMIP, including the salary of the  
17 Executive Director and secretarial support: *Provided fur-*  
18 *ther*, That this appropriation and appropriations for ad-  
19 ministrative expenses of any other department or agency  
20 which is a member of the National Intergovernmental  
21 Audit Forum or a Regional Intergovernmental Audit  
22 Forum shall be available to finance an appropriate share  
23 of Forum costs as determined by the Forum, including  
24 necessary travel expenses of non-Federal participants.  
25 Payments hereunder to either the Forum or the JFMIP



1 may be credited as reimbursements to any appropriation  
2 from which costs involved are initially financed: *Provided*  
3 *further*, That to the extent that funds are otherwise avail-  
4 able for obligation, agreements or contracts for the re-  
5 moval of asbestos, and renovation of the building and  
6 building systems (including the heating, ventilation and  
7 air conditioning system, electrical system and other major  
8 building systems) of the General Accounting Office Build-  
9 ing may be made for periods not exceeding five years: *Pro-*  
10 *vided further*, That this appropriation and appropriations  
11 for administrative expenses of any other department or  
12 agency which is a member of the American Consortium  
13 on International Public Administration (ACIPA) shall be  
14 available to finance an appropriate share of ACIPA costs  
15 as determined by the ACIPA, including any expenses at-  
16 tributable to membership of ACIPA in the International  
17 Institute of Administrative Sciences: *Provided further*,  
18 That of the amount provided under this heading, not to  
19 exceed \$500,000 shall be available for a broadbased orga-  
20 nizational performance review of the General Accounting  
21 Office, focused on agency structure, skills, staffing, sys-  
22 tems, and its execution of its statutory and assigned  
23 responsibilities.

## 1 TITLE III—GENERAL PROVISIONS

2 SEC. 301. No part of the funds appropriated in this  
3 Act shall be used for the maintenance or care of private  
4 vehicles, except for emergency assistance and cleaning as  
5 may be provided under regulations relating to parking fa-  
6 cilities for the House of Representatives issued by the  
7 Committee on House Administration and for the Senate  
8 issued by the Committee on Rules and Administration.

9 SEC. 302. No part of any appropriation contained in  
10 this Act shall remain available for obligation beyond the  
11 current fiscal year unless expressly so provided herein.

12 SEC. 303. Whenever any office or position not specifi-  
13 cally established by the Legislative Pay Act of 1929 is ap-  
14 propriated for herein or whenever the rate of compensa-  
15 tion or designation of any position appropriated for herein  
16 is different from that specifically established for such posi-  
17 tion by such Act, the rate of compensation and the des-  
18 ignation of the position, or either, appropriated for or pro-  
19 vided herein, shall be the permanent law with respect  
20 thereto: *Provided*, That the provisions herein for the var-  
21 ious items of official expenses of Members, officers, and  
22 committees of the Senate and House of Representatives,  
23 and clerk hire for Senators and Members of the House  
24 of Representatives shall be the permanent law with respect  
25 thereto.

1        SEC. 304. The expenditure of any appropriation  
2 under this Act for any consulting service through procure-  
3 ment contract, pursuant to 5 U.S.C. 3109, shall be limited  
4 to those contracts where such expenditures are a matter  
5 of public record and available for public inspection, except  
6 where otherwise provided under existing law, or under ex-  
7 isting Executive order issued pursuant to existing law.

8        SEC. 305. Notwithstanding any other provision of  
9 law, and subject to approval by the Committee on Appro-  
10 priations of the House of Representatives and the Com-  
11 mittee on Appropriations of the Senate, amounts may be  
12 transferred from the appropriation "Library of Congress,  
13 Salaries and expenses" to the appropriation "Architect of  
14 the Capitol, Library buildings and grounds, Structural  
15 and mechanical care" for the purpose of purchase, rental,  
16 lease, or other agreement, of storage and warehouse space  
17 for use by the Library of Congress during fiscal year  
18 1994, and to incur incidental expenses in connection with  
19 such use.

20        SEC. 306. The General Accounting Office, the Gov-  
21 ernment Printing Office, or the Library of Congress may  
22 for such employees as it deems appropriate authorize a  
23 payment to employees who voluntarily separate before  
24 January 1, 1994, whether by retirement or resignation,

1 which payment shall be paid in accordance with the provi-  
2 sions of section 5597(d) of title 5, United States Code.

3 SEC. 307. (a) The number of employee positions, on  
4 a full-time equivalent basis, for each covered entity shall  
5 be reduced by at least 4 percent from the level as of Sep-  
6 tember 30, 1992, or, with the approval of the Committee  
7 on Appropriations of the House of Representatives and the  
8 Committee on Appropriations of the Senate, as of a later  
9 date, but not later than September 30, 1993. At least 10  
10 percent of the positions eliminated shall be positions the  
11 pay for which is equal to or greater than the annual rate  
12 of basic pay payable for grade GS-14 of the General  
13 Schedule.

14 (b) The reduction required by subsection (a) shall be  
15 completed not later than September 30, 1995, with at  
16 least 62.5 percent of the reduction for each covered entity  
17 to be achieved by September 30, 1994.

18 (c) The Comptroller General shall carry out compli-  
19 ance reporting under this section.

20 (d) As used in this section—

21 (1) the term “covered entity” means an entity  
22 of the legislative branch with more than 100 em-  
23 ployee positions, on a full-time equivalent basis, as  
24 of September 30, 1992; and

1           (2) the term “entity of the legislative branch”  
2           means the House of Representatives, the Senate, the  
3           Office of the Architect of the Capitol (including the  
4           Botanic Garden), the Capitol Police, the Congres-  
5           sional Budget Office, the Copyright Royalty Tribu-  
6           nal, the General Accounting Office, the Government  
7           Printing Office, the Library of Congress, and the  
8           Office of Technology Assessment.

9           SEC. 308. (a) For fiscal years 1995, 1996, and 1997,  
10          the submissions in support of the amounts included in the  
11          Budget for each entity of the legislative branch shall set  
12          forth a separate category for administrative expenses. For  
13          fiscal years 1993 and 1994, the administrative expenses  
14          for each entity of the legislative branch shall be calculated  
15          and submitted in a separate category in the same format  
16          as if submitted in support of amounts included in the  
17          Budget.

18          (b) For fiscal years 1994, 1995, 1996, and 1997, the  
19          submissions under subsection (a) in the separate category  
20          for administrative expenses for each entity of the legisla-  
21          tive branch shall include reductions from the amount cal-  
22          culated for administrative expenses for fiscal year 1993,  
23          adjusted for inflation, as follows:

24                  (1) Fiscal year 1994, reduction of not less than  
25                  3 percent.

1           (2) Fiscal year 1995, reduction of not less than  
2           6 percent.

3           (3) Fiscal year 1996, reduction of not less than  
4           9 percent.

5           (4) Fiscal year 1997, reduction of not less than  
6           14 percent.

7           (c) The Comptroller General shall carry out compli-  
8           ance reporting under this section.

9           (d) As used in this section—

10           (1) the term “administrative expenses” means  
11           expenses of contractual services and supplies, other  
12           than rental payments, programmatic mission-essen-  
13           tial expenses, reimbursable expenses, and expenses  
14           required by law;

15           (2) the term “Budget” means the budget of the  
16           United States Government, submitted under section  
17           1105 of title 31, United States Code; and

18           (3) the term “entity of the legislative branch”  
19           means the House of Representatives, the Senate, the  
20           Office of the Architect of the Capitol (including the  
21           Botanic Garden), the Capitol Police, the Congres-  
22           sional Budget Office, the Copyright Royalty Tribu-  
23           nal, the General Accounting Office, the Government  
24           Printing Office, the Library of Congress, and the  
25           Office of Technology Assessment.

1 RETIREMENT CREDIT FOR CERTAIN PRIOR SERVICE WITH  
2 THE HOUSE CHILD CARE CENTER

3 SEC. 309. (a) DEFINITIONS.—For the purpose of this  
4 section—

5 (1) the term “House Child Care Center” means  
6 the House of Representatives Child Care Center;  
7 and

8 (2) the term “Congressional employee” has the  
9 meaning given such term—

10 (A) in subchapter III of chapter 83 of title  
11 5, United States Code, to the extent that this  
12 section relates to the Civil Service Retirement  
13 System; or

14 (B) in chapter 84 of title 5, United States  
15 Code, to the extent that this section relates to  
16 the Federal Employees’ Retirement System.

17 (b) CSRS.—(1) Subject to paragraph (2), any indi-  
18 vidual who is an employee of the House Child Care Center  
19 on the date of enactment of this Act shall be allowed credit  
20 under subchapter III of chapter 83 of title 5, United  
21 States Code, as a Congressional employee, for any service  
22 if—

23 (A) such service was performed before October  
24 1, 1991, as an employee of the House Child Care  
25 Center (as constituted before that date); and

1           (B) the employee is subject to subchapter III of  
2           chapter 83 of such title as of the date of enactment  
3           of this Act.

4           (2) Credit for service described in paragraph (1)(A)  
5           shall not be allowed under this section unless there is paid  
6           into the Civil Service Retirement and Disability Fund, by  
7           or on behalf of the employee involved, an amount equal  
8           to the deductions from pay which would have been applica-  
9           ble under section 8334(c) of title 5, United States Code,  
10          for the period of service involved, if such employee were  
11          then a Congressional employee, including interest. Retire-  
12          ment credit may not be allowed under this section for any  
13          such service unless the full amount of the deposit required  
14          under the preceding sentence has been paid.

15          (c) FERS.—(1) Subject to paragraph (2), any indi-  
16          vidual who is an employee of the House Child Care Center  
17          on the date of enactment of this Act shall be allowed credit  
18          under chapter 84 of title 5, United States Code, as a Con-  
19          gressional employee, for any service if—

20                 (A) such service was performed before October  
21                 1, 1991, as an employee of the House Child Care  
22                 Center (as constituted before that date); and

23                 (B) the employee is subject to chapter 84 of  
24                 such title as of the date of enactment of this Act.



1           (2) Credit for service described in paragraph (1)(A)  
2 shall not be allowed under this section unless there is paid  
3 into the Civil Service Retirement and Disability Fund, by  
4 or on behalf of the employee involved, an amount equal  
5 to the deductions from pay which would have been payable  
6 under applicable provisions of law, for the period of service  
7 involved, if such employee were then a Congressional em-  
8 ployee, including interest (computed in the same way as  
9 interest under subsection (b)(2)). Retirement credit may  
10 not be allowed under this section for any such service un-  
11 less the full amount of the deposit required under the pre-  
12 ceding sentence has been paid.

13           (d) CLARIFICATION.—Nothing in this section shall be  
14 considered to relate to the Thrift Savings Plan.

15           (e) OPM FUNCTIONS.—The Office of Personnel  
16 Management shall—

17                 (1) prescribe any regulations which may be nec-  
18                 essary to carry out this section; and

19                 (2) with respect to any service for which credit  
20                 is sought under this section, accept the certification  
21                 of the Clerk of the House of Representatives con-  
22                 cerning the period of such service and the amount  
23                 of pay which was paid for such service.

24           SEC. 310. (a) Section 17 of the Act entitled “An Act  
25 making Appropriations for sundry Civil Expenses of the

1 Government for the Year ending June thirtieth, eighteen  
2 hundred and sixty-seven, and for other purposes”, ap-  
3 proved July 28, 1866 (2 U.S.C. 43), is amended by insert-  
4 ing after “mileage” the first place it appears the following:  
5 “for each Senator”.

6 (b) The amendment made by subsection (a) shall take  
7 effect on October 1, 1993.

8 SEC. 311. The Committee on House Administration  
9 of the House of Representatives is authorized and directed  
10 to take such action, whether by regulation or otherwise,  
11 to transfer to the Clerk of the House of Representatives  
12 responsibility for all financial activities of legislative serv-  
13 ice organizations, including the establishment and mainte-  
14 nance of revolving accounts to receive their dues and as-  
15 sessments and to make disbursements of their ordinary  
16 and necessary business expenses in support of Members’  
17 official and representational duties. The transfer referred  
18 to in the preceding sentence shall take effect not later than  
19 January 1, 1994.

20 SEC. 312. None of the funds made available in this  
21 Act may be used for the relocation of the office of any  
22 Member of the House of Representatives within the House  
23 office buildings.

1        This Act may be cited as the “Legislative Branch Ap-  
2        propriations Act, 1994”.
