AN ACT

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 1994, and for other purposes.

- 1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 Legislative Branch for the fiscal year ending September
6 30, 1994, and for other purposes, namely:

7 *SEC. 1. (a) Charges for expenses of any office, the funds*
8 *of which are disbursed by the Secretary of the Senate, may*
9 *be vouchered by a Senate support office paying such ex-*
10 *penses or to which such charges are owed for goods or serv-*
11 *ices provided, if—*

12 *(1) such charges are paid on behalf of the office*
13 *incurring such expenses by such Senate support office;*
14 *or*

15 *(2) such charges are payable to such Senate sup-*
16 *port office for goods or services provided by such office*
17 *to the office incurring such expenses.*

18 *(b) Payments under this section shall be charged to*
19 *the official funds of the office on whose behalf the expenses*
20 *were paid, or which received the goods or services for which*
21 *payment is required.*

22 *(c) Any voucher submitted by a Senate support office*
23 *pursuant to this section shall be accompanied by a certifi-*
24 *cation from such office of the amount and that such pur-*
25 *chases were of the nature that they could be charged to the*

1 *official funds of the office on whose behalf charges were paid,*
 2 *or to which goods or services were provided.*

3 *(d) Vouchers under this section shall be submitted and*
 4 *paid subject to such regulations as may be promulgated by*
 5 *the Committee on Rules and Administration.*

6 *SEC. 2. Effective on and after October 1, 1993, the ag-*
 7 *gregate of each of the sums determined under clauses (iii)*
 8 *and (iv) of section 506(b)(3)(A) of the Supplemental Appro-*
 9 *priations Act, 1973 (2 U.S.C. 58(b)(3)(A) (iii) and (iv)),*
 10 *shall be deemed decreased by 2.5 percent.*

11 *SEC. 3. Section 12 under the subheading “ADMINIS-*
 12 *TRATIVE PROVISIONS” under the heading “SENATE” in the*
 13 *Legislative Branch Appropriations Act, 1991 (2 U.S.C.*
 14 *58c–1) is amended in the first sentence by striking “the*
 15 *Committee on Appropriations of the Senate and”.*

10 For salaries and expenses of the House of Represent-
11 atives, \$686,318,000, as follows:

13 For salaries and expenses, as authorized by law,
14 \$5,871,000, including: Office of the Speaker, \$1,395,000,
15 including \$25,000 for official expenses of the Speaker; Of-

3 amounts so credited for fiscal year 1993 and not obligated
4 shall be available for obligation in fiscal year 1994.

5 ALLOWANCES AND EXPENSES

6 For allowances and expenses as authorized by House
7 resolution or law, \$220,812,000, including: Official Ex-
8 penses of Members, \$76,545,000; supplies, materials, ad-
9 ministrative costs and Federal tort claims, \$11,328,000;

11 equipment, \$7,196,000; net expenses for telecommuni-
12 cations, \$5,960,000; furniture and furnishings,
13 \$1,720,000; stenographic reporting of committee hearings,

16 surance fund, retirement funds, Social Security fund,
17 Medicare fund, health benefits fund, and worker's and un-

8 of executive agencies, by the Committee on Appropria-
9 tions, and temporary personal services for such committee,
10 to be expended in accordance with section 202(b) of the
11 Legislative Reorganization Act of 1946, and to be avail-
12 able for reimbursement to agencies for services performed,
13 \$6,431,000.

14 OFFICIAL MAIL COSTS

15 For expenses necessary for official mail costs of the
16 House of Representatives, as authorized by law,
17 \$40,000,000.

18 SALARIES, OFFICERS AND EMPLOYEES

19 For compensation and expenses of officers and em-
20 ployees, as authorized by law, \$50,147,000, including: Of-
21 fice of the Clerk, including not to exceed \$1,000 for official
22 representation and reception expenses, \$11,947,000; Of-
23 fice of the Sergeant at Arms, including not to exceed \$500
24 for official representation and reception expenses,
25 \$1,384,000; Office of the Doorkeeper, including overtime,
26 as authorized by law, \$10,101,000; Office of Director of

1 Non-legislative and Financial Services, \$14,402,000; for
2 the salaries and expenses of the Office of General Counsel,
3 \$674,000; Office of the Chaplain, \$123,000; Office of the
4 Parliamentarian, including the Parliamentarian and
5 \$2,000 for preparing the Digest of Rules, \$898,000; for
6 salaries and expenses of the Office of the Historian,
7 \$310,000; for salaries and expenses of the Office of the
8 Law Revision Counsel of the House, \$1,453,000; for sala-
9 ries and expenses of the Office of the Legislative Counsel
10 of the House, \$4,071,000; six minority employees,
11 \$738,000; the House Democratic Steering and Policy
12 Committee and the Democratic Caucus, \$1,474,000; the
13 House Republican Conference, \$1,474,000; and other au-
14 thorized employees, \$1,098,000.

15 ADMINISTRATIVE PROVISIONS

16 SEC. 101. (a) Upon the transfer of any function to
17 the Director of Non-legislative and Financial Services by
18 the authority of the Committee on House Administration
19 pursuant to rule X of the House of Representatives and
20 upon the commencement of operation of the Office of In-
21 spector General, the applicable amounts appropriated by
22 the Legislative Branch Appropriations Act, 1992, or by
23 this Act, for the purposes specified in subsection (b) shall
24 be available to the Director and the Office of Inspector
25 General for the carrying out of such function or operation,

1 upon the approval of the Committee on Appropriations of
2 the House of Representatives. In no case shall the transfer
3 of any function referred to in the preceding sentence in-
4 clude the transfer of any function of the Capitol Guide
5 Service.

6 (b) The purposes referred to in subsection (a) are sal-
7 aries and expenses of the House of Representatives under
8 the headings “ALLOWANCES AND EXPENSES” and “SALA-
9 RIES, OFFICERS AND EMPLOYEES”.

10 SEC. 101A. (a) House Resolution 1238, Ninety-first
11 Congress, agreed to December 22, 1970 (as enacted into
12 permanent law by chapter VIII of the Supplemental Ap-
13 propriations Act, 1971, and supplemented by the Act enti-
14 tled “An Act relating to former Speakers of the House
15 of Representatives” (88 Stat. 1723)) (2 U.S.C. 31b–1 et
16 seq.) is amended by adding at the end the following new
17 section:

18 “SEC. 8. The entitlements of a former Speaker of the
19 House of Representatives under this resolution shall be
20 available—

21 “(1) in the case of an individual who is a
22 former Speaker on the effective date of this section,
23 for 5 years, commencing on such effective date; and

24 “(2) in the case of an individual who becomes
25 a former Speaker after such effective date, for 5

1 years, commencing at the expiration of the term of
2 office of the individual as a Representative in Con-
3 gress.”.

4 (b) The amendment made by subsection (a) shall take
5 effect on October 1, 1993.

11 Secretary of the Senate.

13 For salaries and expenses of the Joint Committee on
14 Printing, ~~\$1,377,000~~ \$1,311,000, to be disbursed by the
15 Secretary of the Senate.

16 JOINT COMMITTEE ON TAXATION

17 For salaries and expenses of the Joint Committee on
18 Taxation, \$5,701,000, to be disbursed by the Clerk of the
19 House.

20 For other joint items, as follows:

21 OFFICE OF THE ATTENDING PHYSICIAN

22 For medical supplies, equipment, and contingent ex-
23 penses of the emergency rooms, and for the Attending
24 Physician and his assistants, including (1) an allowance
25 of \$1,500 per month to the Attending Physician; (2) an
26 allowance of \$500 per month each to two medical officers

1 while on duty in the Attending Physician's office; (3) an
2 allowance of \$500 per month each to two assistants and
3 \$400 per month each to not to exceed nine assistants on
4 the basis heretofore provided for such assistance; and (4)
5 \$1,002,000 for reimbursement to the Department of the
6 Navy for expenses incurred for staff and equipment as-
7 signed to the Office of the Attending Physician, which
8 shall be advanced and credited to the applicable appropria-
9 tion or appropriations from which such salaries, allow-
10 ances, and other expenses are payable and shall be avail-
11 able for all the purposes thereof, \$1,502,000, to be dis-
12 bursed by the Clerk of the House.

13 CAPITOL POLICE BOARD

14 CAPITOL POLICE

15 SALARIES

16 For the Capitol Police Board for salaries, including
17 overtime, and Government contributions to employees'
18 benefits funds, as authorized by law, of officers, members,
19 and employees of the Capitol Police, \$62,255,000, of
20 which \$29,453,000 is provided to the Sergeant at Arms
21 of the House of Representatives, to be disbursed by the
22 Clerk of the House, and \$32,802,000 is provided to the
23 Sergeant at Arms and Doorkeeper of the Senate, to be
24 disbursed by the Secretary of the Senate: *Provided*, That
25 of the amounts appropriated for fiscal year 1994 for sala-

1 ries, including overtime, and Government contributions to
2 employees' benefits funds under this heading, such
3 amounts as may be necessary may be transferred between
4 the Sergeant at Arms of the House of Representatives and
5 the Sergeant at Arms and Doorkeeper of the Senate, upon
6 approval of the Committee on Appropriations of the House
7 of Representatives and the Committee on Appropriations
8 of the Senate.

9 GENERAL EXPENSES

10 For the Capitol Police Board for necessary expenses
11 of the Capitol Police, including motor vehicles, commu-
12 nications and other equipment, uniforms, weapons, sup-
13 plies, materials, training, medical services, the employee
14 assistance program, not more than \$2,000 for the awards
15 program, postage, telephone service, travel advances, relo-
16 cation of instructor and liaison personnel for the Federal
17 Law Enforcement Training Center, and \$85 per month
18 for extra services performed for the Capitol Police Board
19 by an employee of the Sergeant at Arms of the Senate
20 or the House of Representatives designated by the Chair-
21 man of the Board, \$1,977,000, to be disbursed by the
22 Clerk of the House of Representatives: *Provided*, That,
23 notwithstanding any other provision of law, the cost of
24 basic training for the Capitol Police at the Federal Law
25 Enforcement Training Center for fiscal year 1994 shall

1 be paid by the Secretary of the Treasury from funds avail-
2 able to the Department of the Treasury.

3 ADMINISTRATIVE PROVISION

4 SEC. 102. Amounts appropriated for fiscal year 1994

8 vehicles, except for emergency assistance and cleaning as
9 may be provided under regulations relating to parking fa-
10 cilities for the House of Representatives issued by the
11 Committee on House Administration and for the Senate
12 issued by the Committee on Rules and Administration.

13 SEC. 302. No part of any appropriation contained in
14 this Act shall remain available for obligation beyond the
15 current fiscal year unless expressly so provided herein.

16 SEC. 303. Whenever any office or position not specifi-
17 cally established by the Legislative Pay Act of 1929 is ap-
18 propriated for herein or whenever the rate of compensa-
19 tion or designation of any position appropriated for herein
20 is different from that specifically established for such posi-
21 tion by such Act, the rate of compensation and the des-
22 ignation of the position, or either, appropriated for or pro-
23 vided herein, shall be the permanent law with respect
24 thereto: *Provided*, That the provisions herein for the var-
25 ious items of official expenses of Members, officers, and

1 committees of the Senate and House of Representatives,
2 and clerk hire for Senators and Members of the House
3 of Representatives shall be the permanent law with respect
4 thereto.

5 SEC. 304. The expenditure of any appropriation
6 under this Act for any consulting service through procure-
7 ment contract, pursuant to 5 U.S.C. 3109, shall be limited
8 to those contracts where such expenditures are a matter
9 of public record and available for public inspection, except
10 where otherwise provided under existing law, or under ex-
11 isting Executive order issued pursuant to existing law.

12 SEC. 305. Notwithstanding any other provision of
13 law, and subject to approval by the Committee on Appro-
14 priations of the House of Representatives and the Com-
15 mittee on Appropriations of the Senate, amounts may be
16 transferred from the appropriation "Library of Congress,
17 Salaries and expenses" to the appropriation "Architect of
18 the Capitol, Library buildings and grounds, Structural
19 and mechanical care" for the purpose of purchase, rental,
20 lease, or other agreement, of storage and warehouse space
21 for use by the Library of Congress during fiscal year
22 1994, and to incur incidental expenses in connection with
23 such use.

24 ~~SEC. 306. The General Accounting Office, the Gov-~~
25 ~~ernment Printing Office, or the Library of Congress may~~

1 for such employees as it deems appropriate authorize a
2 payment to employees who voluntarily separate before
3 January 1, 1994, whether by retirement or resignation,
4 which payment shall be paid in accordance with the provi-
5 sions of section 5597(d) of title 5, United States Code.

6 *SEC. 306. (a) The General Accounting Office, the Gov-*
7 *ernment Printing Office, or the Library of Congress may*
8 *for such employees as it deems appropriate authorize a pay-*
9 *ment to employees who voluntarily separate before January*
10 *1, 1994, whether by retirement or resignation, which pay-*
11 *ment shall be paid in accordance with the provisions of sec-*

13 *(b) The number of employee positions authorized for*

15 *fice, or the Library of Congress, as the case may be, shall*
16 *be reduced by one position for each vacancy created by rea-*
17 *son of a separation under subsection (a). No funds appro-*
18 *priated by this Act for salaries or expenses of any position*
19 *that is eliminated under the preceding sentence may be used*
20 *for any other purpose.*

21 *SEC. 307. (a) The number of employee positions, on*
22 *a full-time equivalent basis, for each covered entity shall*
23 *be reduced by at least 4 percent from the level funded level,*
24 *other than those supported by gift and trust funds, as of*
25 *September 30, 1992, or, with the approval of the Commit-*

tee on Appropriations of the House of Representatives and the Committee on Appropriations of the Senate, as of a later date, but not later than September 30, 1993. At least 10 percent of the positions eliminated shall be positions the pay for which is equal to or greater than the annual rate of basic pay payable for grade GS-14 of the General Schedule.

(b) The reduction required by subsection (a) shall be completed not later than September 30, 1995, with at least 62.5 percent of the reduction for each covered entity to be achieved by September 30, 1994.

(c) The Comptroller General shall carry out compliance reporting under this section.

(d) As used in this section—

(1) the term “covered entity” means an entity of the legislative branch with more than 100 employee positions, on a full-time equivalent basis, as of September 30, 1992; and

(2) the term “entity of the legislative branch” means the House of Representatives, the Senate, the Office of the Architect of the Capitol (including the Botanic Garden), the Capitol Police, the Congressional Budget Office, the Copyright Royalty Tribunal, the General Accounting Office, the Government

1 Printing Office, the Library of Congress, and the
2 Office of Technology Assessment.

3 SEC. 308. (a) For fiscal years 1995, 1996, and 1997,
4 the submissions in support of the amounts included in the
5 Budget for each entity of the legislative branch shall set
6 forth a separate category for administrative expenses. For
7 fiscal years 1993 and 1994, the administrative expenses
8 for each entity of the legislative branch shall be calculated
9 and submitted in a separate category in the same format
10 as if submitted in support of amounts included in the
11 Budget.

12 (b) For fiscal years 1994, 1995, 1996, and 1997, the
13 submissions under subsection (a) in the separate category
14 for administrative expenses for each entity of the legisla-
15 tive branch shall include reductions from the amount cal-
16 culated for administrative expenses for fiscal year 1993,
17 adjusted for inflation, as follows:

18 (1) Fiscal year 1994, reduction of not less than
19 3 percent.

20 (2) Fiscal year 1995, reduction of not less than
21 6 percent.

22 (3) Fiscal year 1996, reduction of not less than
23 9 percent.

24 (4) Fiscal year 1997, reduction of not less than
25 14 percent.

1 (c) The Comptroller General shall carry out compli-
2 ance reporting under this section.

3 (d) As used in this section—

4 (1) the term “administrative expenses” means
5 expenses of contractual services and supplies, other
6 than rental payments, programmatic mission-essen-
7 tial expenses, reimbursable expenses, and expenses
8 required by law;

9 (2) the term “Budget” means the budget of the
10 United States Government, submitted under section
11 1105 of title 31, United States Code; and

12 (3) the term “entity of the legislative branch”
13 means the House of Representatives, the Senate, the
14 Office of the Architect of the Capitol (including the
15 Botanic Garden), the Capitol Police, the Congres-
16 sional Budget Office, the Copyright Royalty Tribu-
17 nal, the General Accounting Office, the Government
18 Printing Office, the Library of Congress, and the
19 Office of Technology Assessment.

20 RETIREMENT CREDIT FOR CERTAIN PRIOR SERVICE WITH
21 THE HOUSE CHILD CARE CENTER

22 SEC. 309. (a) DEFINITIONS.—For the purpose of this
23 section—

24 (1) the term “House Child Care Center” means
25 the House of Representatives Child Care Center;
26 and

1 (2) the term “Congressional employee” has the
2 meaning given such term—

3 (A) in subchapter III of chapter 83 of title
4 5, United States Code, to the extent that this
5 section relates to the Civil Service Retirement
6 System; or

7 (B) in chapter 84 of title 5, United States
8 Code, to the extent that this section relates to
9 the Federal Employees’ Retirement System.

10 (b) CSRS.—(1) Subject to paragraph (2), any indi-
11 vidual who is an employee of the House Child Care Center
12 on the date of enactment of this Act shall be allowed credit
13 under subchapter III of chapter 83 of title 5, United
14 States Code, as a Congressional employee, for any service
15 if—

16 (A) such service was performed before October
17 1, 1991, as an employee of the House Child Care
18 Center (as constituted before that date); and

19 (B) the employee is subject to subchapter III of
20 chapter 83 of such title as of the date of enactment
21 of this Act.

22 (2) Credit for service described in paragraph (1)(A)
23 shall not be allowed under this section unless there is paid
24 into the Civil Service Retirement and Disability Fund, by
25 or on behalf of the employee involved, an amount equal

1 to the deductions from pay which would have been applica-
2 ble under section 8334(c) of title 5, United States Code,
3 for the period of service involved, if such employee were
4 then a Congressional employee, including interest. Retire-
5 ment credit may not be allowed under this section for any
6 such service unless the full amount of the deposit required
7 under the preceding sentence has been paid.

8 (c) FERS.—(1) Subject to paragraph (2), any indi-
9 vidual who is an employee of the House Child Care Center
10 on the date of enactment of this Act shall be allowed credit
11 under chapter 84 of title 5, United States Code, as a Con-
12 gressional employee, for any service if—

13 (A) such service was performed before October
14 1, 1991, as an employee of the House Child Care
15 Center (as constituted before that date); and

16 (B) the employee is subject to chapter 84 of
17 such title as of the date of enactment of this Act.

18 (2) Credit for service described in paragraph (1)(A)
19 shall not be allowed under this section unless there is paid
20 into the Civil Service Retirement and Disability Fund, by
21 or on behalf of the employee involved, an amount equal
22 to the deductions from pay which would have been payable
23 under applicable provisions of law, for the period of service
24 involved, if such employee were then a Congressional em-
25 ployee, including interest (computed in the same way as

1 interest under subsection (b)(2)). Retirement credit may
2 not be allowed under this section for any such service un-
3 less the full amount of the deposit required under the pre-
4 ceding sentence has been paid.

5 (d) CLARIFICATION.—Nothing in this section shall be
6 considered to relate to the Thrift Savings Plan.

7 (e) OPM FUNCTIONS.—The Office of Personnel
8 Management shall—

9 (1) prescribe any regulations which may be nec-
10 essary to carry out this section; and

11 (2) with respect to any service for which credit
12 is sought under this section, accept the certification
13 of the Clerk of the House of Representatives con-
14 cerning the period of such service and the amount
15 of pay which was paid for such service.

16 ~~SEC. 310. (a) Section 17 of the Act entitled “An Act~~

1 *SEC. 310. (a) Section 17 of the Act of July 28, 1866*

3 *(b) The first section of the Act of July 8, 1935 (2*
4 *U.S.C. 43a), under the heading “SENATE” and the sub-*
5 *heading “SALARIES AND MILEAGE OF SENATORS”, is*
6 *amended by deleting “and hereafter the President of the*
7 *Senate shall be paid mileage at the same rate and in the*
8 *same manner as now allowed by law to Senators, Members*

10 *SEC. 311. The Committee on House Administration*
11 *of the House of Representatives is authorized and directed*
