A BILL

To make emergency supplemental appropriations for fiscal year 1993 to provide refugee impact assistance for the States of Florida, Massachusetts, and New York.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Refugee Impact Assist-
5 ance Supplemental Appropriations Act for Fiscal Year
6 1993”.

1 **SEC. 2. EMERGENCY SUPPLEMENTAL APPROPRIATIONS.**

2 The following sums are appropriated, out of any
3 money in the Treasury not otherwise appropriated, to pro-
4 vide emergency supplemental appropriations for fiscal year
5 1993:

6 DEPARTMENT OF HEALTH AND HUMAN
7 SERVICES

8 ADMINISTRATION FOR CHILDREN AND FAMILIES
9 REFUGEE AND ENTRANT ASSISTANCE

10 For an additional amount for “Refugee and entrant
11 assistance” for the purpose of targeted assistance grants
12 to States for unreimbursed refugee assistance expenses re-
13 sulting from the entry into the United States of HIV-in-
14 fected Haitian refugees, \$1,830,000, of which amount
15 \$1,098,000 shall be made available to Florida, \$274,500
16 shall be made available to Massachusetts, and \$457,500
17 shall be made available to New York.

18 **SEC. 3. EMERGENCY DESIGNATION.**

19 (a) DESIGNATION BY CONGRESS.—The Congress
20 hereby designates the entire amount provided in section
21 2 as an emergency requirement for all purposes of the Bal-
22 anced Budget and Emergency Deficit Control Act of 1985.

23 (b) REQUIREMENT OF DESIGNATION BY PRESI-
24 DENT.—The amount provided in section 2 shall be avail-
25 able only to the extent of a specific dollar amount for the
26 purpose specified in such section that is included in an

1 official budget request submitted by the President to the
2 Congress and that is designated as an emergency require-
3 ment for all purposes of the Balanced Budget and Emer-
4 gency Deficit Control Act of 1985.
