A BILL

To amend the Public Health Service Act to provide for programs regarding ovarian cancer.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Ovarian Cancer Re-
- 5 search and Information Amendments of 1993".
- 6 SEC. 2. FUNDING FOR RESEARCH ON OVARIAN CANCER.
- 7 Section 417B(b)(2) of the Public Health Service Act,
- 8 as added by section 403 of Public Law 103-43, is amend-
- 9 ed—

1	(1) by striking "CANCERS.—For the purpose
2	of" and all that follows through "417," and insert-
3	ing the following: "CANCERS.—
4	"(A) For the purpose of carrying out sec-
5	tion 417(d),"; and
6	(2) by adding at the end the following subpara-
7	graph:
8	"(B)(i) For the purpose of carrying out re-
9	search under section 417(d) on ovarian cancer,
10	there are authorized to be appropriated
11	\$90,000,000 for fiscal year 1994, and such
12	sums as may be necessary for each of the fiscal
13	years 1995 and 1996. With respect to such pur-
14	pose, such authorizations of appropriations are
15	in addition to the authorizations of appropria-
16	tions established in subparagraph (A) and in
17	subsection (a).
18	"(ii) Of the amounts appropriated under
19	clause (i), the Director of the Institute shall re-
20	serve 50 percent for research described in such
21	clause that does not involve treatment or clini-
22	cal trials, and 50 percent for research described
23	in such clause that does involve treatment and

clinical trials.

1	"(iii) In expending the amounts reserved
2	under clause (ii), the Director of the Institute
3	shall ensure that 1 or more programs of re-
4	search on ovarian cancer are carried out under
5	the programs designated by the Director as the
6	Specialized Programs of Research Excellence.".
7	SEC. 3. PUBLIC INFORMATION AND EDUCATION ON OVAR-
8	IAN CANCER.
9	Section 417(d)(4) of the Public Health Service Act,
10	as added by section 401 of Public Law 103-43, is amend-
11	ed by striking "section 413; and" and inserting the follow-
12	ing: "section 413, which programs shall include programs
13	on ovarian cancer that (subject to changes in the applica-
14	ble facts) provide information and education regarding—
15	"(A) screening procedures for such cancer,
16	including the fact that there is not a procedure
17	that reliably provides for the early detection of
18	such cancer;
19	"(B) the fact that there may be a genetic
20	basis to such cancer;
21	"(C) factors indicating a substantial risk
22	of such cancer; and
23	"(D) the various treatments for such can-
24	cer and the extent to which the treatments are
25	effective: and".

1 SEC. 4. EFFECTIVE DATE.

- 2 This Act takes effect October 1, 1993, or upon the
- 3 date of the enactment of this Act, whichever occurs later.
