To amend title 38, United States Code, to restore certain benefits eligibility to unremarried surviving spouses of veterans.

# A BILL

To amend title 38, United States Code, to restore certain benefits eligibility to unremarried surviving spouses of veterans.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Surviving Spouses"
- 5 Benefits Act of 1993".

#### SEC. 2. SPECIAL DEATH GRATUITY FOR UNREMARRIED

- 2 SURVIVING SPOUSES.
- 3 (a) IN GENERAL.—Chapter 13 of title 38, United
- 4 States Code, is amended by adding at the end of sub-
- 5 chapter II the following new section:

## 6 "§ 1319. Special death gratuity

- 7 "In any case in which benefits under this chapter
- 8 have been terminated or denied as the result of a marriage
- 9 by a surviving spouse and in which such marriage has sub-
- 10 sequently been terminated by death or divorce, a special
- 11 monthly death gratuity shall be payable to an unremarried
- 12 surviving spouse in an amount equal to the amount pay-
- 13 able under section 1311(a)(1) of this title, subject to a
- 14 reduction of \$1 for each \$1 of income countable under
- 15 section 1315(f)(1) of this title.".
- 16 (b) CLERICAL AMENDMENT.—The table of sections
- 17 at the beginning of such chapter is amended by inserting
- 18 after the item relating to section 1318 the following new
- 19 item:

"1319. Special death gratuity.".

- 20 SEC. 3. RESTORATION OF PENSION ELIGIBILITY FOR
- 21 **UNREMARRIED SPOUSES.**
- Section 1501 of title 38, United States Code, is
- 23 amended by adding at the end the following new para-
- 24 graph:

- 1 "(5) The term 'surviving spouse' includes the spouse
- 2 of a deceased veteran whose eligibility for benefits under
- 3 this chapter as a surviving spouse was terminated or de-
- 4 nied by reason of a subsequent remarriage if such subse-
- 5 quent remarriage is terminated by death or divorce.".

### 6 SEC. 4. EFFECTIVE DATE.

- 7 (a) IN GENERAL.—Subject to subsection (b), the
- 8 amendments made by sections 2 and 3 shall take effect
- 9 on December 1, 1994.
- 10 (b) CONTINGENCY.—The amendments made by sec-
- 11 tions 2 and 3 shall not take effect if there has not been
- 12 enacted as of December 1, 1994, a law providing a cost-
- 13 of-living adjustment in the rates of compensation payable
- 14 under chapter 11 or dependency and indemnity compensa-
- 15 tion payable under chapter 13 of title 38, United States
- 16 Code, for fiscal year 1995.
- 17 SEC. 5. POLICY REGARDING COST-OF-LIVING ADJUSTMENT
- 18 IN COMPENSATION RATES FOR FISCAL YEAR
- 19 **1995**.
- 20 (a) ROUNDING DOWN.—The fiscal year 1995 cost-of-
- 21 living adjustments in the rates of and limitations for com-
- 22 pensation payable under chapter 11 of title 38, United
- 23 States Code, and of dependency and indemnity compensa-
- 24 tion payable under chapter 13 of such title will be no more
- 25 than a percentage equal to the percentage by which benefit

- 1 amounts payable under title II of the Social Security Act
- 2 (42 U.S.C. 401 et seq.) are increased effective December
- 3 1, 1994, as a result of a determination under section
- 4 215(i) of such Act (42 U.S.C. 415(i)), with all increased
- 5 monthly rates and limitations (other than increased rates
- 6 or limitations equal to a whole dollar amount) rounded
- 7 down to the next lower dollar.
- 8 (b) Limitation on Fiscal Year 1995 Cost-of-
- 9 LIVING ADJUSTMENT FOR CERTAIN DIC RECIPIENTS.—
- 10 (1) During fiscal year 1995, the amount of any increase
- 11 in any of the rates of dependency and indemnity com-
- 12 pensation in effect under section 1311(a)(3) of title 38,
- 13 United States Code, will not exceed 50 percent of the new
- 14 law increase, rounded down (if not an even dollar amount)
- 15 to the next lower dollar.
- 16 (2) For purposes of paragraph (1), the new law in-
- 17 crease is the amount by which the rate of dependency and
- 18 indemnity compensation provided for recipients under sec-
- 19 tion 1311(a)(1) of such title is increased for fiscal year
- 20 1995.
