A BILL

To amend title 38, United States Code, to restore certain benefits eligibility to unremarried surviving spouses of veterans.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Surviving Spouses’
5 Benefits Act of 1993”.

6 **SEC. 2. SPECIAL DEATH GRATUITY FOR UNREARRIED**
7 **SURVIVING SPOUSES.**

8 (a) IN GENERAL.—Chapter 13 of title 38, United
9 States Code, is amended by adding at the end of sub-
10 chapter II the following new section:

11 **“§ 1319. Special death gratuity**

12 “In any case in which benefits under this chapter
13 have been terminated or denied as the result of a marriage
14 by a surviving spouse and in which such marriage has sub-
15 sequently been terminated by death or divorce, a special
16 monthly death gratuity shall be payable to an unremarried
17 surviving spouse in an amount equal to the amount pay-
18 able under section 1311(a)(1) of this title, subject to a
19 reduction of \$1 for each \$1 of income countable under
20 section 1315(f)(1) of this title.”.

21 (b) CLERICAL AMENDMENT.—The table of sections
22 at the beginning of such chapter is amended by inserting
23 after the item relating to section 1318 the following new
24 item:

“1319. Special death gratuity.”.

1 **SEC. 3. RESTORATION OF PENSION ELIGIBILITY FOR**
2 **UNREMARIED SPOUSES.**

3 Section 1501 of title 38, United States Code, is
4 amended by adding at the end the following new para-
5 graph:

6 “(5) The term ‘surviving spouse’ includes the spouse
7 of a deceased veteran whose eligibility for benefits under
8 this chapter as a surviving spouse was terminated or de-
9 nied by reason of a subsequent remarriage if such subse-
10 quent remarriage is terminated by death or divorce.”.

11 **SEC. 4. RESTORATION OF BURIAL ELIGIBILITY FOR**
12 **UNREMARIED SPOUSES.**

13 *Section 2402(5) of title 38, United States Code, is*
14 *amended by inserting “(which for purposes of this chapter*
15 *includes an unremarried surviving spouse who had a subse-*
16 *quent remarriage which was terminated by death or di-*
17 *vorce)” after “surviving spouse”.*

18 **SEC. 4. 5. EFFECTIVE DATE.**

19 (a) IN GENERAL.—Subject to subsection (b), the
20 amendments made by sections 2 and 3 shall take effect
21 on December 1, 1994.

22 (b) CONTINGENCY.—The amendments made by sec-
23 tions 2 and 3 shall not take effect if there has not been
24 enacted as of December 1, 1994, a law providing a cost-
25 of-living adjustment in the rates of compensation payable
26 under chapter 11 or dependency and indemnity compensa-

1 tion payable under chapter 13 of title 38, United States
2 Code, for fiscal year 1995.

3 **SEC. 5. 6. POLICY REGARDING COST-OF-LIVING ADJUST-**
4 **MENT IN COMPENSATION RATES FOR FISCAL**
5 **YEAR 1995.**

6 (a) ROUNDING DOWN.—The fiscal year 1995 cost-of-
7 living adjustments in the rates of and limitations for com-
8 pensation payable under chapter 11 of title 38, United
9 States Code, and of dependency and indemnity compensa-
10 tion payable under chapter 13 of such title will be no more
11 than a percentage equal to the percentage by which benefit
12 amounts payable under title II of the Social Security Act
13 (42 U.S.C. 401 et seq.) are increased effective December
14 1, 1994, as a result of a determination under section
15 215(i) of such Act (42 U.S.C. 415(i)), with all increased
16 monthly rates and limitations (other than increased rates
17 or limitations equal to a whole dollar amount) rounded
18 down to the next lower dollar.

19 (b) LIMITATION ON FISCAL YEAR 1995 COST-OF-
20 LIVING ADJUSTMENT FOR CERTAIN DIC RECIPIENTS.—
21 (1) During fiscal year 1995, the amount of any increase
22 in any of the rates of dependency and indemnity com-
23 pensation in effect under section 1311(a)(3) of title 38,
24 United States Code, will not exceed 50 percent of the new

1 law increase, rounded down (if not an even dollar amount)
2 to the next lower dollar.

3 (2) For purposes of paragraph (1), the new law in-
4 crease is the amount by which the rate of dependency and
5 indemnity compensation provided for recipients under sec-
6 tion 1311(a)(1) of such title is increased for fiscal year
7 1995.
