A BILL

To provide that cost-of-living adjustments to payments made under Federal law shall be determined using a new price index which does not take into account tobacco products.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	SECTION 1. COST-OF-LIVING ADJUSTMENTS TO PAYMENTS
2	MADE UNDER FEDERAL LAW DETERMINED
3	USING PRICE INDEX WHICH DOES NOT TAKE
4	INTO ACCOUNT TOBACCO PRODUCTS.
5	(a) IN GENERAL.—Notwithstanding any other provi-
6	sion of law, the Consumer Price Index for Government
7	Use (CPI-G) established by subsection (c) shall be used
8	to determine the amount of any cost-of-living or similar
9	adjustment to any payment (including payments referred
10	to in subsection (b)) made under Federal law which is oth-
11	erwise subject to such an adjustment using any price index
12	which takes into account prices of tobacco products.
13	(b) Payments Affected.—The payments referred
14	to in this subsection are:
15	(1) Benefits payable under the Social Security
16	Act.
17	(2) Retirement benefits payable to former em-
18	ployees of the United States or to former members
19	of the Armed Forces of the United States.
20	(3) Payments on account of the death or dis-
21	ability of any employee or former employee of the
22	United States.
23	(4) Tier 1 railroad retirement benefits.
24	(c) Publication of New Index.—
25	(1) IN GENERAL.—Not later than August 1,
26	1994, the Bureau of Labor Statistics shall publish

- a Consumer Price Index for Government Use (CPI-G).
- 3 (2) INDEX NOT TO INCLUDE TOBACCO PROD4 UCTS.—The Consumer Price Index for Government
 5 Use (CPI-G) shall be modeled after the Consumer
 6 Price Index for All Urban Consumers, but shall not
 7 include tobacco products in the items for which
 8 prices are compared.
- 9 (3) PAST PERIODS INCLUDED.—Such Index 10 shall be determined, to the extent practicable, for 11 the same periods before October 1, 1994, that the 12 Consumer Price Index for All Urban Consumers was 13 determined.
- (d) Transition to New Index.—If, in determining an amount for any period, an adjustment takes into account periods before October 1, 1994, and periods after September 30, 1994—
- 18 (1) the Consumer Price Index for Government 19 Use shall be treated as being used for all periods, 20 and
- 21 (2) the amount being adjusted shall be treated 22 as being the amount which, had such Index been 23 used for all prior periods, would result in the 24 amount in effect for the immediately preceding pe-25 riod.

- 1 (e) Effective Date.—The section shall apply to
- 2 adjustments after September 30, 1994.
