**H. R. 3759**

**AN ACT**

Making emergency supplemental appropriations for the fiscal year ending September 30, 1994, and for other purposes.



1 California fires of 1993 and other natural disasters,  
2 \$340,500,000, to remain available until September 30,  
3 1995: *Provided*, That such amount is designated by Con-  
4 gress as an emergency requirement pursuant to section  
5 251(b)(2)(D)(i) of the Balanced Budget and Emergency  
6 Deficit Control Act of 1985, as amended: *Provided further*,  
7 That if the Secretary determines that the cost of land and  
8 levee restoration exceeds the fair market value of an af-  
9 fected cropland, the Secretary may use sufficient amounts  
10 from funds provided under this heading to accept bids  
11 from willing sellers to enroll such cropland inundated by  
12 the Midwest floods of 1993 in any of the affected States  
13 in the Wetlands Reserve Program, authorized by sub-  
14 chapter C of chapter 1 of subtitle D of title XII of the  
15 Food Security Act of 1985 (16 U.S.C. 3837).

16 AGRICULTURAL STABILIZATION AND CONSERVATION

17 SERVICE

18 EMERGENCY CONSERVATION PROGRAM

19 For an additional amount for “Emergency conserva-  
20 tion program” for expenses resulting from the Midwest  
21 floods and California fires of 1993 and other natural dis-  
22 asters, \$25,000,000, to remain available until September  
23 30, 1995: *Provided*, That such amount is designated by  
24 Congress as an emergency requirement pursuant to sec-

1 tion 251(b)(2)(D)(i) of the Balanced Budget and Emer-  
2 gency Deficit Control Act of 1985, as amended.

3 COMMODITY CREDIT CORPORATION

4 Funds made available in Public Law 103-75 for the  
5 Commodity Credit Corporation shall be available to fund  
6 the costs of replanting, reseeding, or repairing damage to  
7 commercial trees and seedlings, including orchard and  
8 nursery inventory.

13 RELATED AGENCY

14 SMALL BUSINESS ADMINISTRATION

15 DISASTER LOANS PROGRAM ACCOUNT

16 For an additional amount for emergency expenses re-  
17 sulting from the January 1994 earthquake in Southern  
18 California and other disasters, \$309,750,000, to remain  
19 available until expended, of which up to \$55,000,000 may  
20 be transferred to and merged with the appropriations for  
21 “Salaries and expenses” for associated administrative ex-  
22 penses: *Provided*, That the entire amount is designated by  
23 Congress as an emergency requirement pursuant to sec-  
24 tion 251(b)(2)(D)(i) of the Balanced Budget and Emer-  
25 gency Deficit Control Act of 1985, as amended.

## 1 ADMINISTRATIVE PROVISION

2 Section 24 of the Small Business Act (15 U.S.C. 651)  
3 is amended in subsection (a) by striking the period at the  
4 end thereof and by inserting in lieu thereof the following:  
5 “, and shall give priority to a proposal to restore an area  
6 determined to be a major disaster by the President on a  
7 date not more than three years prior to the fiscal year  
8 for which the application is made.”.

## 12 MILITARY PERSONNEL, ARMY

13 For an additional amount for “Military Personnel,  
14 Army”, \$6,600,000: *Provided*, That the entire amount is  
15 designated by Congress as an emergency requirement pur-  
16 suant to section 251(b)(2)(D)(i) of the Balanced Budget  
17 and Emergency Deficit Control Act of 1985, as amended.

## 18 MILITARY PERSONNEL, NAVY

19 For an additional amount for “Military Personnel,  
20 Navy”, \$19,400,000: *Provided*, That the entire amount is  
21 designated by Congress as an emergency requirement pur-  
22 suant to section 251(b)(2)(D)(i) of the Balanced Budget  
23 and Emergency Deficit Control Act of 1985, as amended.

## 1           MILITARY PERSONNEL, AIR FORCE

2           For an additional amount for “Military Personnel,  
3 Air Force”, \$18,400,000: *Provided*, That the entire  
4 amount is designated by Congress as an emergency re-  
5 quirement pursuant to section 251(b)(2)(D)(i) of the Bal-  
6 anced Budget and Emergency Deficit Control Act of 1985,  
7 as amended.

## 8           OPERATION AND MAINTENANCE

## 9           OPERATION AND MAINTENANCE, ARMY

10          For an additional amount for “Operation and Main-  
11 tenance, Army”, \$420,100,000: *Provided*, That the entire  
12 amount is designated by Congress as an emergency re-  
13 quirement pursuant to section 251(b)(2)(D)(i) of the Bal-  
14 anced Budget and Emergency Deficit Control Act of 1985,  
15 as amended.

## 16          OPERATION AND MAINTENANCE, NAVY

17          For an additional amount for “Operation and Main-  
18 tenance, Navy”, \$104,800,000: *Provided*, That the entire  
19 amount is designated by Congress as an emergency re-  
20 quirement pursuant to section 251(b)(2)(D)(i) of the Bal-  
21 anced Budget and Emergency Deficit Control Act of 1985,  
22 as amended.

## 23          OPERATION AND MAINTENANCE, AIR FORCE

24          For an additional amount for “Operation and Main-  
25 tenance, Air Force”, \$560,100,000: *Provided*, That the

1 entire amount is designated by Congress as an emergency  
2 requirement pursuant to section 251(b)(2)(D)(i) of the  
3 Balanced Budget and Emergency Deficit Control Act of  
4 1985, as amended.

5 OPERATION AND MAINTENANCE, DEFENSE-WIDE

6 For an additional amount for “Operation and Main-  
7 tenance, Defense-Wide”, \$21,600,000: *Provided*, That the  
8 entire amount is designated by Congress as an emergency  
9 requirement pursuant to section 251(b)(2)(D)(i) of the  
10 Balanced Budget and Emergency Deficit Control Act of  
11 1985, as amended.

12 PROCUREMENT

13 AIRCRAFT PROCUREMENT, ARMY

14 For an additional amount for “Aircraft Procurement,  
15 Army”, \$20,300,000, to remain available for obligation  
16 until September 30, 1996: *Provided*, That the entire  
17 amount is designated by Congress as an emergency re-  
18 quirement pursuant to section 251(b)(2)(D)(i) of the Bal-  
19 anced Budget and Emergency Deficit Control Act of 1985,  
20 as amended.

21 OTHER PROCUREMENT, ARMY

22 For an additional amount for “Other Procurement,  
23 Army”, \$200,000, to remain available for obligation until  
24 September 30, 1996: *Provided*, That the entire amount is  
25 designated by Congress as an emergency requirement pur-

1 suant to section 251(b)(2)(D)(i) of the Balanced Budget  
2 and Emergency Deficit Control Act of 1985, as amended.

3 OTHER PROCUREMENT, AIR FORCE

4 For an additional amount for “Other Procurement,  
5 Air Force”, \$26,800,000, to remain available for obliga-  
6 tion until September 30, 1996: *Provided*, That the entire  
7 amount is designated by Congress as an emergency re-  
8 quirement pursuant to section 251(b)(2)(D)(i) of the Bal-  
9 anced Budget and Emergency Deficit Control Act of 1985,  
10 as amended.

11 GENERAL PROVISIONS—CHAPTER III

12 SEC. 301. Notwithstanding sections 607 and 630 of  
13 the Foreign Assistance Act of 1961 (22 U.S.C. 2357 and  
14 22 U.S.C. 2390), reimbursements received from the  
15 United Nations for expenses of the Department of Defense  
16 charged to the appropriations provided by this Act shall  
17 be deposited to the miscellaneous receipts of the Treasury.

18 SEC. 302. During the current fiscal year, the Depart-  
19 ment of Defense is authorized to incur obligations for pur-  
20 poses specified in Section 2350j(c) of Title 10, United  
21 States Code in anticipation of receipt of contributions  
22 under that section: *Provided*, That, upon receipt, such con-  
23 tributions shall be credited to the appropriation or fund  
24 which incurred such obligations.

5 DEPARTMENT OF HEALTH AND HUMAN  
6 SERVICES  
7 ADMINISTRATION FOR CHILDREN AND FAMILIES  
8 LOW-INCOME HOME ENERGY ASSISTANCE

9           Of the amounts provided under this heading in Public  
10 Law 103–112 and designated by Congress as an emer-  
11 gency requirement pursuant to section 251(b)(2)(D)(i) of  
12 the Balanced Budget and Emergency Deficit Control Act  
13 of 1985, as amended, subject to the terms and conditions  
14 specified in Public Law 103–112, \$200,000,000, if des-  
15 ignated by the President as an emergency, may be allotted  
16 by the Secretary of the Department of Health and Human  
17 Services, as she determines is appropriate, to any one or  
18 more of the jurisdictions funded under title XXVI of the  
19 Omnibus Budget Reconciliation Act of 1981, to meet  
20 emergency needs.

21           The second paragraph under this heading in Public  
22 Law 102–394 is amended as follows: strike “June 30,  
23 1994” and insert “September 30, 1994”.

## 2 IMPACT AID

3 For carrying out disaster assistance activities result-  
4 ing from the January 1994 earthquake in Southern Cali-  
5 fornia and other disasters as authorized under section 7  
6 of Public Law 81-874, \$165,000,000, to remain available  
7 through September 30, 1995: *Provided*, That the entire  
8 amount is designated by Congress as an emergency re-  
9 quirement pursuant to section 251(b)(2)(D)(i) of the Bal-  
10 anced Budget and Emergency Deficit Control Act of 1985,  
11 as amended.

## 12 STUDENT FINANCIAL ASSISTANCE

13 For an additional amount for “Student financial as-  
14 sistance” for payment of awards made under title IV, part  
15 A, subpart 1 of the Higher Education Act of 1965, as  
16 amended, \$80,000,000, to remain available through Sep-  
17 tember 30, 1995: *Provided*, That notwithstanding sections  
18 442(e) and 462(j) of such Act, the Secretary may reallo-  
19 cate, for use in award year 1994-1995 only, any excess  
20 funds returned to the Secretary of Education under the  
21 Federal Work-Study or Federal Perkins Loan programs  
22 from award year 1993-1994 to assist individuals who suf-  
23 fered financial harm from the January 1994 earthquake  
24 in Southern California and other disasters: *Provided fur-*  
25 *ther*, That the entire amount is designated by Congress  
26 as an emergency requirement pursuant to section

1 251(b)(2)(D)(i) of the Balanced Budget and Emergency  
2 Deficit Control Act of 1985, as amended.

4 CHAPTER VI  
5 DEPARTMENT OF TRANSPORTATION AND  
6 RELATED AGENCIES  
7 FEDERAL HIGHWAY ADMINISTRATION  
8 FEDERAL-AID HIGHWAYS  
9 EMERGENCY RELIEF PROGRAM  
(HIGHWAY TRUST FUND)

10 For the Emergency Fund authorized by 23 U.S.C.  
11 125 to cover expenses arising from the January 1994  
12 earthquake in Southern California and other disasters,  
13 \$950,000,000; and in addition \$400,000,000, which shall  
14 be available only to the extent an official budget request  
15 for a specific dollar amount, that includes designation of  
16 the entire amount of the request as an emergency require-  
17 ment as defined in the Balanced Budget and Emergency  
18 Deficit Control Act of 1985, as amended, is transmitted  
19 by the President to the Congress, all to be derived from  
20 the Highway Trust Fund and to remain available until  
21 expended: *Provided*, That the entire amount is designated  
22 by Congress as an emergency requirement pursuant to  
23 section 251(b)(2)(D)(i) of the Balanced Budget and  
24 Emergency Deficit Control Act of 1985, as amended: *Pro-*  
25 *vided further*, That the limitation on obligations per State  
26 in 23 U.S.C. 125(b) shall not apply to projects relating

1 to such earthquake: *Provided further*, That notwithstand-  
2 ing 23 U.S.C. 120(e), the Federal share for any project  
3 on the Federal-aid highway system related to such earth-  
4 quake shall be 100 percent for the costs incurred in the  
5 180 day period beginning on the date of the earthquake.

6 In addition, for emergency expenses resulting from  
7 the Loma Prieta earthquake of October 17, 1989, as au-  
8 thorized by 23 U.S.C. 125, \$315,000,000, to be derived  
9 from the Highway Trust Fund and to remain available  
10 until expended: *Provided*, That such amount is designated  
11 by Congress as an emergency requirement pursuant to  
12 section 251(b)(2)(D)(i) of the Balanced Budget and  
13 Emergency Deficit Control Act of 1985, as amended.

14 CHAPTER VII

15 DEPARTMENTS OF VETERANS AFFAIRS AND  
16 HOUSING AND URBAN DEVELOPMENT, AND  
17 INDEPENDENT AGENCIES

18 DEPARTMENT OF VETERANS AFFAIRS

19 VETERANS HEALTH ADMINISTRATION

20 MEDICAL CARE

21 For an additional amount for emergency expenses re-  
22 sulting from the January 1994 earthquake in Southern  
23 California, \$21,000,000, to remain available until ex-  
24 pended, of which not to exceed \$802,000 is available for  
25 transfer to General Operating Expenses, the Guaranty

1 and Indemnity Program Account, and the Vocational Re-  
2 habilitation Loans Program Account: *Provided*, That the  
3 entire amount is designated by Congress as an emergency  
4 requirement pursuant to section 251(b)(2)(D)(i) of the  
5 Balanced Budget and Emergency Deficit Control Act of  
6 1985, as amended.

7 CONSTRUCTION, MAJOR PROJECTS

8 For an additional amount for “Construction, major  
9 projects” for emergency expenses resulting from the Janu-  
10 ary 1994 earthquake in Southern California and other dis-  
11 asters, \$45,600,000, to remain available until expended,  
12 of which such sums as may be necessary may be trans-  
13 ferred to the “Medical care” and “Construction, minor  
14 projects” accounts: *Provided*, That the entire amount is  
15 designated by Congress as an emergency requirement pur-  
16 suant to section 251(b)(2)(D)(i) of the Balanced Budget  
17 and Emergency Deficit Control Act of 1985, as amended.

18 DEPARTMENT OF HOUSING AND URBAN

19 DEVELOPMENT

20 HOUSING PROGRAMS

21 ANNUAL CONTRIBUTIONS FOR ASSISTED HOUSING

22 For an additional amount under this head,  
23 \$225,000,000, to remain available until December 31,  
24 1995, of which \$200,000,000 shall be for rental assistance  
25 under the section 8 existing housing certificate program  
26 (42 U.S.C. 1437f) and the housing voucher program

1 under section 8(o) of the United States Housing Act of  
2 1937 (42 U.S.C. 1437f(o)), and \$25,000,000 shall be for  
3 the modernization of existing public housing projects pur-  
4 suant to section 14 of the United States Housing Act of  
5 1937 (42 U.S.C. 1437l): *Provided*, That these funds shall  
6 be used first to replenish amounts used from the head-  
7 quarters reserve established pursuant by section  
8 213(d)(4)(A) of the Housing and Community Develop-  
9 ment Act of 1974, as amended, for assistance to victims  
10 of the January 1994 earthquake in Southern California:  
11 *Provided further*, That any amounts remaining after the  
12 headquarters reserve has been replenished shall be avail-  
13 able under such programs for additional assistance to vic-  
14 tims of the earthquake referred to above: *Provided further*,  
15 That in administering these funds, the Secretary may  
16 waive or specify alternative requirements for any provision  
17 of any statute or regulation that the Secretary administers  
18 in connection with the obligation by the Secretary or any  
19 use by the recipient of these funds, except for the require-  
20 ments relating to fair housing and nondiscrimination, the  
21 environment, and labor standards, upon finding that such  
22 waiver is required to facilitate the obligation and use of  
23 such funds and would not be inconsistent with the overall  
24 purpose of the statute or regulation: *Provided further*,  
25 That the entire amount is designated by Congress as an

1 emergency requirement pursuant to section  
2 251(b)(2)(D)(i) of the Balanced Budget and Emergency  
3 Deficit Control Act of 1985, as amended.

4 FLEXIBLE SUBSIDY FUND

5 For emergency assistance to owners of eligible multi-  
6 family housing projects damaged by the January 1994  
7 earthquake in Southern California who are either insured  
8 or formerly insured under the National Housing Act, as  
9 amended, or otherwise eligible for assistance under section  
10 201(c) of the Housing and Community Development  
11 Amendments of 1978, as amended (12 U.S.C. 1715z-1a),  
12 in the program of assistance for troubled multifamily  
13 housing projects under the Housing and Community De-  
14 velopment Amendments of 1978, as amended,  
15 \$100,000,000, to remain available until September 30,  
16 1995: *Provided*, That assistance to an owner of a multi-  
17 family housing project assisted, but not insured under the  
18 National Housing Act, may be made if the project owner  
19 and the mortgagee have provided or agreed to provide as-  
20 sistance to the project in a manner as determined by the  
21 Secretary of Housing and Urban Development: *Provided*  
22 *further*, That assistance is for the repair of damage or the  
23 recovery of losses directly attributable to the Southern  
24 California earthquake of 1994: *Provided further*, That in  
25 administering these funds, the Secretary may waive, or  
26 specify alternative requirements for, any provision of any

1 statute or regulation that the Secretary administers in  
2 connection with the obligation by the Secretary or any use  
3 by the recipient of these funds, except for statutory re-  
4 quirements relating to fair housing and nondiscrimination,  
5 the environment, and labor standards, upon finding that  
6 such waiver is required to facilitate the obligation and use  
7 of such funds, and would not be inconsistent with the over-  
8 all purpose of the statute or regulation: *Provided further,*  
9 That the entire amount is designated by Congress as an  
10 emergency requirement pursuant to section  
11 251(b)(2)(D)(i) of the Balanced Budget and Emergency  
12 Deficit Control Act of 1985, as amended.

13 COMMUNITY PLANNING AND DEVELOPMENT

14 COMMUNITY DEVELOPMENT GRANTS

15 For an additional amount for “Community develop-  
16 ment grants”, as authorized under title I of the Housing  
17 and Community Development Act of 1974, for emergency  
18 expenses resulting from the January 1994 earthquake in  
19 Southern California, \$250,000,000, to remain available  
20 until September 30, 1996 for all activities eligible under  
21 such title I except those activities reimbursable by the  
22 Federal Emergency Management Agency (FEMA) or  
23 available through the Small Business Administration  
24 (SBA): *Provided,* That from this amount, the Secretary  
25 may transfer up to \$50,000,000 to the “HOME invest-

1 ment partnerships program”, as authorized under title II  
2 of the Cranston-Gonzalez National Affordable Housing  
3 Act, as amended (Public Law 101–625), to remain avail-  
4 able until expended, as an additional amount for such  
5 emergency expenses for all activities eligible under such  
6 title II except activities reimbursable by FEMA or avail-  
7 able through SBA: *Provided further*, That the recipients  
8 of amounts under this appropriation, including the fore-  
9 going transfer (if any), shall use such amounts first to  
10 replenish amounts previously obligated under their Com-  
11 munity Development Block Grant or HOME programs, re-  
12 spectively, in connection with the Southern California  
13 earthquake of January 1994: *Provided further*, That in ad-  
14 ministering these funds, the Secretary may waive, or  
15 specify alternative requirements for, any provision of any  
16 statute or regulation that the Secretary administers in  
17 connection with the obligation by the Secretary or any use  
18 by the recipient of these funds, except for statutory re-  
19 quirements relating to fair housing and nondiscrimination,  
20 the environment, and labor standards, upon finding that  
21 such waiver is required to facilitate the obligation and use  
22 of such funds, and would not be inconsistent with the over-  
23 all purpose of the statute or regulation: *Provided further*,  
24 That the entire amount is designated by Congress as an  
25 emergency requirement pursuant to section

1 251(b)(2)(D)(i) of the Balanced Budget and Emergency  
2 Deficit Control Act of 1985, as amended.

3 INDEPENDENT AGENCIES

4 FEDERAL EMERGENCY MANAGEMENT AGENCY

5 DISASTER RELIEF

6 For an additional amount for “Disaster Relief” for  
7 the January 1994 earthquake in Southern California and  
8 other disasters, \$4,709,000,000 to remain available until  
9 expended: *Provided*, That the entire amount is designated  
10 by Congress as an emergency requirement pursuant to  
11 section 251(b)(2)(D)(i) of the Balanced Budget and  
12 Emergency Deficit Control Act of 1985, as amended.

13 EMERGENCY MANAGEMENT PLANNING AND ASSISTANCE

14 For an additional amount for “Emergency Manage-  
15 ment Planning and Assistance”, to carry out activities  
16 under the Earthquake Hazards Reduction Act of 1977,  
17 as amended (42 U.S.C. 7701 et seq.) \$15,000,000, to re-  
18 main available until expended, to study the January 1994  
19 earthquake in Southern California in order to enhance  
20 seismic safety throughout the United States: *Provided*,  
21 That the entire amount is designated by Congress as an  
22 emergency requirement pursuant to section  
23 251(b)(2)(D)(i) of the Balanced Budget and Emergency  
24 Deficit Control Act of 1985, as amended.

1                                   CHAPTER VIII  
2                   FUNDS APPROPRIATED TO THE PRESIDENT  
3                                   UNANTICIPATED NEEDS

4           For an additional amount for emergency expenses re-  
5           sulting from the January 1994 earthquake in Southern  
6           California and other disasters, \$500,000,000, to remain  
7           available until expended: *Provided*, That these funds may  
8           be transferred to any authorized Federal governmental ac-  
9           tivity to meet the requirements of such disasters: *Provided*  
10          *further*, That the entire amount shall be available only to  
11          the extent that an official budget request for a specific  
12          dollar amount, that includes designation of the entire  
13          amount of the request as an emergency requirement as  
14          defined in the Balanced Budget and Emergency Deficit  
15          Control Act of 1985, as amended, is transmitted by the  
16          President to Congress: *Provided further*, That the entire  
17          amount is designated by Congress as an emergency re-  
18          quirement pursuant to section 251(b)(2)(D)(i) of the Bal-  
19          anced Budget and Emergency Deficit Control Act of 1985,  
20          as amended.

21                                   CHAPTER IX  
22                   GENERAL PROVISIONS

23          SEC. 601. No part of any appropriation contained in  
24          this Act shall remain available for obligation beyond the  
25          current fiscal year unless expressly so provided herein.

1 PROHIBITION OF BENEFITS FOR INDIVIDUALS NOT  
2 LAWFULLY WITHIN THE UNITED STATES

3 SEC. 602. None of the funds made available in this  
4 Act may be used to provide any benefit or assistance to  
5 any individual in the United States when it is known to  
6 a Federal entity or official to which the funds are made  
7 available that—

8 (1) the individual is not lawfully within the  
9 United States; and

10 (2) the direct Federal assistance or benefit to  
11 be provided is other than search and rescue; emer-  
12 gency medical care; emergency mass care; emergency  
13 shelter; clearance of roads and construction of tem-  
14 porary bridges necessary to the performance of  
15 emergency tasks and essential community services;  
16 warning of further risks or hazards; dissemination of  
17 public information and assistance regarding health  
18 and safety measures; the provision of food, water,  
19 medicine and other essential needs, including move-  
20 ment of supplies or persons; and reduction of imme-  
21 diate threats to life, property and public health and  
22 safety.

23 SEC. 603. (a) STUDY BY COMPTROLLER GENERAL.—  
24 The Comptroller General of the United States shall con-  
25 duct a study regarding Federal laws, unfunded Federal

1 mandates, and other Federal regulatory requirements,  
2 that may prevent or impair the ability of State and local  
3 authorities to rebuild expeditiously the areas devastated  
4 by the January 1994 earthquake in Southern California.  
5 In conducting the study, the Comptroller General shall  
6 consult with State and local officials of California.

7 (b) REPORT.—Not later than 30 days after the date  
8 of the enactment of this Act, the Comptroller General shall  
9 submit to the Congress a report setting forth findings and  
10 recommendations as a result of the study conducted under  
11 subsection (a). The report shall include—

12 (1) an identification of the specific Federal  
13 laws, unfunded Federal mandates, and other Federal  
14 regulatory requirements, referred to in subsection  
15 (a);

16 (2) an analysis of the manner in which such  
17 laws, mandates, and other requirements may prevent  
18 or impair the ability of State and local authorities  
19 to rebuild expeditiously the areas devastated by the  
20 January 1994 earthquake in Southern California;  
21 and
