Mr. Pallone (for himself, Mr. Saxton, Mr. Shays, and Mr. Gallo) introduced the following bill; which was referred to the Committee on Merchant Marine and Fisheries

A BILL

To prohibit the commercial harvesting of Atlantic striped bass in the coastal waters and the exclusive economic zone.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 **SECTION 1. DEFINITIONS.**
- 4 As used in this Act, the terms "Magnuson Act", "At-
- 5 lantic striped bass", and "coastal waters" have the same
- 6 meanings that are given such terms in section 2 of the
- 7 Atlantic Striped Bass Conservation Act (16 U.S.C. 1851
- 8 note).

1 SEC. 2. PROHIBITION ON COMMERCIAL HARVESTING OF

- 2 ATLANTIC STRIPED BASS.
- 3 (a) Prohibition.—It is unlawful to engage in, or to
- 4 attempt to engage in, the commercial harvesting of Atlan-
- 5 tic striped bass in the coastal waters or in the exclusive
- 6 economic zone established by Proclamation Numbered
- 7 5030, dated March 10, 1983.
- 8 (b) PENALTIES.—(1) Any person who is found by the
- 9 Secretary of Commerce after notice and an opportunity
- 10 for a hearing in accordance with section 554 of title 5,
- 11 United States Code, to have committed an act that is un-
- 12 lawful under subsection (a), is liable to the United States
- 13 for a civil penalty. The amount of the civil penalty may
- 14 not exceed \$1,000 for each violation. Each day of continu-
- 15 ing violation constitutes a separate offense. The amount
- 16 of the civil penalty shall be assessed by the Secretary of
- 17 Commerce by written notice. In determining the amount
- 18 of the penalty, the Secretary of Commerce shall take into
- 19 account the nature, circumstances, extent, and gravity of
- 20 the prohibited act committed and, with respect to the vio-
- 21 lator, the degree of culpability, any history of prior viola-
- 22 tions, ability to pay, and such other matters as justice may
- 23 require.
- 24 (2) Subsections (b) through (e) of section 308 of the
- 25 Magnuson Act (16 U.S.C. 1858(b)–(e); relating to review
- 26 of civil penalties; acting upon failure to pay assessment,

- 1 compromise, and subpoenas) shall apply to penalties as-
- 2 sessed under paragraph (1) to the same extent and in the
- 3 same manner as if those penalties were assessed under
- 4 subsection (a) of such section 308.
- 5 (c) CIVIL FORFEITURES.—(1) Any vessel (including
- 6 its gear, equipment, appurtenances, stores, and cargo)
- 7 used, and any fish (or the fair market value thereof) taken
- 8 or retained, in any manner, in connection with, or the re-
- 9 sult of, the commission of any act that is unlawful under
- 10 subsection (a), is subject to forfeiture to the United
- 11 States. All or part of the vessel may, and all such fish
- 12 (or the fair market value thereof) shall, be forfeited to the
- 13 United States under a civil proceeding described in para-
- 14 graph (2). The district courts of the United States have
- 15 jurisdiction over proceedings under this subsection.
- 16 (2) Subsections (c) through (e) of section 310 of the
- 17 Magnuson Act (16 U.S.C. 1860(c)–(e); relating to judg-
- 18 ment, procedure, and rebuttable presumptions) apply with
- 19 respect to proceedings for forfeiture commenced under
- 20 this subsection to the same extent and in the same manner
- 21 as if the proceeding were commenced under subsection (a)
- 22 of such section 310.
- 23 SEC. 3. CONSEQUENTIAL EFFECTS ON EXISTING LAW.
- 24 (a) COMMISSION ACTION.—The Atlantic States Ma-
- 25 rine Fisheries Commission shall promptly take action to

- 1 amend the Interstate Fisheries Management Plan for
- 2 Striped Bass, dated October 1, 1981, to take into account
- 3 the prohibition established under section 2 on the commer-
- 4 cial harvesting of Atlantic striped bass in coastal waters.
- 5 (b) Striped Bass Study.—The Director of the
- 6 United States Fish and Wildlife Service shall adjust the
- 7 scope of the study required under section 5 of Public Law
- 8 100–589 (16 U.S.C. 1851 note) to reflect the prohibition
- 9 established under section 2 on the commercial harvesting
- 10 of Atlantic striped bass.
- 11 (c) Repeal of Provisions Regulating Fishing
- 12 FOR ATLANTIC STRIPED BASS IN THE EXCLUSIVE ECO-
- 13 NOMIC ZONE.—Section 6 of Public Law 100-589 (16
- 14 U.S.C. 1851 note) is repealed.
