A BILL

To rescind certain unauthorized supplemental appropriations for fiscal year 1994, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Supplemental Appro-
5 priations Rescissions Act of 1994”.

1 **SEC. 2. RESCISSION OF FUNDS FOR AUTOMATION OF FIN-**
2 **GERPRINT IDENTIFICATION SERVICES.**

3 Of the funds made available under the heading “Fed-
4 eral Bureau of Investigation—Salaries and Expenses” in
5 chapter 2 of title II of Public Law 103–211, \$20,000,000
6 is rescinded.

7 **SEC. 3. REPEAL OF AUTHORITY TO USE CERTAIN PRO-**
8 **CEEDS FOR NUCLEAR SHIP SAVANNAH.**

9 Chapter 2 of title II of Public Law 103–211 is
10 amended by striking the paragraph under the heading
11 “Maritime Administration—Administrative Provision”.

12 **SEC. 4. RESCISSION OF FUNDS FOR CONVERSION OF POST**
13 **OFFICE TO TRAIN STATION AND COMMER-**
14 **CIAL CENTER.**

15 Of the funds made available under the heading “Fed-
16 eral Railroad Administration—Pennsylvania Station Re-
17 development Project” in chapter 6 of title II of Public Law
18 103–211, \$10,000,000 is rescinded.

19 **SEC. 5. RESCISSION OF FUNDS FOR HILO-HAMAKUA COAST**
20 **OF HAWAII.**

21 (a) IN GENERAL.—Of the \$260,000,000 earmarked
22 for special purpose grants in the 14th proviso under the
23 heading “Department of Housing and Urban Develop-
24 ment—Housing Programs—Annual Contributions for As-
25 sisted Housing” in Public Law 102–389, \$1,300,000 is
26 rescinded, to be derived from the amount made available

1 for continued assistance to 2 sugarcane mills on the Hilo-
2 Hamakua Coast of Hawaii.

3 (b) RELATED REPEAL.—Chapter 8 of title II of Pub-
4 lic Law 103–211 is amended by striking the 1st paragraph
5 under the heading “Department of Housing and Urban
6 Development—Housing Programs—Administrative Provi-
7 sions”.
