- SONAL EFFECTS OF PARTICIPANTS IN CERTAIN WORLD ATHLETIC EVENTS.

  (a) IN GENERAL.—Subchapter II of chapter 99 of the Harmonized Tariff Schedule of the United States is amended by inserting in numerical sequence the following new heading:

- 8 (b) Taxes and Fees Not To Apply.—The articles 9 described in heading 9902.98.04 of the Harmonized Tariff 0 Schedule of the United States (as added by subsection (a))

- 9 of the Tariff Act of 1930 or any other provision of law,
- 10 upon proper request (which includes sufficient information
- 11 to identify and locate the entry) filed with the Customs
- 12 Service on or before the date that is 180 days after the
- 13 date of the enactment of this Act, any entry, or withdrawal
- 14 from warehouse for consumption, of an article described
- 15 in heading 9902.98.04 of the Harmonized Tariff Schedule
- 16 of the United States (as added by section 1) that oc-
- 17 curred—
- 18 (1) after December 31, 1993, and before the
- date which is 15 days after the date of the enact-
- 20 ment of this Act, and
- 21 (2) with respect to which there would have been
- 22 no duty if the amendment made by section 1 applied
- to such entry or withdrawal,
- 24 shall be liquidated or reliquidated as though such amend-
- 25 ment applied to such entry or withdrawal.
