A BILL

- 2 The Congress finds that—
- 3 (1) in 1988, Congress enacted Public Law 100-
- 4 460, establishing the Lower Mississippi Delta Devel-
- 5 opment Commission, to assess the needs, problems,
- and opportunities of people living in the Lower Mis-
- 7 sissippi Delta Region that includes 219 counties and
- 8 parishes within the States of Arkansas, Illinois, Ken-
- 9 tucky, Louisiana, Mississippi, Missouri, and Ten-
- 10 nessee;

- (2) the Commission conducted a thorough investigation to assess these needs, problems, and opportunities, and held several public hearings throughout the Delta Region;
 - (3) on the basis of these investigations, the Commission issued the Delta Initiatives Report, which included recommendations on natural resource protection, historic preservation, and the enhancement of educational and other opportunities in the areas of mathematics and science and technology transfer for Delta residents;
 - (4) the Delta Initiatives Report recommended—
 - (A) the implementation of pre-college education programs in mathematics and science as well as other initiatives to enhance the educational and technical capabilities of the Delta Region's workforce;
 - (B) that States and local school systems seek ways to expand the pool of qualified educators in mathematics and sciences;
 - (C) that institutions of higher education in the Delta Region work with local school districts to promote mathematics and science education;

2	target more research and development monies

5	SEC. 4. DEFINITIONS.
6	As used in this Act, the term—
7	(1) "Commission" means the Lower Mississippi
8	Delta Development Commission established pursuant
9	to Public Law 100–460;
10	(2) "Delta Initiatives Report" means the May
11	14, 1990 Final Report of the Commission entitled
12	"The Delta Initiatives: Realizing the Dream * * *

14	(3) "Delta Region" means the Lower Mis-
15	sissippi Delta Region including the 219 counties and
16	parishes within the States of Arkansas, Illinois, Ken-
17	tucky, Louisiana, Mississippi, Missouri, and Ten-
18	nessee, as defined in the Delta Initiatives Report,
19	except that, for any State for which the Delta Re-

20	SEC. 102. NATURAL RESOURCES AND ENVIRONMENTAL
21	EDUCATIONAL INITIATIVES.
22	(a) Office of Education.—(1) There shall be es-
23	tablished within the Department an Office of Education
	to encourage, support, and coordinate education programs

- of the Department at the elementary, secondary, college and university, and graduate levels. 3 (2) The goals of the Office of Education shall be to— (A) enhance the quality of education in the areas of natural resources, the environment, the sciences, cultural resources management, historic 6 7 preservation, archeology, aquaculture, and related subjects; 8 (B) establish initiatives at minority colleges or 9 10 universities: 11 (C) encourage the consideration of careers in 12 the areas of natural resources, the environment, the sciences, cultural resource management, historic 13 preservation, archeology, aquaculture, and related 14 subjects; 15 (D) enhance teacher development and recruit-16 17 ment: 18 (E) increase research opportunities for teachers 19 and students: 20 (F) enhance curriculum development; and (G) improve laboratory instrumentation and 21 22 equipment through purchase, loan, or other transfer
- 24 (b) DUTIES.—The duties of the Secretary, through 25 the Office of Education, shall be to—

- 1 (1) coordinate the educational programs within 2 the Department, including implementation of pro-3 grams established under this title, in order to ensure 4 the goals of the Office of Education are met; and
- (2) inventory existing education programs with-in the Department.
- 7 (c) The Secretary shall report to Congress, within one
- 8 year after the date of the enactment of this Act and annu-
- 9 ally thereafter, on an inventory of existing education pro-
- 10 grams of the Department, the status of such programs,
- 11 and progress toward meeting the goals of the Office of
- 12 Education as established in this Act.
- 13 (d) Minority College and University Initia-
- 14 TIVE.—(1) Within one year after the date of enactment
- 15 of this Act, and annually thereafter, the Secretary,
- 16 through the Office of Education, shall submit to the Com-
- 17 mittee on Energy and Natural Resources of the United
- 18 States Senate and to the United States House of Rep-
- 19 resentatives a report identifying opportunities for minority
- 20 colleges or universities to participate in programs and ac-
- 21 tivities carried out by the Department. The Secretary,
- 22 through the Office of Education, shall consult with rep-
- 23 resentatives of minority colleges or universities in prepar-
- 24 ing the report. Such report shall—

- (A) describe ongoing education and training programs carried out by the Department with respect to, or in conjunction with, minority colleges or universities in the areas of natural resources, the environment, the sciences, cultural resource management, historic preservation, archeology, aquaculture, and related subjects;
 - (B) describe ongoing research, development or demonstration programs involving the Department and minority colleges or universities;
 - (C) describe funding levels for the programs referred to in subparagraphs (A) and (B);
 - (D) include specific proposals and recommendations for providing assistance to minority colleges and universities to enter into memoranda of understanding and other appropriate forms of agreement with the Department in order to plan and develop programs to foster greater involvement of these schools in the contract, research, education, training, and recruitment activities of the Department;
 - (E) address the need for, and potential role of, the Department in providing minority colleges or universities with—
- 24 (i) increased research opportunities for fac-25 ulty and students;

2	recruitment;
3	(iii) curriculum enhancement and develop-

8	(F) address the need for, and potential role of,
9	the Department in providing financial and technical
10	assistance for the development of infrastructure fa-
11	cilities, including buildings and laboratory facilities,
12	at minority colleges or universities; and
13	(G) include specific proposals and recommenda-
14	tions, together with estimates of necessary funding
15	levels, for initiatives to be carried out by the Depart-
16	ment in order to assist minority colleges or univer-
17	sities in providing education and training in the
18	areas of natural resources, the environment, the
19	sciences, cultural resource management, historic
20	preservation, archeology, aquaculture, and related
21	subjects.
22	(2) The Secretary, through the Office of Education,
23	shall encourage memoranda of understanding and other
24	appropriate forms of agreement between the Department
25	and minority colleges or universities directed at jointly

- 1 planning and developing programs to foster greater in-
- 2 volvement of minority colleges or universities in the re-
- 3 search, education, training, and recruitment activities of
- 4 the Department.
- 5 (e) Scholarship Program.—The Secretary,
- 6 through the Office of Education, shall establish a scholar-
- 7 ship program for students pursuing undergraduate or
- 8 graduate degrees in natural resource and environmental
- 9 related fields including, but not limited to: biology, wildlife
- 10 biology, forestry, botany, horticulture, historic preserva-
- 11 tion, cultural resource management, archeology, anthro-
- 12 pology, aquaculture, geology, engineering, the environ-
- 13 ment, the sciences, and ecology at minority colleges and
- 14 universities in the Delta Region. The scholarship program
- 15 shall include tuition assistance. Recipients of such scholar-
- 16 ships shall be students deemed by the Secretary to have
- 17 demonstrated (1) a need for such assistance; and (2) aca-
- 18 demic potential in the particular area of study.
- 19 (f) Pre-College Education.—The Secretary,
- 20 through the Office of Education, shall undertake activities
- 21 to encourage pre-college education programs in subjects
- 22 relating to natural resources, the environment, the
- 23 sciences, cultural resource management, historic preserva-
- 24 tion, archeology, aquaculture, and related subjects, for

- 1 students in the Delta Region. Such activities shall include,
- 2 but not be limited to, the following:

- (1) Cooperation with, and assistance to, State departments of education and local school districts in the Delta Region to develop and carry out after school and summer education programs for elementary, middle, and secondary school students.
 - (2) Cooperation with, and assistance to, institutions of higher education in the Delta Region to develop and carry out pre-college education programs for elementary, middle, and secondary school students.
 - (3) Cooperation with, and assistance to, State departments of education and local school districts in the Delta Region in the development and use of curriculum and educational materials.
 - (4) The establishment of education programs for elementary, middle, and secondary school teachers in the Delta Region at research facilities of the Department.
- 21 (g) VOLUNTEER PROGRAM.—The Secretary, through 22 the Office of Education, shall establish and carry out a 23 program to encourage the involvement on a voluntary 24 basis of qualified employees of the Department in edu-25 cational enrichment programs relating to natural re-

- 1 sources, the environment, the sciences, cultural resource
- 2 management, historic preservation, archeology, aqua-
- 3 culture, and related subjects, in cooperation with State de-
- 4 partments of education and local school districts in the
- 5 Delta Region.
- 6 (h) Women and Minorities in the Sciences.—
- 7 The Secretary, through the Office of Education, shall es-
- 8 tablish a Center for Excellence in the Sciences at Alcorn
- 9 State in Lorman, Mississippi, in cooperation with South-
- 10 ern University in Baton Rouge, Louisiana, and the Uni-
- 11 versity of Arkansas at Pine Bluff, Arkansas, and other
- 12 minority colleges or universities for purposes of encourag-
- 13 ing women and minority students in the Delta Region to
- 14 study and pursue careers in the sciences. The Center shall
- 15 enter into cooperative agreements with Southern Univer-
- 16 sity in Baton Rouge, Louisiana, and the University of Ar-
- 17 kansas at Pine Bluff, Arkansas, and other minority col-
- 18 leges and universities in the Delta Region, to carry out
- 19 affiliated programs and coordinate programs activities at
- 20 such colleges and universities. The Secretary is authorized
- 21 to provide grants and other forms of financial assistance
- 22 to the Center.
- 23 (i) Center for Aquaculture Studies.—The Sec-
- 24 retary, through the Office of Education, shall establish a
- 25 Center for Aquaculture Studies at the University of Ar-

- 1 kansas at Pine Bluff, Arkansas, in cooperation with
- 2 Southern University in Baton Rouge, Louisiana, and
- 3 Alcorn State in Lorman, Mississippi, and other minority
- 4 colleges or universities for purposes of encouraging women
- 5 and minority students in the Delta Region to study and
- 6 pursue careers in the field of aquaculture. The Center
- 7 shall enter into cooperative agreements with Southern
- 8 University in Baton Rouge, Louisiana, and Alcorn State
- 9 in Lorman, Mississippi, and other minority colleges or uni-
- 10 versities in the Delta Region to carry out affiliated pro-
- 11 grams and coordinate program activities at such colleges
- 12 or universities.
- 13 (j) COORDINATION WITH OTHER FEDERAL AGEN-
- 14 CIES.—The Secretary, through the Office of Education,
- 15 shall ensure that the programs authorized in this section
- 16 are coordinated with, and complimentary to, educational
- 17 assistance programs administered by other Federal agen-
- 18 cies. These agencies include, but are not limited to, the
- 19 Department of Energy, the Department of Agriculture,
- 20 the Department of Education, the Department of Defense,
- 21 the National Science Foundation, and the National Aero-
- 22 nautics and Space Administration.

1 SEC. 103. LOWER MISSISSIPPI DELTA REGION HERITAGE

- 2 STUDY.
- 3 (a) IN GENERAL.—The Secretary, in consultation
- 4 with the States of the Delta Region, the Lower Mississippi
- 5 Delta Development Center, and other appropriate Delta
- 6 Region institutions, is directed to prepare and transmit
- 7 to the Congress within three years after the date of the
- 8 enactment of this Act, a study of significant natural, rec-
- 9 reational, historical or prehistorical, and cultural lands,
- 10 waters, sites, and structures located within the Delta Re-
- 11 gion. This study shall take into consideration the research
- 12 and inventory of resources conducted by the Mississippi
- 13 River Heritage Corridor Study Commission.
- 14 (b) Transportation Routes.—(1) The study shall
- 15 include recommendations on appropriate designation and
- 16 interpretation of historically significant roads, trails, by-
- 17 ways, waterways, or other routes within the Delta Region.
- 18 (2) In order to provide for public appreciation, edu-
- 19 cation, understanding, interpretation, and enjoyment of
- 20 the significant sites identified pursuant to subsection (a),
- 21 which are accessible by public roads, the Secretary shall
- 22 recommend in the study vehicular tour routes along exist-
- 23 ing public roads linking such sites within the Delta Re-
- 24 gion.
- 25 (3) Such recommendations shall include an analysis
- 26 of designating the Great River Road (as depicted on the

- 1 map entitled "Proposed Delta Transportation Network"
- 2 on pages 102-103 of the Delta Initiatives Report) and
- 3 other sections of the Great River Road between Baton
- 4 Rouge and New Orleans, Louisiana and an analysis of
- 5 designating that portion of the Old Antonio Road and the
- 6 Louisiana Natchez Trace which extends generally along
- 7 Highway 84 from Vidalia, Louisiana, to Clarence, Louisi-
- 8 ana, and Louisiana Highway 6 from Clarence, Louisiana,
- 9 to the Toledo Bend Reservoir, Louisiana, as a National
- 10 Scenic Byway, or as a component of the National Trails
- 11 System, or such other designation as the Secretary deems
- 12 appropriate.
- 13 (4) The Secretary shall also recommend in the study
- 14 an appropriate route along existing public roads to com-
- 15 memorate the importance of timber production and trade
- 16 to the economic development of the Delta Region in the
- 17 early twentieth century, and to highlight the continuing
- 18 importance of timber production and trade to the eco-
- 19 nomic life of the Delta Region. Recommendations shall in-
- 20 clude an analysis of designating that portion of US 165
- 21 which extends from Alexandria, Louisiana, to Monroe,
- 22 Louisiana, as a National Scenic Byway, or as a component
- 23 of the National Trails System, or such other designation
- 24 as the Secretary deems appropriate.

- 1 (5) The study shall also include a comprehensive
- 2 recreation, interpretive, and visitor use plan for the routes
- 3 described in the above paragraphs, including bicycle and
- 4 hiking paths, and make specific recommendations for the
- 5 acquisition and construction of related interpretive and
- 6 visitor information facilities at selected sites along such
- 7 routes.
- 8 (6) The Secretary is authorized to make grants to
- 9 States for work necessary to stabilize, maintain, and widen
- 10 public roads to allow for adequate access to the nationally
- 11 significant sites and structures identified by the study, to
- 12 allow for proper use of the vehicular tour route, trails, by-
- 13 ways, including the routes defined in paragraphs (3) and
- 14 (4) or other public roads within the Delta Region and to
- 15 implement the comprehensive recreation, interpretive, and
- 16 visitor use plan required in paragraph (5).
- 17 (c) Listing.—On the basis of the study, and in con-
- 18 sultation with the National Trust for Historic Preserva-
- 19 tion, the Secretary shall inventory significant structures
- 20 and sites in the Delta Region. The Secretary shall further
- 21 recommend and encourage cooperative preservation and
- 22 economic development efforts such as the establishment
- 23 of preservation districts linking groups of contiguous
- 24 counties or parishes, especially those that lie along the
- 25 aforementioned designated routes. The Secretary shall

- prepare a list of the sites and structures for possible inclusion by the National Park Service as National Historic Landmarks of such other designation as the Secretary 4 deems appropriate. SEC. 104. DELTA REGION HERITAGE CORRIDORS AND HER-6 ITAGE AND CULTURAL CENTERS. 7 (a) FINDINGS.—The Congress finds that— (1) in 1990, the Congress authorized the Insti-8 9 tute of Museum Services to prepare a report assess-10 ing the needs of small, emerging, minority, and rural 11 museums in order to identify the resources such mu-12 seums needed to meet their education mission, to 13 identify the areas of museum operation in which the 14 needs were greatest, and to make recommendations on how these needs could best be met; 15 (2) the Institute of Museum Services undertook 16 17 a comprehensive eighteen month study of such needs 18 with the assistance of two advisory groups, surveyed 19 524 museums from throughout the Nation, held dis-20 cussion groups in which representatives of 25 museum groups participated, and conducted case stud-21
 - (3) on the basis of this assessment, the Institute of Museum Services issued a report in September 1992, entitled, "National Needs Assessment of

ies of 12 museum facilities around the Nation;

- Small, Emerging, Minority and Rural Museums in the United States" (hereinafter "National Needs As-sessment") which found that small, emerging, mi-nority, and rural museums provide valuable educational and cultural resources for their communities and contain a reservoir of the Nation's material, cul-tural and scientific heritage, but due to inadequate resources are unable to meet their full potential or the demands of the surrounding communities;
 - (4) the needs of these institutions are not being met through existing Federal programs;
 - (5) fewer than half of the participants in the survey had applied for Federal assistance in the past two years and that many small, emerging, minority and rural museums believe existing Federal programs do not meet their needs;
 - (6) based on the National Needs Assessment, that funding agencies should increase support available to small, emerging, minority, and rural museums and make specific recommendations for increasing technical assistance in order to identify such institutions and provide assistance to facilitate their participation in Federal programs;
 - (7) the Delta Initiatives Report made specific recommendations for the creation and development

- of centers for the preservation of the cultural, historical, scientific and literary heritage of the Delta Region, including recommendations for the establishment of a Delta Region Native American Heritage and Cultural Center and a Delta Region African American Heritage and Cultural Center with additional satellite centers or museums linked throughout the Delta Region;
 - (8) the Delta Initiatives Report stated that new ways of coordinating, preserving, and promoting the Delta Region's literature, art, and music should be established including the creation of a network to promote the Delta Region's literary, artistic, and musical heritage; and
 - (9) wholesale destruction and attrition of archeological sites and structures has eliminated a significant portion of Native American heritage as well as the interpretive potential of the Delta Region's parks and museums. Furthermore, site and structure destruction is so severe that an ambitious program of site and structure acquisition in the Delta Region is necessary.
- 23 (b) GENERAL.—The Secretary, in consultation with 24 the States of the Delta Region, the Chairman of the Na-25 tional Endowment for the Arts, the Chairman of the Na-

- 1 tional Endowment for the Humanities, the Director of the
- 2 Smithsonian Institution, the Lower Mississippi Delta De-
- 3 velopment Center, Historically Black Colleges and Univer-
- 4 sities, other Delta Regional educational institutions, and
- 5 appropriate African American and Native American orga-
- 6 nizations in the Delta Region, is further directed to pre-
- 7 pare and transmit to the Congress a plan outlining specific
- 8 recommendations, including recommendations for nec-
- 9 essary funding, for the establishment of a Delta Region
- 10 Native American Heritage Corridor and Heritage and Cul-
- 11 tural Center with a network of satellite or cooperative
- 12 units.
- 13 (c) Delta Region Native American Heritage
- 14 CORRIDOR AND CULTURAL CENTER.—(1) The plan re-
- 15 ferred to in subsection (b) of this section shall include rec-
- 16 ommendations for establishing a network of parks, muse-
- 17 ums, and other centers to interpret Native American cul-
- 18 ture and heritage in the Delta Region, including a ten year
- 19 development strategy for such a network.
- 20 (2) Such plan shall include specific proposals for the
- 21 development of a Native American Heritage Corridor and
- 22 Heritage and Cultural Center in the Delta Region, along
- 23 with recommendations for the appropriate Federal role in
- 24 such a center including matching grants, technical and
- 25 interpretive assistance.

- 1 (3) Such plan shall be conducted in consultation with
- 2 tribal leaders in the Delta Region.
- 3 (4) Such plan shall also include specific proposals for
- 4 educational and training assistance for Delta Region Na-
- 5 tive Americans to carry out the recommendations provided
- 6 in the study.
- 7 (d) Delta Region African American Heritage
- 8 Corridor and Heritage and Cultural Center.—(1)
- 9 The plan referred to in subsection (b) of this section shall
- 10 include recommendations for establishing a heritage cor-
- 11 ridor or trail system, consisting of one or two major north-
- 12 south routes and several east-west-spur loops to preserve,
- 13 interpret and commemorate the African American herit-
- 14 age and culture in the Delta Region during all significant
- 15 historical periods.
- 16 (2) Such plan shall make specific recommendations
- 17 for representing all forms of expressive culture including
- 18 the musical, folklore, literary, artistic, scientific, historical,
- 19 educational, and political contributions and accomplish-
- 20 ments of African Americans in the Delta Region.
- 21 (3) Such plan shall make specific recommendations
- 22 for implementing the findings of the Delta Initiatives Re-
- 23 port with respect to establishing an African American

- 2 forms of financial assistance to the Center.
- 3 (f) COORDINATION WITH OTHER FEDERAL AGEN-
- 4 CIES.—The Secretary shall ensure that the programs au-
- 5 thorized in this section are coordinated with, and com-
- 6 plimentary to, education assistance programs adminis-
- 7 tered by the Department and by other Federal agencies
- 8 in the Delta Region. These agencies include, but are not
- 9 limited to, the Department of the Interior, the Depart-
- 10 ment of Agriculture, and Department of Education, the
- 11 National Science Foundation, and the National Aero-
- 12 nautics and Space Administration.
- 13 (g) AUTHORIZATION OF APPROPRIATIONS.—There is
- 14 hereby authorized to be appropriated such sums as may
- 15 be necessary to carry out the purposes of this section.

16 SEC. 205. INTEGRATED BIOMASS ENERGY SYSTEMS

- 17 (a) Program Direction.—The Secretary, in con-
- 18 sultation with the Secretary of Agriculture, shall conduct
- 19 a research, development and demonstration program to
- 20 determine the economic viability of integrated biomass en-
- 21 ergy systems within the Delta Region.
- 22 (b) Program Plan.—Not later than six months
- 23 after the date of enactment of this Act, the Secretary shall
- 24 prepare and submit to the Congress a program plan to

1	(c) Solicitation of Proposals.—Not later than

7	(1) involve the production of dedicated energy

10	(2) include predominantly herbaceous energy
11	crops;
12	(3) include predominantly short-rotation woody
13	crops;
14	(4) demonstrate cost-effective methods for
15	growing, harvesting, storing, transporting, and pre-
16	paring energy crops for conversion to electricity or
17	transportation fuel; and
18	(5) result in the conversion of such crops to
19	electricity or transportation fuel by a non-Federal
20	energy producer or the Tennessee Valley Authority.
21	(d) Cost Sharing.—(1) For research and develop-
22	ment programs carried out under this section, the Sec-
23	retary shall require a commitment from non-Federal
24	sources of at least 20 percent of the cost of the project.

- 1 (2) The Secretary shall require at least 50 percent
- 2 of the costs directly and specifically related to any dem-
- 3 onstration or commercial application project under this
- 4 section to be provided from non-Federal sources. The Sec-
- 5 retary may reduce the non-Federal requirement under this
- 6 section if the Secretary determines that the reduction is
- 7 necessary and appropriate considering the technological
- 8 risks involved in the project and is necessary to meet the
- 9 objectives of this section.
- 10 (3) In calculating the amount of the non-Federal
- 11 commitment under paragraph (1) or (2), the Secretary
- 12 shall include cash, personnel, services, equipment, and
- 13 other resources.
- 14 (e) AUTHORIZATION OF APPROPRIATIONS.—There is
- 15 authorized to be appropriated for purposes of carrying out
- 16 this section, to remain available until expended, not more
- 17 than \$10,000,000 for each of fiscal years 1995, 1996, and
- 18 1997.
- 19 SEC. 206. WEATHERIZATION ASSISTANCE PROGRAM FOR
- 20 THE DELTA REGION
- 21 Title IV of the Energy Conservation and Production
- 22 Act (42 U.S.C. 6851, 6861–6846) is further amended by
- 23 adding a new section 423 as follows:

1	"WEATHERIZATION ASSISTANCE PROGRAM FOR THE
2	DELTA REGION
3	"Sec. 423. (a) Purpose.—The purpose of this sec-
4	tion is to encourage the weatherization of low-income
5	dwelling units in the Delta Region.
6	"(b) Grants for Establishment of Program.—
7	Not later than 12 months after the date of the enactment
8	of the Lower Mississippi Delta Initiatives Act of 1993, the
9	Secretary shall make grants to (1) States, and (2) in ac-
10	cordance with the provisions of subsection $(413)(d)$, to In-
11	dian tribal organizations to serve Native Americans in the
12	Delta Region. Such grants shall be made for the purposes
13	of providing financial assistance for the weatherization of
14	low-income dwelling units.
15	"(c) Applications.—(1) Applications of States or
16	Indian tribal organizations for grants under this section
17	shall be made not more than once for any fiscal year. Such
18	applications shall be submitted to the State weatherization
19	agency, in consultation with Community Action Agencies
20	and Planning and Development Districts in the Delta Re-
21	gion, and the State weatherization agency shall make a
22	single submittal to the Secretary containing all applica-
23	tions which comply with subsection (e).
24	"(2) Applications for grants for energy conservation
25	projects shall contain, or be accompanied by, such infor-

- 1 mation as the Secretary may reasonably require in accord-
- 2 ance with regulations governing weatherization assistance
- 3 programs under this Part.
- 4 "(d) SELECTION OF APPLICATIONS.—(1) The Sec-
- 5 retary shall select applications from States to receive
- 6 grants under subsection (b).
- 7 "(2) Such grants shall be in addition to such grants
- 8 as would otherwise be provided under section 414 of this
- 9 Act.
- 10 "(3) No one grant recipient under this section shall
- 11 receive Federal funds in excess of \$2,000,000.
- 12 "(e) SELECTION CRITERIA.—The Secretary shall se-
- 13 lect recipients of grants under this section in accordance
- 14 with the requirements of sections 414(b) and 415 of this
- 15 Act, and on the basis of the following criteria:
- 16 "(1) The location of the grant applicant in the
- 17 Delta Region.
- 18 "(2) The demonstrated or potential resources
- available to the grant applicant for carrying out the
- 20 purposes of this section.
- 21 "(3) The demonstrated or potential ability of
- the grant applicant to improve energy efficiency in
- low-income dwelling units.
- 24 "(f) COORDINATION WITH OTHER WEATHERIZATION
- 25 Assistance Programs.—The Secretary shall ensure that

- 1 the programs authorized in this section are coordinated
- 2 with, and complimentary to, Department weatherization
- 3 assistance programs under sections 413, 414A and 414B
- 4 of this Act.
- 5 "(g) Definition.—For purposes of this section, the
- 6 term 'Delta Region' means the Lower Mississippi Delta
- 7 Region including the 219 counties and parishes within the
- 8 States of Arkansas, Illinois, Kentucky, Louisiana, Mis-
- 9 sissippi, Missouri, and Tennessee, as defined in the May
- 10 14, 1990 Final Report of the Lower Mississippi Delta De-
- 11 velopment Commission entitled 'The Delta Initiatives: Re-
- 12 alizing the Dream * * * Fulfilling the Potential'.
- 13 "(h) AUTHORIZATION OF APPROPRIATIONS.—There
- 14 is authorized to be appropriated for purposes of carrying
- 15 out this section, to remain available until expended, not
- 16 more than \$20,000,000 for each of fiscal years 1995,
- 17 1996, and 1997.".
- 18 SEC. 207. RENEWABLE ENERGY PRODUCTION INCENTIVES.
- 19 Section 1212 of the Energy Policy Act of 1992
- 20 (42 U.S.C. 13317) is amended by inserting immediately
- 21 after "foregoing," the following: "by the Tennessee Valley
- 22 Authority,".

- There is authorized to be appropriated \$350,000 for

- 25 main available until expended.
