AN ACT

To reform the concept of baseline budgeting.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Baseline Reform Act
5 of 1994”.

6 **SEC. 2. THE BASELINE.**

7 (a) The second sentence of section 257(c) of the Bal-
8 anced Budget and Emergency Deficit Control Act of 1985
9 is amended—

1 (1) by inserting “but only for the purpose of
2 adjusting the discretionary spending limits set forth
3 in section 601(a)(2) of the Congressional Budget
4 Act of 1974” after “for inflation as specified in
5 paragraph (5); and

6 (2) by inserting “but only for the purpose of
7 adjusting the discretionary spending limits set forth
8 in section 601(a)(2) of the Congressional Budget
9 Act of 1974” after “to offset pay absorption and for
10 pay annualization as specified in paragraph (4)”.

11 (b) Section 1109(a) of title 31, United States Code,
12 is amended by adding after the first sentence the following
13 new sentence: “These estimates shall not include an ad-
14 justment for inflation for programs and activities subject
15 to discretionary appropriations.”.

16 **SEC. 3. THE PRESIDENT’S BUDGET.**

17 (a) Paragraph (5) of section 1105(a) of title 31,
18 United States Code, is amended to read as follows:

19 “(5) except as provided in subsection (b) of this
20 section, estimated expenditures and appropriations
21 for the current year and estimated expenditures and
22 proposed appropriations the President decides are
23 necessary to support the Government in the fiscal
24 year for which the budget is submitted and the 4 fis-
25 cal years following that year;”.

1 (b) Section 1105(a)(6) of title 31, United States
2 Code, is amended by inserting “current fiscal year and
3 the” before “fiscal year”.

4 (c) Section 1105(a)(12) of title 31, United States
5 Code, is amended by striking “and” at the end of subpara-
6 graph (A), by striking the period and inserting “; and”
7 at the end of subparagraph (B), and by adding at the end
8 the following new subparagraph:

9 “(C) the estimated amount for the same activ-
10 ity (if any) in the current fiscal year.”.

11 (d) Section 1105(a)(18) of title 31, United States
12 Code, is amended by inserting “new budget authority
13 and” before “budget outlays”.

14 (e) Section 1105(a) of title 31, United States Code,
15 is amended by adding at the end the following new para-
16 graph:

17 “(30) a comparison of levels of estimated ex-
18 penditures and proposed appropriations for each
19 function and subfunction in the current fiscal year
20 and the fiscal year for which the budget is submit-
21 ted, along with the proposed increase or decrease of
22 spending in percentage terms for each function and
23 subfunction.”.

1 **SEC. 4. THE CONGRESSIONAL BUDGET.**

2 Section 301(e) of the Congressional Budget Act of
3 1974 is amended by—

4 (1) inserting after the second sentence the fol-
5 lowing: “The starting point for any deliberations in
6 the Committee on the Budget of each House on the
7 concurrent resolution on the budget for the next fis-
8 cal year shall be the estimated level of outlays for
9 the current year in each function and subfunction.
10 Any increases or decreases in the Congressional
11 budget for the next fiscal year shall be from such es-
12 timated levels.”; and

13 (2) striking paragraph (8) and redesignating
14 paragraphs (9) and (10) as paragraphs (10) and
15 (11), respectively, and by inserting after paragraph
16 (7) the following new paragraphs:

17 “(8) a comparison of levels for the current fis-
18 cal year with proposed spending and revenue levels
19 for the subsequent fiscal years along with the pro-
20 posed increase or decrease of spending in percentage
21 terms for each function and subfunction; and

22 “(9) information, data, and comparisons indi-
23 cating the manner in which and the basis on which,
24 the committee determined each of the matters set
25 forth in the concurrent resolution;”.

1 **SEC. 5. CONGRESSIONAL BUDGET OFFICE REPORTS TO**
2 **COMMITTEES.**

3 (a) The first sentence of section 202(f)(1) of the Con-
4 gressional Budget Act of 1974 is amended to read as fol-
5 lows: “On or before February 15 of each year, the Direc-
6 tor shall submit to the Committees on the Budget of the
7 House of Representatives and the Senate a report for the
8 fiscal year commencing on October 1 of that year with
9 respect to fiscal policy, including (A) alternative levels of
10 total revenues, total new budget authority, and total out-
11 lays (including related surpluses and deficits) compared
12 to comparable levels for the current year and (B) the levels
13 of tax expenditures under existing law, taking into account
14 projected economic factors and any changes in such levels
15 based on proposals in the budget submitted by the Presi-
16 dent for such fiscal year.”.

17 (b) Section 202(f)(1) of the Congressional Budget
18 Act of 1974 is amended by inserting after the first sen-
19 tence the following new sentence: “That report shall also
20 include a table on sources of spending growth in total
21 mandatory spending for the budget year and the ensuing
22 4 fiscal years, which shall include changes in outlays at-
23 tributable to the following: cost-of-living adjustments;
24 changes in the number of program recipients; increases
25 in medical care prices, utilization and intensity of medical
26 care; and residual factors.”.

1 (c) Section 308(a)(1) of the Congressional Budget
2 Act of 1974 is amended—

3 (1) in subparagraph (C), by inserting “, and
4 shall include a comparison of those levels to com-
5 parable levels for the current fiscal year” before “if
6 timely submitted”; and

7 (2) by striking “and” at the end of subpara-
8 graph (C), by striking the period and inserting “;
9 and” at the end of subparagraph (D), and by adding
10 at the end the following new subparagraph:

11 “(E) comparing the levels in existing pro-
12 grams in such measure to the estimated levels
13 for the current fiscal year.”

14 (d)(1) Title IV of the Congressional Budget Act of
15 1974 is amended by adding at the end the following new
16 section:

17 “GAO REPORTS TO BUDGET COMMITTEES

18 “SEC. 408. On or before January 15 of each year,
19 the Comptroller General, after consultation with appro-
20 priate committees of the House of Representatives and
21 Senate, shall submit to the Congress a report listing all
22 programs, projects, and activities that fall within the defi-
23 nition of direct spending under section 250(c)(8) of the
24 Balanced Budget and Emergency Deficit Control Act of
25 1985.”.

1 (2) CONFORMING AMENDMENT.—The table of con-
2 tents set forth in section 1(b) of the Congressional Budget
3 and Impoundment Control Act of 1974 is amended by in-
4 serting after the item relating to section 407 the following
5 new item:

“Sec. 408. GAO reports to budget committees.”.
