A BILL

- 3 **SECTION 1. SHORT TITLE.**
- 4 This Act may be cited as the "Maritime Regulatory
- 5 Reform Act of 1994".

- 3 (a) Chapter 21 of title 46, United States Code, is
- 4 amended by adding a new section 2103a to read as fol-
