3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Farm, Ranch, and 5 Homestead Protection Act of 1994".

than the Federal Government, on request of the person or entity, the Secretary shall compensate the
person or entity for any loss in market value of the
land that results from the designation.".

6 The first sentence of section 7(a)(2) of the Endan-7 gered Species Act of 1973 (16 U.S.C. 1536(a)(2)) is 8 amended by inserting after "by such agency" the follow-9 ing: "that results in the expenditure of \$500,000 or 10 more".
