AN ACT

For the relief of Melissa Johnson.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PAYMENT FOR THE BENEFIT OF CLAIMANT.
- 4 The Secretary of the Treasury shall pay, out of any
- 5 money in the Treasury not otherwise appropriated,
- 6 \$125,000 to Melissa Johnson of Barryville, New York.
- 7 Such sum shall be in full and complete settlement of all
- 8 claims against the United States arising out of the per-
- 9 sonal injuries and mental pain and suffering incurred as
- 10 a result of the sexual assault and molestation of Melissa

- 1 Johnson by an employee of the United States Postal Serv-
- 2 ice on June 3, 1982, and various other dates.

3 SEC. 2. DEPOSIT OF AMOUNT IN TRUST ACCOUNTS.

- 4 Barbara Johnson Lizzi of Barryville, New York, the
- 5 mother of Melissa Johnson, shall deposit the sum paid
- 6 under section 1 in a federally insured depository institu-
- 7 tion in an interest bearing account or accounts in trust
- 8 for Melissa Johnson. Barbara Johnson Lizzi shall serve
- 9 as sole trustee of such account or accounts and, as such
- 10 trustee—
- 11 (1) shall pay those debts and obligations which
- are outstanding at the time the sum is paid under
- section 1 to the extent those debts and obligations
- arise from the injuries and pain and suffering de-
- scribed in section 1;
- 16 (2) shall, until Melissa Johnson reaches the age
- of majority under the laws of the State in which Me-
- lissa Johnson is residing at the time, pay, from the
- amounts in the trust account or accounts, expenses
- 20 incurred for Melissa Johnson's medical care and
- 21 education; and
- 22 (3) shall, when Melissa Johnson reaches the age
- of majority under the laws of the State in which Me-
- lissa Johnson is residing at the time, pay to Melissa

- Johnson all amounts remaining in the trust account
- 2 or accounts.

3 SEC. 3. LIMITATION ON ATTORNEYS' FEES.

- 4 Not more than 10 percent of the amount appro-
- 5 priated by section 1 may be paid or delivered to or received
- 6 by any agent or attorney on account of services rendered
- 7 in connection with the claim described in section 1, not-
- 8 withstanding any contract which provides otherwise. Any
- 9 person who violates the provisions of this section shall be
- 10 guilty of an infraction and shall be subject to a fine in
- 11 the amount provided in title 18, United States Code.
