To authorize the Secretary of Transportation to convey vessels in the National Defense Reserve Fleet to certain nonprofit organizations.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Merchant Marine Me-
- 5 morial Enhancement Act of 1993".

1 SEC. 2. CONVEYANCE VESSELS.

2	(a) AUTHORITY TO CONVEY.—The Secretary of
3	Transportation may convey without consideration all
4	right, title, and interest of the United States in 2 vessels
5	described in subsection (b) to any nonprofit organization
6	which operates and maintains a Liberty Ship or Victory
7	Ship as a memorial to merchant mariners.
8	(b) VESSELS DESCRIBED.—Vessels which may be
9	conveyed under subsection (a) are vessels which—
10	(1) are in the National Defense Reserve Fleet
11	on the date of the enactment of this Act;
12	(2) are not less than 4,000 displacement tons;
13	(3) have no usefulness to the Government; and
14	(4) are scheduled to be scrapped.
15	(c) Conditions of Conveyance.—As a condition of
16	conveying any vessel to an organization under subsection
17	(a), the Secretary shall require that before the date of the
18	conveyance the organization enter into an agreement
19	under which the organization shall—
20	(1) sell the vessel for scrap purposes;
21	(2) use the proceeds of that scrapping for the
22	purpose of refurbishing and making seaworthy a
23	Liberty Ship or Victory Ship which the organization

24	maintains as a memorial to merchant mariners, to

- 3 (3) return to the United States any proceeds of
- 4 scrapping carried out pursuant to paragraph (1)
- 5 which are not used in accordance with paragraph
- 6 (2).
- 7 (d) Deposit of Amounts Returned.—Amounts
- 8 returned to the United States pursuant to subsection
- 9 (c)(3) shall be deposited in the Vessel Operations Revolv-
- 10 ing Fund created by the Act of June 2, 1951 (65 Stat.
- 11 59; 46 App. U.S.C. 1241a).
- 12 (e) Delivery of Vessels.—The Secretary shall de-
- 13 liver each vessel conveyed under this section—
- 14 (1) at the place where the vessel is located on
- the date of the approval of the conveyance by the
- 16 Secretary;
- 17 (2) in its condition on that date; and
- 18 (3) without cost to the Government.
- 19 (f) Expiration of Authority to Convey.—The
- 20 authority of the Secretary under this section to convey ves-
- 21 sels shall expire on the date that is 2 years after the date
- 22 of the enactment of this Act.
- 23 SEC. 3. DOCUMENTATION OF VESSELS.
- 24 (a) Notwithstanding section 27 of the Merchant Ma-

- tional vessel of equal or greater capacity within 12
- months of the date of enactment of this Act, for de-

- which vessel shall also be documented under chapter
- 19 121 of title 46, United States Code.
- 20 (e) Notwithstanding sections 12106 and 12108 of
- 21 title 46, United States Code, the Act of June 19, 1886
- 22 (46 App. U.S.C. 289), and section 27 of the Merchant
- 23 Marine Act, 1920 (46 App. U.S.C. 883), the Secretary
- 24 of Transportation may issue a certificate of documentation
- 25 with a coastwise and fishery endorsement for the vessel

- 3 (f) Notwithstanding section 12108 of title 46, United
- 4 States Code, the Secretary of Transportation may issue

- 8 (g) Notwithstanding any other law or any agreement
- 9 with the United States Government, the vessels UST AT-
- 10 LANTIC (United States official number 601437) and

- 12 may be sold to a person that is not a citizen of the United
- 13 States and transferred to or placed under a foreign reg-
- 14 istry.
- 15 (h) Notwithstanding any other law, the vessel AMY
- 16 CHOUEST (United States official number 995631) is
- 17 deemed to be less than 500 gross tons, as measured under
- 18 chapter 145 of title 46, United States Code, for purposes
- 19 of the maritime laws of the United States.
- 20 SEC. 4. NAUTICAL CHARTING AND MARINE SAFETY IM-
- 21 **PROVEMENTS.**
- No later than 180 days after the date of enactment
- 23 of this Act, the Secretary of Commerce may deploy a
- 24 Physical Ocean Real-Time System consisting, at a mini-
- 25 mum, of current, wind, tide, salinity, and water level

- 1 measuring devices and necessary computer links, in Gal-
- 2 veston Bay and the Houston Ship Channel.
- 3 SEC. 5. PILOT PROGRAM ON SEALIFT TRAINING.
- 4 The Secretary of Transportation shall establish a 3-
- 5 year pilot program for Sealift Training at the Massachu-
- 6 setts Maritime Academy.
