## RESOLUTION

Providing for consideration of the bill (H.R. 2667) making emergency supplemental appropriations for relief from the major, widespread flooding in the Midwest for the fiscal year ending September 30, 1993, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 2667) making emergency supple-

1 mental appropriations for relief from the major, wide-  
2 spread flooding in the Midwest for the fiscal year ending  
3 September 30, 1993, and for other purposes. The first  
4 reading of the bill shall be dispensed with. All points of  
5 order against consideration of the bill are waived. General  
6 debate shall be confined to the bill and shall not exceed  
7 one hour equally divided and controlled by the chairman  
8 and ranking minority member of the Committee on Appro-  
9 priations. After general debate the bill shall be considered  
10 for amendment under the five-minute rule. The modifica-  
11 tion to the bill printed in part 1 of the report of the Com-  
12 mittee on Rules accompanying this resolution shall be con-  
13 sidered as adopted in the House and in the Committee  
14 of the Whole. The bill, as modified, shall be considered  
15 as read. All points of order against the bill, as modified,  
16 are waived. No amendment to the bill, as modified, shall  
17 be in order except the amendment printed in part 2 of  
18 the report. The amendment printed in part 2 of the report  
19 may be offered only by the named proponent or a designee,  
20 shall be considered as read, shall be debatable for the time  
21 specified in the report equally divided and controlled by  
22 the proponent and an opponent, and shall not be subject  
23 to amendment. At the conclusion of consideration of the  
24 bill for amendment the Committee shall rise and report  
25 the bill, as modified, to the House with such amendment

1 as may have been adopted. The previous question shall  
2 be considered as ordered on the bill and amendment there-  
3 to to final passage without intervening motion except one  
4 motion to recommit.
