Mr. HALL of Ohio, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4426) making appropriations for foreign operations, export financing, and related programs for the fiscal year ending September 30, 1995.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4426) making appropriations for

1 foreign operations, export financing, and related programs
2 for the fiscal year ending September 30, 1995. All points
3 of order against the bill and against its consideration are
4 waived. General debate shall be confined to the bill and
5 the amendment in the nature of a substitute recommended
6 by the Committee on Appropriations and shall not exceed
7 one hour equally divided and controlled by the chairman
8 and ranking minority member of the Committee on Appro-
9 priations. After general debate the pending question shall
10 be the adoption of the amendment in the nature of a sub-
11 stitute recommended by the Committee on Appropriations
12 now printed in the bill. The committee amendment in the
13 nature of a substitute shall be designated and shall be de-
14 batable for ten minutes equally divided and controlled by
15 the chairman and ranking minority member of the Com-
16 mittee on Appropriations. All points of order against the
17 committee amendment in the nature of a substitute, and
18 against provisions in the bill if so amended, are waived.
19 If the committee amendment in the nature of a substitute
20 is adopted, then the bill as so amended shall be considered
21 as the original bill for the purpose of further amendment
22 under the five-minute rule and shall be considered as read.
23 No further amendment shall be in order except those
24 printed in the report of the Committee on Rules accom-
25 panying this resolution. Each amendment may be offered

1 only in the order printed in the report, may be offered
2 only by a Member designated in the report, shall be con-
3 sidered as read, shall be debatable for the time specified
4 in the report equally divided and controlled by the pro-
5 ponent and an opponent, shall not be subject to amend-
6 ment except as specified in the report, and shall not be
7 subject to a demand for division of the question in the
8 House or in the Committee of the Whole. All points of
9 order against amendments printed in the report are
10 waived. The chairman of the Committee of the Whole may
11 postpone until a time during further consideration in the
12 Committee of the Whole a request for a recorded vote on
13 any amendment made in order by this resolution. The
14 chairman of the Committee of the Whole may reduce to
15 not less than five minutes the time for voting by electronic
16 device on any postponed question that immediately follows
17 another vote by electronic device without intervening busi-
18 ness, provided that the time for voting by electronic device
19 on the first in any series of questions shall be not less
20 than fifteen minutes. At the conclusion of consideration
21 of the bill for amendment the Committee shall rise and
22 report the bill to the House with such amendments as may
23 have been adopted. Any Member may demand a separate
24 vote in the House on any amendment adopted in the Com-
25 mittee of the Whole to the bill or to the committee amend-

1 ment in the nature of a substitute. The previous question
2 shall be considered as ordered on the bill and amendments
3 thereto to final passage without intervening motion except
4 one motion to recommit with or without instructions.
