AN ACT

To amend title 38, United States Code, to provide for the organization and administration of the Readjustment Counseling Service, to improve eligibility for readjustment counseling and related counseling, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Readjustment Counsel-
- 5 ing Service Amendments of 1994".
- 6 SEC. 2. ORGANIZATION OF THE READJUSTMENT COUNSEL-
- 7 ING SERVICE IN THE DEPARTMENT OF VET-
- 8 ERANS AFFAIRS.
- 9 (a) IN GENERAL.—Section 7305 of title 38, United
- 10 States Code, is amended—

1	(1) by redesignating paragraph (7) as para-
2	graph (8); and
3	(2) by inserting after paragraph (6) the follow-
4	ing new paragraph (7):
5	"(7) A Readjustment Counseling Service.".
6	(b) Organization.—The Readjustment Counseling
7	Service shall have the organizational structure and admin-
8	istrative structure of that service as such structures were
9	in existence on January 1, 1993.
10	(c) REVISION OF ORGANIZATIONAL STRUCTURE.—
11	(1) The Secretary of Veterans Affairs may not alter or
12	revise the organizational structure or the administrative
13	structure of the Readjustment Counseling Service until—
14	(A) the Secretary has submitted to the Commit-
15	tees on Veterans' Affairs of the Senate and House
16	of Representatives a report containing a full and
17	complete statement of the proposed alteration or re-
18	vision; and
19	(B) a period of 60 days has elapsed after the
20	date on which the report is received by the commit-
21	tees.
22	(2) In the computation of the 60-day period under
22	
23	paragraph $(1)(B)$, there shall be excluded any day on

1	of an adjournment of more than 3 calendar days to a day
2	certain.
3	(d) Budget Information Relating to the Serv-
4	ICE.—Each budget submitted to Congress by the Presi-
5	dent under section 1105 of title 31, United States Code,
6	shall set forth the amount requested in the budget for the
7	operation of the Readjustment Counseling Service in the
8	fiscal year covered by the budget and shall set forth sepa-
9	rately the amount requested for administrative oversight
10	of the activities of the service (including the amount re-
11	quested for funding of the Advisory Committee on Read-
12	justment of Veterans).

- 18 (c) Organizational Requirement.—The Director
- 19 of the Readjustment Counseling Service shall report to the
- 20 Under Secretary for Health of the Department of Veter-
- 21 ans Affairs through the Associate Deputy Under Secretary
- 22 for Health for Clinical Programs.

1	SEC. 4. EXPANSION OF ELIGIBILITY FOR READJUSTMENT
2	COUNSELING AND CERTAIN RELATED COUN-
3	SELING SERVICES.
4	(a) Readjustment Counseling.—(1) Subsection
5	(a) of section 1712A of title 38, United States Code, is
6	amended to read as follows:
7	"(a)(1)(A) Upon the request of any veteran referred
8	to in subparagraph (B) of this paragraph, the Secretary
9	shall furnish counseling to the veteran to assist the vet-
10	eran in readjusting to civilian life.
11	"(B) A veteran referred to in subparagraph (A) of
12	this paragraph is any veteran who—
13	"(i) served on active duty during the Vietnam
14	era; or
15	"(ii) served on active military, naval, or air
16	service in a theater of combat operations (as deter-
17	mined by the Secretary, in consultation with the
18	Secretary of Defense) during a period of war or in
19	any other area during a period in which hostilities
20	(as defined in subparagraph (D) of this paragraph)
21	occurred in such area.
22	"(C) Upon the request of any veteran other than a
23	veteran referred to in subparagraph (A) of this paragraph,
24	the Secretary may furnish counseling to the veteran to as-
25	sist the veteran in readjusting to civilian life.

- 1 "(D) For the purposes of subparagraph (A) of this
- 2 paragraph, the term 'hostilities' means an armed conflict
- 3 in which the members of the Armed Forces are subjected
- 4 to danger comparable to the danger to which members of
- 5 the Armed Forces have been subjected in combat with
- 6 enemy armed forces during a period of war, as determined
- 7 by the Secretary in consultation with the Secretary of De-
- 8 fense.
- 9 "(2) The counseling referred to in paragraph (1)
- 10 shall include a general mental and psychological assess-
- 11 ment of a covered veteran to ascertain whether such vet-
- 12 eran has mental or psychological problems associated with
- 13 readjustment to civilian life.".
- 14 (2) Subsection (c) of such section is repealed.
- 15 (b) Other Counseling.—Such section is further
- 16 amended by inserting after subsection (b) the following
- 17 new subsection (c):
- 18 ''(c)(1) The Secretary shall provide the counseling
- 19 services described in section 1701(6)(B)(ii) of this title to
- 20 the surviving parents, spouse, and children of any member
- 21 of the Armed Forces who is killed during service on active
- 22 military, naval, or air service in a theater of combat oper-
- 23 ations (as determined by the Secretary, in consultation
- 24 with the Secretary of Defense) during a period of war or
- 25 in any other area during a period in which hostilities (as

- 1 defined in subsection (a)(1)(D) of this section) occurred
- 2 in such area.
- 3 "(2) The Secretary may provide the counseling serv-
- 4 ices referred to in paragraph (1) to the surviving parents,
- 5 spouse, and children of any member of the Armed Forces
- 6 who dies while serving on active duty or from a condition
- 7 (as determined by the Secretary) incurred in or aggra-
- 8 vated by such service.
- 9 "(3) The Secretary may provide to the parents,
- 10 spouse, and children of any member of the Armed Forces
- 11 who (as determined by the Secretary) is a prisoner of war,
- 12 or is missing in action, such counseling as the Secretary
- 13 determines appropriate to assist such persons with the
- 14 mental or psychological problems associated with the sta-
- 15 tus of such member as a prisoner of war or as missing
- 16 in action, as the case may be.".
- 17 (c) AUTHORITY TO CONTRACT FOR COUNSELING
- 18 Services.—Subsection (e) of such section is amended by
- 19 striking out "subsections (a) and (b)" each place it ap-
- 20 pears and inserting in lieu thereof "subsections (a), (b),
- 21 and (c)".

1	SEC. 5. ADVISORY COMMITTEE ON THE READJUSTMENT OF
2	VETERANS.
3	(a) IN GENERAL.—(1) Subchapter II of chapter 17
4	of title 38, United States Code, is amended by inserting
5	after section 1712B the following:
6	"§1712C. Advisory Committee on the Readjustment
7	of Veterans
8	"(a)(1) There is in the Department the Advisory
9	Committee on the Readjustment of Veterans (hereafter in
10	this section referred to as the 'Committee').
11	"(2) The Committee shall consist of not more than
12	18 members appointed by the Secretary from among vet-
13	erans who—
14	"(A) have demonstrated significant civic or pro-
15	fessional achievement; and
16	"(B) have experience with the provision of vet-
17	erans benefits and services by the Department.
18	"(3) The Secretary shall seek to ensure that members
19	appointed to the Committee include persons from a wide
20	variety of geographic areas and ethnic backgrounds, per-
21	sons from veterans service organizations, and women.
22	"(4) The Secretary shall determine the terms of serv-
23	ice and pay and allowances of the members of the Commit-
24	tee, except that a term of service may not exceed 2 years.
25	The Secretary may reappoint any member for additional
26	terms of service.

- 1 "(b)(1) The Secretary shall, on a regular basis, con-
- 2 sult with and seek the advice of the Committee with re-
- 3 spect to the provision by the Department of benefits and
- 4 services to veterans in order to assist veterans in the read-
- 5 justment to civilian life.
- 6 "(2)(A) In providing advice to the Secretary under
- 7 this subsection, the Committee shall—
- 8 "(i) assemble and review information relating to
- 9 the needs of veterans in readjusting to civilian life;
- 10 "(ii) provide information relating to the nature
- and character of psychological problems arising from
- service in the Armed Forces;
- "(iii) provide an on-going assessment of the ef-
- fectiveness of the policies, organizational structures,
- and services of the Department in assisting veterans
- in readjusting to civilian life; and
- 17 "(iv) provide on-going advice on the most ap-
- propriate means of responding to the readjustment
- 19 needs of veterans in the future.
- 20 "(B) In carrying out its duties under subparagraph
- 21 (A), the Committee shall take into special account veter-
- 22 ans of the Vietnam era, and the readjustment needs of
- 23 such veterans.
- "(c)(1) Not later than March 31 of each year, the
- 25 Committee shall submit to the Secretary a report on the

- 1 programs and activities of the Department that relate to
- 2 the readjustment of veterans to civilian life. Each such
- 3 report shall include—
- 4 "(A) an assessment of the needs of veterans
- 5 with respect to readjustment to civilian life;
- 6 "(B) a review of the programs and activities of
- 7 the Department designed to meet such needs; and
- 8 "(C) such recommendations (including rec-
- 9 ommendations for administrative and legislative ac-
- 10 tion) as the Committee considers appropriate.
- 11 "(2) Not later than 90 days after the receipt of each
- 12 report under paragraph (1), the Secretary shall transmit
- 13 to the Committees on Veterans' Affairs of the Senate and
- 14 House of Representatives a copy of the report, together
- 15 with any comments and recommendations concerning the
- 16 report that the Secretary considers appropriate.
- 17 "(3) The Committee may also submit to the Sec-
- 18 retary such other reports and recommendations as the
- 19 Committee considers appropriate.
- 20 "(4) The Secretary shall submit with each annual re-
- 21 port submitted to the Congress pursuant to section 529
- 22 of this title a summary of all reports and recommendations
- 23 of the Committee submitted to the Secretary since the pre-
- 24 vious annual report of the Secretary submitted pursuant
- 25 to that section.

- 1 "(d)(1) Except as provided in paragraph (2), the pro-
- 2 visions of the Federal Advisory Committee Act (5 U.S.C.
- 3 App.) shall apply to the activities of the Committee under
- 4 this section.
- 5 "(2) Section 14 of such Act shall not apply to the
- 6 Committee.".
- 7 (2) The table of sections at the beginning of chapter
- 8 17 of such title is amended by inserting after the item
- 9 relating to section 1712B the following:
 - "1712C. Advisory Committee on the Readjustment of Veterans.".
- 10 (b) Original Members.—(1) Notwithstanding sub-
- 11 section (a)(2) of section 1712C of such title (as added by
- 12 subsection (a)), the members of the Advisory Committee
- 13 on the Readjustment of Vietnam and Other War Veterans
- 14 on the date of the enactment of this Act shall be the origi-
- 15 nal members of the advisory committee recognized under
- 16 such section.
- 17 (2) The original members shall so serve until the Sec-
- 18 retary of Veterans Affairs carries out appointments under
- 19 such subsection (a)(2). The Secretary shall carry out such
- 20 appointments as soon after such date as is practicable.
- 21 The Secretary may make such appointments from among
- 22 such original members.

1	SEC. 6. PLAN FOR EXPANSION OF VIETNAM VETERAN RE-
2	SOURCE CENTER PILOT PROGRAM.
3	(a) REQUIREMENT.—(1) The Secretary of Veterans
4	Affairs shall submit to the Committees on Veterans' Af-
5	fairs of the Senate and House of Representatives a plan
6	for the expansion of the Vietnam Veteran Resource Center
7	program established pursuant to the amendment made by
8	section 105 of the Veterans' Administration Health-Care
9	Amendments of 1985 (Public Law 99–166; 99 Stat. 944).
10	The plan shall include a schedule for, and an assessment
11	of the cost of, the implementation of the program at or
12	through all Department of Veterans Affairs readjustment
13	counseling centers.
14	(2) The Secretary shall submit the plan not later
15	than 4 months after the date of the enactment of this Act.
16	(b) Definition.—In this section, the term "Depart-
17	ment of Veterans Affairs readjustment counseling cen-
18	ters" has the same meaning given the term "center" in
19	section 1712A(i)(1) of title 38, United States Code.
20	SEC. 7. REPORT ON COLLOCATION OF VET CENTERS AND
21	DEPARTMENT OF VETERANS AFFAIRS OUT-
22	PATIENT CLINICS.
23	(a) REQUIREMENT.—(1) The Secretary of Veterans
24	Affairs shall submit to the Committees on Veterans' Af-
25	fairs of the Senate and House of Representatives a report
26	on the feasibility and desirability of the collocation of Vet

- Centers and outpatient clinics (including rural mobile clinics) of the Department of Veterans Affairs as current leases for such centers and clinics expire. 4 (2) The Secretary shall submit the report not later than 6 months after the date of the enactment of this Act.
- (b) COVERED MATTERS.—The report under this sec-6 tion shall include an assessment of the following:
 - (1) The results of any collocation of Vet Centers and outpatient clinics carried out by the Secretary before the date of the enactment of this Act, including the effects of such collocation on the quality of care provided at such centers and clinics.
 - (2) The effect of such collocation on the capacity of such centers to carry out their primary mission.
 - (3) The extent to which such collocation will impair the operational independence or administrative integrity of such centers.
 - (4) The feasibility of combining the services provided by such centers and clinics in the course of the collocation of such centers and clinics.
 - (5) The advisability of the collocation of centers and clinics of significantly different size.

- 1 (6) The effect of the locations (including urban 2 and rural locations) of the centers and clinics on the 3 feasibility and desirability of such collocation. 4 (7) The amount of any costs sayings to be
 - (7) The amount of any costs savings to be achieved by Department as a result of such collocation.
 - (8) The desirability of such collocation in light of plans for the provision of health care services by the Department under national health care reform.
- 10 (9) Any other matters that the Secretary deter-11 mines appropriate.

12 SEC. 8. VET CENTER HEALTH CARE PILOT PROGRAM.

- 13 (a) IN GENERAL.—The Secretary of Veterans Affairs
- 14 shall carry out a pilot program for the provision of health-
- 15 related services to eligible veterans at readjustment coun-
- 16 seling centers. The Secretary shall carry out the pilot pro-
- 17 gram in accordance with this section.
- 18 (b) Services.—(1) In carrying out the pilot pro-
- 19 gram, the Secretary shall provide the services referred to
- 20 in paragraph (2) at not less than 10 readjustment counsel-
- 21 ing centers in existence on the date of the enactment of
- 22 this Act.

- 23 (2) The Secretary shall provide basic ambulatory
- 24 services and health care screening services by such person-
- 25 nel as the Secretary considers appropriate at each read-

- 1 justment counseling center under the pilot program. The
- 2 Secretary shall assign not less than one-half of a full-time
- 3 employee equivalent at each such center in order to pro-
- 4 vide such services under the pilot program.
- 5 (3) In determining the location of the readjustment
- 6 counseling centers at which to provide services under the
- 7 pilot program, the Secretary shall select centers that are
- 8 located in a variety of geographic areas and that serve vet-
- 9 erans of a variety of economic, social, and ethnic back-
- 10 grounds.
- 11 (c) Period of Operation.—(1) The Secretary shall
- 12 commence the provision of health-related services at read-
- 13 justment counseling centers under the pilot program not
- 14 later than 4 months after the date of the enactment of
- 15 this Act.
- 16 (2) The pilot program shall terminate 2 years after
- 17 the date on which the Secretary commences the provision
- 18 of services under paragraph (1).
- 19 (d) Report.—(1) The Secretary shall submit to Con-
- 20 gress a report on the pilot program established under this
- 21 section. The report shall include the following:
- (A) A description of the program, including in-
- formation on—

1	(i) the number of veterans provided basic
2	ambulatory services and health care screening
3	services under the pilot program;
4	(ii) the number of such veterans referred
5	to Department of Veterans Affairs general
6	health-care facilities in order to provide such
7	services to such veterans; and
8	(iii) the cost to the Department of Veter-
9	ans Affairs of the pilot program.
10	(B) An analysis of the effectiveness of the serv-
11	ices provided to veterans under the pilot program.
12	(C) The recommendations of the Secretary for
13	means of improving the pilot program, and an esti-
14	mate of the cost to the Department of implementing
15	such recommendations.
16	(D) An assessment of the desirability of ex-
17	panding the type or nature of services provided
18	under the pilot program in light of plans for the pro-
19	vision of health care services by the Department
20	under national health care reform.
21	(E) An assessment of the extent to which the
22	provision of services under the pilot program impairs
23	the operational or administrative independence of
24	the readjustment counseling centers at which such

services are provided.

1	(F) An assessment of the effect of the location
2	of the centers on the effectiveness for the Depart-
3	ment and for veterans of the services provided under
4	the pilot program.
5	(G) Such other information as the Secretary
6	considers appropriate.
7	(2) The Secretary shall submit the report not later
8	than 18 months after the date of the enactment of this
9	Act.
10	(e) Definitions.—For the purposes of this section
11	(1) The term "Department of Veterans Affairs
12	general health-care facility" has the meaning given
13	such term in section 1712A(i)(2) of title 38, United
14	States Code.
15	(2) The term "eligible veteran" means any vet-
16	eran eligible for outpatient services under paragraph
17	(1), (2), or (3) of section 1712(a) of such title.
18	(3) The term "readjustment counseling center"
19	has the same meaning given the term "center" in
20	section 1712A(i)(1) of such title.
