1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Piscataway National
5 Park Expansion Act of 1993”.

1 **SEC. 2. ACQUISITION OF LAND.**

2 (a) ~~IN GENERAL.~~—Subject to subsection (b), the Sec-
3 retary of the Interior is authorized to acquire land or in-
4 terests in land generally depicted on the drawing entitled
5 “Proposed Boundary Map—Piscataway Park”, numbered
6 838–80137, and dated November 17, 1993.

7 (b) ~~MEANS OF ACQUISITION.~~—The Secretary may ac-
8 quire the land or interests in land described in subsection
9 (a) by purchase, donation, exchange, or otherwise.

10 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

11 There is authorized to be appropriated such sums as
12 are necessary to carry out this Act.

13 **SECTION 1. SHORT TITLE.**

14 *This Act may be cited as the “Piscataway National*
15 *Park Expansion Act of 1994”.*

16 **SEC. 2. EXPANSION OF PARK.**

17 (a) *The boundaries of Piscataway Park in Maryland*
18 *are hereby revised to reflect the addition of approximately*
19 *163 acres of lands as generally depicted on the map entitled*
20 *“Proposed Boundary Map—Piscataway Park”, numbered*
21 *838–80137, and dated November 17, 1993.*

22 (b) *The Secretary of the Interior is authorized to ac-*
23 *quire lands and interests therein within the areas added*
24 *to the park pursuant to subsection (a) by donation, pur-*
25 *chase with donated or appropriated funds, or exchange.*

1 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

2 *There is authorized to be appropriated such sums as*

3 *are necessary to carry out this Act.*
