A BILL

To authorize the President to award a gold medal on behalf of the Congress to Richard “Red” Skelton, and to provide for the production of bronze duplicates of such medal for sale to the public.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 The Congress finds that—

5 (1) Richard “Red” Skelton has provided gen-
6 erations with the gift of laughter, driven by his pas-
7 sion to instill happiness in the hearts of others;

8 (2) Red Skelton, a true patriot, supported the
9 United States Armed Forces during World War II
10 by selling a record number of United States war
11 bonds, serving as a private in the United States
12 Army, and working arduously to lift the morale of
13 his fellow soldiers; and

14 (3) Red Skelton, who worked his way from pov-
15 erty to success, has shared his talent and his wealth
16 with numerous charities, in an effort to help those
17 less fortunate than himself.

18 **SEC. 2. CONGRESSIONAL GOLD MEDAL.**

19 (a) **PRESENTATION AUTHORIZED.**—The President is
20 authorized to present, on behalf of the Congress, to Red
21 Skelton a gold medal of appropriate design in recognition
22 of his exemplary performance as an entertainer and a hu-
23 manitarian.

24 (b) **DESIGN AND STRIKING.**—For purposes of the
25 presentation referred to in subsection (a), the Secretary

1 of the Treasury (hereafter referred to in this Act as the
2 “Secretary”) shall strike a gold medal with suitable em-
3 bloms, devices, and inscriptions to be determined by the
4 Secretary.

5 **SEC. 3. DUPLICATE MEDALS.**

6 The Secretary may strike bronze duplicates of the
7 gold medal struck pursuant to section 2, under such regu-
8 lations as the Secretary may prescribe, and may sell such
9 bronze duplicates at a price sufficient to cover the cost
10 thereof, including labor, materials, dies, use of machinery,
11 and overhead expenses, and the cost of the gold medal.

12 **SEC. 4. NATIONAL MEDALS.**

13 Medals struck pursuant to this Act are national med-
14 als for purposes of chapter 51 of title 31, United States
15 Code.

16 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS; PROCEEDS**
17 **OF SALE.**

18 (a) AUTHORIZATION OF APPROPRIATIONS.—There is
19 authorized to be appropriated not to exceed \$30,000 to
20 carry out section 2.

21 (b) PROCEEDS OF SALES.—Amounts received from
22 sales of duplicate bronze medals under section 3 shall be
23 credited to the appropriation made pursuant to the au-
24 thorization provided in subsection (a).

16 **SEC. 2. CONGRESSIONAL GOLD MEDAL.**

17 (a) *PRESENTATION AUTHORIZED.—The President is*
18 *authorized to present, on behalf of the Congress, a gold*
19 *medal of appropriate design to Richard “Red” Skelton in*
20 *recognition of his exemplary performance as an entertainer*
21 *and a humanitarian.*

22 (b) *DESIGN AND STRIKING.—For the purposes of the*
23 *presentation referred to in subsection (a), the Secretary of*
24 *the Treasury (hereafter in this Act referred to as the “Sec-*
25 *retary”)* shall strike a gold medal with suitable emblems,
26 *devices, and inscriptions to be determined by the Secretary.*

1 **SEC. 3. DUPLICATE MEDALS.**

2 *The Secretary may strike and sell duplicates in bronze*
3 *of the gold medal struck pursuant to section 2 under such*
4 *regulations as the Secretary may prescribe, and at a price*
5 *sufficient to cover the costs thereof, including labor, mate-*
6 *rials, dies, use of machinery, overhead expenses, and the cost*
7 *of the gold medal.*

8 **SEC. 4. NATIONAL MEDALS.**

9 *The medals struck pursuant to this Act are national*
10 *medals for purposes of chapter 51 of title 31, United States*
11 *Code.*

12 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS; PROCEEDS**
13 **OF SALE.**

14 (a) *AUTHORIZATION OF APPROPRIATIONS.—There is*
15 *hereby authorized to be charged against the Numismatic*
16 *Public Enterprise Fund an amount not to exceed \$30,000*
17 *to pay for the cost of the medal.*

18 (b) *PROCEEDS OF SALE.—Amounts received from the*
19 *sales of duplicate bronze medals under section 3 shall be*
20 *deposited in the Numismatic Public Enterprise Fund.*
