- 1 Be it enacted by the Senate and House of Representa-

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "National Security
- 5 Budgeting and Deficit Control Act of 1994".

1 SEC. 2. EXTENSION OF SPENDING LIMITS.

2 (a) CATEGORY.—Subparagraph (B) of section
3 250(c)(4) of the Balanced Budget and Emergency Deficit
4 Control Act of 1985 is amended to read as follows:

"(B) For fiscal years 1994 through 1997, 5 6 any of the following subsets of discretionary ap-7 propriations: defense or nondefense. For fiscal 8 year 1998, all discretionary appropriations. 9 New accounts or activities shall be categorized 10 in consultation with the Committees on Appro-11 priations and the Budget of the House of Rep-12 resentatives and the Senate.".

"(b) DISCRETIONARY SPENDING.—Section 601(a)(2)
of the Congressional Budget Act of 1974 is amended by
striking subparagraphs (D), (E), and (F) and inserting
the following:
