A BILL

To provide for daylight saving time on an expanded basis, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Daylight Saving Time
- 5 Extension Act of 1994".
- 6 SEC. 2. DAYLIGHT SAVING EXTENDED TO START IN MARCH
- 7 AND END IN NOVEMBER.
- 8 Section 3(a) of the Uniform Time Act of 1966 (15
- 9 U.S.C. 260a(a)) is amended—

1	(1) by striking out "first Sunday of April" and
2	inserting in lieu thereof "third Sunday of March";
3	and
4	(2) by striking out "last Sunday of October"
5	and inserting in lieu thereof "first Sunday of
6	November''.
7	SEC. 3. EFFECT ON EXISTING STATE ELECTIONS.
8	Any law in effect on the date of the enactment of
9	this Act—
10	(1) adopted pursuant to section 3(a)(2) of the
11	Uniform Time Act of 1966 by a State with parts
12	thereof in more than one time zone, or
13	(2) adopted pursuant to section 3(a)(1) of such
14	Act by a State that lies entirely within one time
15	zone,
16	shall be held and considered to remain in effect as the
17	exercise by that State of the exemption permitted by such
18	Act unless that State, by law, provides that such exemp-
19	tion shall not apply.
20	SEC. 4. ADJUSTMENT OF OPERATING HOURS OF DAYTIME
21	BROADCASTERS.
22	(a) Notwithstanding any other law or any regulation
23	issued under any such law, the Federal Communications
24	Commission shall, consistent with any existing treaty or
25	other agreement, make such adjustment by general rules,

- 1 or by interim action pending such general rules, with re-
- 2 spect to hours of operation of daytime standard amplitude
- 3 modulation broadcast stations, as may be consistent with
- 4 the public interest, including the public's interest in receiv-
- 5 ing interference-free service.
- 6 (b) Such general rules, or interim action, may include
- 7 variances with respect to operating power and other tech-
- 8 nical operating characteristics.
- 9 (c) At any time subsequent to the adoption of such
- 10 general rules, such general rules may be varied with re-
- 11 spect to particular stations and areas because of the ex-
- 12 igencies in each case.
- 13 SEC. 5. EFFECTIVE DATE.
- 14 This Act shall take effect 60 days after the date of
- 15 the enactment of this Act, except that if such effective
- 16 date occurs in any calendar year after March 1, this Act
- 17 shall take effect on the first day of the following year.
