A BILL

To authorize the Secretary of Transportation to issue temporary certificates of documentation with appropriate endorsement for employment in the coastwise trade for the vessels IDUN VIKING, LIV VIKING, and FREJA VIKING.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. COASTWISE TRADE AUTHORIZATION.**

2 (a) IN GENERAL.—Notwithstanding section 27 of the
3 Merchant Marine Act, 1920 (46 App. U.S.C. 883) or any
4 other provision of law restricting the operation of foreign-
5 flag vessels in the coastwise trade of the United States,
6 as applicable on the date of enactment of this Act, the
7 foreign-flag vessels IDUN VIKING, LIV VIKING, and
8 FREJA VIKING may, during the period described in sub-
9 section (b), engage in the transportation by water of pas-
10 sengers in the coastwise trade of the United States, if—

11 (1) a binding contract for the construction or
12 rebuilding, in the United States, of coastwise-quali-
13 fied replacement vessels is executed within 9 months
14 after the date of enactment of this Act;

15 (2) all ship repair work on the vessels necessary
16 to their operation under this section is performed in
17 the United States; and

18 (3) all officers and crew members employed on
19 board the vessels during their operation under this
20 section are United States citizens.

21 (b) PERIOD OF AUTHORIZATION.—The period of
22 transportation authorized under subsection (a) for each
23 vessel begins on the date of enactment of this Act and
24 ends on the earlier of—

25 (1) the date that is 4 years after such date of
26 enactment; or

1 (2) the date of delivery of a coastwise-qualified
2 replacement vessel constructed in or rebuilt in the
3 United States.
