A BILL

To establish in the Government Printing Office a means of enhancing electronic public access to a wide range of Federal electronic information.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 **SECTION 1. SHORT TITLE.**
- 4 This Act may be cited as the "Government Printing
- 5 Office Electronic Information Access Enhancement Act of
- 6 1993".
- 7 SEC. 2. AMENDMENTS TO TITLE 44, UNITED STATES CODE.
- 8 (a) In General.—Title 44, United States Code, is
- 9 amended by adding at the end the following new chapter:

1 "CHAPTER 41—ACCESS TO FEDERAL

"4101. Electronic directory; online access to publications; electronic storage facility.

"4102. Fees.

"4103. Biennial report.

"4104. Definition.

3 "§ 4101. Electronic directory; online access to publi-

- 4 cations; electronic storage facility
- 5 "(a) IN GENERAL.—The Superintendent of Docu-
- 6 ments, under the direction of the Public Printer, shall—
- 7 "(1) maintain an electronic directory of Federal
- 8 electronic information;
- 9 "(2) provide a system of online access to the
- 10 Congressional Record, the Federal Register, and, as
- determined by the Superintendent of Documents,
- other appropriate publications distributed by the Su-
- perintendent of Documents; and
- 14 "(3) operate an electronic storage facility for
- 15 Federal electronic information to which online access
- is made available under paragraph (2).
- 17 "(b) Departmental Requests.—To the extent
- 18 practicable, the Superintendent of Documents shall ac-
- 19 commodate any request by the head of a department or
- 20 agency to include in the system of access referred to in
- 21 subsection (a)(2) information that is under the control of
- 22 the department or agency involved.

- 1 "(c) Consultation.—In carrying out this section,
- 2 the Superintendent of Documents shall consult—
- 3 "(1) users of the directory and the system of
- 4 access provided for under subsection (a); and
- 5 "(2) other providers of similar information serv-
- 6 ices.
- 7 The purpose of such consultation shall be to assess the
- 8 quality and value of the directory and the system, in light
- 9 of user needs.

10 **"§ 4102. Fees**

- 11 "(a) IN GENERAL.—The Superintendent of Docu-
- 12 ments, under the direction of the Public Printer, may
- 13 charge reasonable fees for use of the directory and the
- 14 system of access provided for under section 4101, except
- 15 that use of the directory and the system shall be made
- 16 available to depository libraries without charge. The fees
- 17 received shall be treated in the same manner as moneys
- 18 received from sale of documents under section 1702 of this
- 19 title.
- 20 "(b) Cost Recovery.—The fees charged under this
- 21 section shall be set so as to recover the incremental cost
- 22 of dissemination of the information involved, with the cost
- 23 to be computed without regard to section 1708 of this
- 24 title.

1 "§ 4103. Biennial report

- 2 "Not later than December 31 of each odd-numbered
- 3 year, the Public Printer shall submit to the Congress, with
- 4 respect to the two preceding fiscal years, a report on the
- 5 directory, the system of access, and the electronic storage
- 6 facility referred to in section 4101(a). The report shall in-
- 7 clude a description of the functions involved, including a
- 8 statement of cost savings in comparison with traditional
- 9 forms of information distribution.

10 ***§ 4104. Definition**

- 11 "As used in this chapter, the term 'Federal electronic
- 12 information' means Federal public information stored
- 13 electronically.".
- 14 (b) CLERICAL AMENDMENT.—The table of chapters
- 15 for title 44, United States Code, is amended by adding
- 16 at the end the following new item:

17 SEC. 3. STATUS REPORT.

- Not later than June 30, 1994, the Public Printer
- 19 shall submit to the Congress a report on the status of the
- 20 directory, the system of access, and the electronic storage
- 21 facility referred to in section 4101 of title 44, United
- 22 States Code, as added by section 2(a).

23 SEC. 4. SPECIAL RULES.

- 24 (a) OPERATIONAL DEADLINE.—The directory, the
- 25 system of access, and the electronic storage facility re-

- 1 ferred to in section 4101 of title 44, United States Code,
- 2 as added by section 2(a), shall be operational not later
- 3 than one year after the date of the enactment of this Act.
- 4 (b) FIRST BIENNIAL REPORT.—The first report re-
- 5 ferred to in section 4103 of title 44, United States Code,
- 6 as added by section 2(a), shall be submitted not later than
- 7 December 31, 1995.
