A BILL

To require the Secretary of Agriculture to use certain unexpended disaster assistance funds, to the extent necessary, to provide emergency crop loss assistance for certain losses, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. EMERGENCY CROP LOSS ASSISTANCE.
- 4 (a) IN GENERAL.—Notwithstanding any other provi-
- 5 sion of law, the Secretary of Agriculture shall use unex-
- 6 pended disaster assistance funds, to the extent necessary
- 7 to carry out this section, to provide emergency crop loss
- 8 assistance to producers for losses to a crop as a result

- 1 of damaging weather or related condition that occurred
- 2 during the period beginning January 1, 1993, and ending
- 3 March 31, 1993, under the same terms and conditions as
- 4 assistance provided under chapter 3 of subtitle B of title
- 5 XXII of the Food, Agriculture, Conservation, and Trade
- 6 Act of 1990 (7 U.S.C. 1421 note) and the provisions of
- 7 law referred to in subsection (d).
- 8 (b) Emergency Loans.—Notwithstanding any
- 9 other provision of law, the Secretary of Agriculture shall
- 10 make emergency loans under subtitle C of the Consoli-
- 11 dated Farm and Rural Development Act (7 U.S.C. 1961
- 12 et seq.) with respect to damage to an annual crop as a
- 13 result of damaging weather or related condition described
- 14 in subsection (a) without regard to the purchase of crop
- 15 insurance under the Federal Crop Insurance Act (7
- 16 U.S.C. 1501 et seq.) by the producer who requests such
- 17 a loan.
- 18 (c) Administration.—
- 19 (1) IN GENERAL.—The Secretary of Agriculture
- shall issue regulations and take such other actions
- as are necessary to permit producers to apply for as-
- sistance under this section not later than 45 days
- after the date of enactment of this Act.
