Resolved, That the bill from the Senate (S. 986) entitled “An Act to provide for an interpretive center at the Civil War Battlefield of Corinth, Mississippi, and for other purposes”, do pass with the following

AMENDMENT:

Strike out all after the enacting clause and insert:

1 ***TITLE I—CIVIL WAR BATTLE-***
2 ***FIELD OF CORINTH, MIS-***
3 ***SISSIPPI***

4 ***SEC. 101. SHORT TITLE.***

5 *This title may be cited as the “Corinth, Mississippi,*
6 *Battlefield Act of 1994”.*

7 ***SEC. 102. FINDINGS AND PURPOSE.***

8 *(a) FINDINGS.—Congress finds that—*

9 *(1) the 14 sites located in the vicinity of Corinth,*
10 *Mississippi, that were designated as a National His-*
11 *toric Landmark by the Secretary of the Interior in*
12 *1991 represent nationally significant events in the*
13 *Siege and Battle of Corinth during the Civil War;*
14 *and*

1 *plete a plan and design for the center, including the follow-*
2 *ing:*

3 *(A) A detailed description of the design of the fa-*
4 *cility.*

5 *(B) A description of the site.*

6 *(C) The method of acquisition.*

7 *(D) The estimated cost of acquisition, construc-*
8 *tion, operation and maintenance.*

9 *(E) The manner and extent to which non-Fed-*
10 *eral entities shall participate in the acquisition, con-*
11 *struction, operation, and maintenance of the center.*

12 *(2) In the development of the plan and design for the*
13 *center the Secretary shall take into consideration the battle-*
14 *field protection plan prepared for the city of Corinth, Mis-*
15 *sissippi and the Siege and Battle of Corinth Task Force,*
16 *and shall provide an opportunity for public comment.*

17 *(3) Upon completion, the Secretary shall submit the*
18 *plan to the Committee on Natural Resources of the House*
19 *of Representatives and the Committee on Energy and Natu-*
20 *ral Resources of the Senate.*

21 *(c) IMPLEMENTATION.—In order to implement the*
22 *plan and design under subsection (b) of this section, the*
23 *Secretary is authorized to acquire lands and interests in*
24 *lands by donation, purchase with donated or appropriated*
25 *funds, or exchange for the construction of the center author-*

1 ized in subsection (a), provided that such lands or interest
2 therein shall only be acquired with the consent of the owner
3 thereof. Federal funds to carry out this section may only
4 be expended on a two-for-one matching basis with non-Fed-
5 eral funds, services, materials, or lands, fairly valued as
6 determined by the Secretary, or any combination thereof.

7 (d) AGREEMENT FOR THE OPERATION AND MAINTENANCE OF THE CENTER.—Before undertaking the construc-
8 tion of the center, the Secretary shall enter into a binding
9 agreement with a qualified non-Federal entity for convey-
10 ance by deed or lease from the Secretary of any structure
11 or property acquired and developed as provided for by this
12 Act. Any such agreement shall provide that—

14 (1) the non-Federal entity agree to operate and
15 maintain the center and make no major alteration of
16 the structure or grounds without the express written
17 authorization of the Secretary;

18 (2) a plan of operations shall be submitted that
19 is satisfactory to the Secretary;

20 (3) the Secretary shall have access to documents
21 relating to the operation and maintenance of the cen-
22 ter;

23 (4) the Secretary shall have the right of access to
24 the center; and

1 (5) *the United States shall be held harmless from*
2 *all events arising from the operation and mainte-*
3 *nance of the center.*

4 (e) *COOPERATIVE AGREEMENTS FOR TECHNICAL AS-*
5 *SISTANCE.—The Secretary may enter into cooperative*
6 *agreements with the State of Mississippi, the city of Cor-*
7 *inth, and other public or private entities to provide tech-*
8 *nical assistance with respect to the center.*

9 **SEC. 104. AUTHORIZATION OF APPROPRIATIONS.**

10 *There is authorized to be appropriated not more than*
11 *\$6,000,000 to carry out this title.*

12 **TITLE II—STONES RIVER**
13 **NATIONAL BATTLEFIELD**

14 **SEC. 201. EXPANSION OF BATTLEFIELD.**

15 *Section 1(a) of the Act entitled “An Act to amend the*
16 *boundaries of Stones River National Battlefield, Tennessee,*
17 *and for other purposes”, approved December 23, 1987 (101*
18 *Stat. 1433; 16 U.S.C. 426n) is amended by striking “num-*
19 *bered 327/80,004B, and dated November 1991” and insert-*
20 *ing “, numbered 327/80,011, and dated May 1994”.*
