CONCURRENT RESOLUTION

Authorizing the 1996 Summer Olympic Torch Relay to be run through the Capitol Grounds, and for other purposes.

1 Resolved by the House of Representatives (the Senate concurring), 3 SECTION 1. AUTHORIZATION OF RUNNING OF 1996 SUMMER 4 OLYMPIC TORCH RELAY THROUGH CAPITOL 5 GROUNDS. 6 On June 20, 1996, or on such other date as the 7 Speaker of the House of Representatives and the Presi-8 dent pro tempore of the Senate may jointly designate, the 1996 Summer Olympic Torch Relay may be run through

the Capitol Grounds, and the Olympic Torch may be dis-

- 1 played on the Capitol Grounds overnight, as part of the
- 2 ceremony of the Centennial Olympic Games to be held in
- 3 Atlanta, Georgia.

4 SEC. 2. CONDITIONS.

- 5 (a) In General.—The event authorized by section
- 6 1 shall be free of admission charge to the public and ar-
- 7 ranged not to interfere with the needs of Congress, under
- 8 conditions to be prescribed by the Architect of the Capitol
- 9 and the Capitol Police Board. The sponsor of the event
- 10 shall assume full responsibility for all expenses and liabil-
- 11 ities incident to all activities associated with the event.
- 12 (b) Prohibition on Display of Advertise-
- 13 MENTS.—The Architect of the Capitol and the Capitol Po-
- 14 lice Board shall take such actions as may be necessary
- 15 to prohibit the display of advertisements for commercial
- 16 products or services during the event. Such actions shall
- 17 include measures to ensure that advertisements are not
- 18 displayed on any vehicle accompanying runners in the
- 19 Torch Relay.

20 SEC. 3. STRUCTURES AND EQUIPMENT.

- 21 For the purposes of this resolution, the sponsor of
- 22 the event authorized by section 1 may erect upon the Cap-
- 23 itol Grounds, subject to the approval of the Architect of
- 24 the Capitol, such structures and equipment as are nec-
- 25 essary for the event.

1 SEC. 4. ADDITIONAL ARRANGEMENTS.

- 2 The Architect of the Capitol and the Capitol Police
- 3 Board are authorized to make any additional arrangement
- 4 that may be required to carry out the event authorized
- 5 by section 1.

6 SEC. 5. LIMITATIONS ON REPRESENTATIONS.

- 7 A commercial sponsor of the 1996 Summer Olympic
- 8 Torch Relay may not represent, either directly or indi-
- 9 rectly, that this resolution or any activity carried out
- 10 under this resolution in any way constitutes approval or
- 11 endorsement by the Federal Government of the commer-
- 12 cial sponsor or any product or service offered by the com-
- 13 mercial sponsor.
