Mr. VENTO introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To expedite the naturalization of aliens who served with special guerrilla units in Laos.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Hmong Veterans’ Nat-
5 uralization Act of 1995”.

6 **SEC. 2. WAIVER OF ENGLISH LANGUAGE REQUIREMENT**

7 **FOR CERTAIN ALIENS WHO SERVED WITH**

8 **SPECIAL GUERRILLA UNITS IN LAOS.**

9 The requirement of paragraph (1) of section 312(a)
10 of the Immigration and Nationality Act (8 U.S.C.

1 1423(a) shall not apply to the naturalization of any per-
2 son who—

3 (1) served with a special guerrilla unit operat-
4 ing from a base in Laos in support of the United
5 States at any time during the period beginning Feb-
6 ruary 28, 1961, and ending September 18, 1978, or

7 (2) is the spouse or widow of a person described
8 in paragraph (1).

9 **SEC. 3. NATURALIZATION THROUGH SERVICE IN A SPECIAL**
10 **GUERRILLA UNIT IN LAOS.**

11 (a) IN GENERAL.—The first sentence of subsection
12 (a) and subsection (b) (other than paragraph (3)) of sec-
13 tion 329 of the Immigration and Nationality Act (8 U.S.C.
14 1440) shall apply to an alien who served with a special
15 guerrilla unit operating from a base in Laos in support
16 of the United States at any time during the period begin-
17 ning February 28, 1961, and ending September 18, 1978,
18 in the same manner as they apply to an alien who has
19 served honorably in an active-duty status in the military
20 forces of the United States during the period of the Viet-
21 nam hostilities.

22 (b) PROOF.—The Immigration and Naturalization
23 Service shall verify an alien's service with a guerrilla unit
24 described in subsection (a) through—

1 (1) review of refugee processing documentation
2 for the alien,

3 (2) the affidavit of the alien's superior officer,

4 (3) original documents,

5 (4) two affidavits from persons who were also
6 serving with such a special guerrilla unit and who
7 personally knew of the alien's service, or

8 (5) other appropriate proof.

9 The Service shall liberally construe the provisions of this
10 subsection to take into account the difficulties inherent in
11 proving service in such a guerrilla unit.
