Mr. CUNNINGHAM (for himself, Mr. BILBRAY, Mr. HUNTER, and Mr. PACKARD) introduced the following bill; which was referred to the Committee on Commerce

A BILL

To amend the Clean Air Act to provide for the reclassification of downwind nonattainment areas, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. RECLASSIFICATION OF DOWNWIND NON-**
4 **ATTAINMENT AREAS.**

5 (a) IN GENERAL.—Section 181(a) of the Clean Air
6 Act is amended by adding the following new paragraph
7 at the end thereof:

8 “(6)(A) In the case of a downwind nonattainment
9 area impacted by transport of ozone pollution from an

1 upwind area, upon application by the State, the Adminis-
2 tration shall—

3 “(i) reclassify the downwind nonattainment
4 area to reflect an adjusted ozone design value which
5 excludes ozone concentrations attributable to trans-
6 port from an upwind area; and

7 “(ii) redesignate the downwind nonattainment
8 area as an attainment area if the adjusted ozone de-
9 sign value (which excludes concentrations attrib-
10 utable to transport from an upwind area) for the
11 most recent applicable period does not exceed the
12 national ambient air quality standard for ozone.

13 “(B) For purposes of this paragraph:

14 “(i) The term ‘downwind nonattainment area’
15 shall mean a nonattainment area where the air en-
16 tering the area at the upwind boundary already con-
17 tains ozone or ozone precursors.

18 “(ii) The term ‘concentration attributable to
19 transport from an upwind area’ shall mean the por-
20 tion of an ozone concentration in a downwind non-
21 attainment area which is demonstrated (to the satis-
22 faction of the Administrator) to have been caused by
23 ozone or ozone precursor emissions from an identi-
24 fied upwind area.

1 “(iii) The term ‘upwind area’ shall mean an
2 area emitting ozone precursor emissions that are
3 demonstrated (to the satisfaction of the Adminis-
4 trator) to be the cause of ozone concentrations
5 measured at a monitoring site in a downwind non-
6 attainment area.”.

7 (b) IMPLEMENTATION PLAN REQUIREMENTS.—Sec-
8 tion 110(a)(2)(D)(i)(I) is amended by inserting “or any
9 other area within the State” after “any other State”.

10 (c) EFFECTIVE DATE.—Not later than 1 year after
11 the enactment of this Act, each State shall adopt and sub-
12 mit a revision of the applicable implementation plan under
13 section 110 of the Clean Air Act to reflect the amend-
14 ments made by this section.
