Mr. YOUNG of Alaska introduced the following bill; which was referred to the
Committee on Resources

A BILL

To provide for an exchange of lands located near Gustavus,
Alaska.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Glacier Bay National
5 Park and Preserve Boundary Adjustment Act of 1995”.

6 **SEC. 2. LAND EXCHANGE.**

7 (a) IN GENERAL.—If the State of Alaska transfers
8 all right, title, and interest in and to the State lands de-
9 scribed in subsection (b)(1) to the Secretary of the Inte-
10 rior, the Secretary shall transfer to the State of Alaska

1 all right, title, and interest of the United States in and
 2 to the Federal lands described in subsection (b)(2).

3 (b) LANDS DESCRIBED.—

4 (1) STATE LANDS.—The lands referred to in
 5 subsection (a) to be transferred by the State of Alas-
 6 ka comprise approximately 960 acres within the
 7 Dude Creek Critical Habitat Area more particularly
 8 described as follows:

9 Township 40 South, Range 58 East,
 10 C.R.M.

11 Section 16 in its entirety.

12 Section 9, W¹/₂.

13 (2) FEDERAL LANDS.—The lands referred to in
 14 subsection (a) to be transferred by the Secretary
 15 comprise approximately 960 acres more particularly
 16 described as follows:

17 In Township 39 South, Range 59 East,
 18 Copper River Meridian (C.R.M.) partially sur-
 19 veyed—

20 Section 36 (unsurveyed, SE¹/₄SW¹/₄,
 21 S¹/₂SW¹/₄SW¹/₄, NE¹/₄SW¹/₄, W¹/₂W¹/₂,
 22 NW¹/₄SE¹/₄, and S¹/₂SE¹/₄NW¹/₄, contain-
 23 ing approximately 130 acres.

24 In Township 40 South, Range 59 East,
 25 partially surveyed—

1 Section 1 (unsurveyed) NW¹/₄, SW¹/₄,
2 W¹/₂SE¹/₄, and SW¹/₄SW¹/₄NE¹/₄, exclud-
3 ing U.S. Survey 944 and Native Allotment
4 A-442;

5 Section 2 (unsurveyed), fractional,
6 that portion lying above the mean high tide
7 line of Icy Passage, excluding U.S. Survey
8 944 and U.S. Survey 945;

9 Section 11 (unsurveyed), fractional,
10 that portion lying above the mean high tide
11 line of Icy Passage, excluding U.S. Survey
12 944;

13 Section 12 (unsurveyed), fractional,
14 NW¹/₄NE¹/₄, W¹/₂NW¹/₄SW¹/₄NE¹/₄, those
15 portions of NW¹/₄ and SW¹/₄ lying above
16 the mean high tide line of Icy Passage, ex-
17 cluding U.S. Survey 944 and Native Allot-
18 ment A-442,

19 containing approximately 830 acres,
20 aggregating approximately 960 acres.

21 (c) GLACIER BAY NATIONAL PARK AND PRE-
22 SERVE.—The lands acquired from the State of Alaska
23 under this section shall be added to and administered as
24 part of the Glacier Bay National Park and Preserve, sub-
25 ject to valid existing rights. Upon completion of the ex-

1 change of lands under this section, the Secretary shall ad-
2 just the boundary of Glacier Bay National Park and Pre-
3 serve to include the lands acquired from the State of Alas-
4 ka and to exclude the lands transferred to the State of
5 Alaska under this section.
