A BILL

To amend title 28, United States Code, to authorize the appointment of additional bankruptcy judges, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Bankruptcy Judgeship
- 3 Act of 1995".
- 4 SEC. 2. PERMANENT JUDGESHIPS.
- 5 Section 152(a)(2) of title 28, United States Code, is
- 6 amended—
- 7 (1) in the item relating to the central district
- 8 of California by striking "21" and inserting "25";
- 9 and
- 10 (2) in the item relating to the district of Mary-
- land by striking "4" and inserting "5".
- 12 SEC. 3. TEMPORARY JUDGESHIPS.
- 13 (a) APPOINTMENTS.—The following are temporary
- 14 judgeship positions which shall be filled in the manner pre-
- 15 scribed in section 152(a)(1) of title 28, United States
- 16 Code:
- 17 (1) 1 additional bankruptcy judgeship for the
- southern district of Florida.
- 19 (2) 1 additional bankruptcy judgeship for the
- 20 eastern district of Michigan.
- 21 (3) 1 additional bankruptcy judgeship for the
- 22 district of New Jersey.
- 23 (4) 1 additional bankruptcy judgeship for the
- eastern district of New York.
- 25 (5) 1 additional bankruptcy judgeship for the
- 26 northern district of New York.

- 1 (6) 1 additional bankruptcy judgeship for the 2 eastern district of Pennsylvania.
- 3 (b) Vacancies.—The first vacancy occurring in the
- 4 office of a bankruptcy judge in each of the judicial dis-
- 5 tricts set forth in subsection (a)—
- 6 (1) which results from the death, retirement,
- 7 resignation, or removal of a bankruptcy judge ap-
- 8 pointed under section 152(a)(1) of title 28, United
- 9 States Code, and
- 10 (2) which occurs 5 years or more after the ap-
- pointment date of a judge under subsection (a),
- 12 shall not be filled.
- 13 SEC. 4. TECHNICAL.
- The first sentence of section 152(a)(1) of title 28,
- 15 United States Code, is amended to read as follows: "The
- 16 bankruptcy judges established in paragraph (2) for a judi-
- 17 cial district shall be appointed, in such number as are es-
- 18 tablished in such paragraph, by the United States court
- 19 of appeals for the circuit in which such district is lo-
- 20 cated.".
