2	tives of the United States of America in Congress assembled,
3	SECTION 1. PROHIBITION OF USE ON DEPARTMENT OF DE-
4	FENSE FUNDS FOR DEPLOYMENT ON THE
5	GROUND OF UNITED STATES ARMED FORCES
6	IN THE REPUBLIC OF BOSNIA AND
7	HERZEGOVINA AS PART OF ANY PEACEKEEP-
8	ING OPERATION OR IMPLEMENTATION
9	FORCE.
10	None of the funds appropriated or otherwise available
11	to the Department of Defense may be obligated or ex-
12	pended for the deployment on the ground of United States
13	Armed Forces in the Republic of Bosnia and Herzegovina
14	as part of any peacekeeping operation, or as part of any
15	implementation force, unless funds for such deployment
16	have been specifically appropriated by a law enacted after
17	the date of the enactment of this Act.
