AN ACT

- To transfer jurisdiction over certain parcels of Federal real property located in the District of Columbia, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. PURPOSE.

| 13 | SEC. 2. TRANSFERS OF JURISDICTION. |
| 14 | (a) In General.—Effective on the date of the enact- |
| 15 | ment of this Act and notwithstanding any other provision |
| 16 | of law, jurisdiction over the parcels of Federal real prop- |
| 17 | erty described in subsection (b) is transferred without ad- |
| 18 | ditional consideration as provided by subsection (b). |
| 19 | (b) Specific Transfers.— |
| 20 | (1) Transfers to secretary of the inte- |
| 21 | RIOR.— |
| 22 | (A) In general.—Jurisdiction over the |
| 23 | following parcels is transferred to the Secretary |
| 24 | of the Interior: |
| 25 | (i) That triangle of Federal land, in- |
| 26 | cluding any contiguous sidewalks and tree |

space, that is part of the United States Capitol Grounds under the jurisdiction of the Architect of the Capitol bound by D Street, N.W., New Jersey Avenue, N.W., and Louisiana Avenue, N.W., in Square W632 in the District of Columbia, as shown on the Map Showing Properties Under Jurisdiction of the Architect of the Capitol, dated November 8, 1994.

- (ii) That triangle of Federal land, including any contiguous sidewalks and tree space, that is part of the United States Capitol Grounds under the jurisdiction of the Architect of the Capitol bound by C Street, N.W., First Street, N.W., and Louisiana Avenue, N.W., in the District of Columbia, as shown on the Map Showing Properties Under Jurisdiction of the Architect of the Capitol, dated November 8, 1994.
- (B) Limitation.—The parcels transferred by subparagraph (A) shall not include those contiguous sidewalks abutting Louisiana Avenue, N.W., which shall remain part of the Unit-

10 SEC. 3. MISCELLANEOUS.

- 11 (a) Compliance With Other Laws.—Compliance
- 12 with this Act shall be deemed to satisfy the requirements
- 13 of all laws otherwise applicable to transfers of jurisdiction
- 14 over parcels of Federal real property.
- 15 (b) Law Enforcement Responsibility.—Law en-
- 16 forcement responsibility for the parcels of Federal real
- 17 property for which jurisdiction is transferred by section
- 18 2 shall be assumed by the person acquiring such jurisdic-
- 19 tion.
- 20 (c) United States Capitol Grounds.—
- 21 (1) Definition.—The first section of the Act
- 22 entitled "An Act to define the United States Capitol
- Grounds, to regulate the use thereof, and for other
- 24 purposes", approved July 31, 1946 (40 U.S.C.
- 25 193a), is amended to include within the definition of

- the United States Capitol Grounds the parcels of Federal real property described in section 2(b)(2).
- 3 (2) JURISDICTION OF CAPITOL POLICE.—The
 4 United States Capitol Police shall have jurisdiction
 5 over the parcels of Federal real property described
 6 in section 2(b)(2) in accordance with section 9 of
 7 such Act of July 31, 1946 (40 U.S.C. 212a).
- 8 (e) Effect of Transfers.—A person relinquishing
- 9 jurisdiction over a parcel of Federal real property trans-
- 10 ferred by section 2 shall not retain any interest in the par-
- 11 cel except as specifically provided by this Act.
