A BILL

To repeal the emergency salvage timber sale program enacted as part of Public Law 104–19.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Restoration of Natural
- 3 Resources Laws on the Public Lands Act of 1995".
- 4 SEC. 2. REPEAL OF EMERGENCY SALVAGE TIMBER SALE
- 5 PROGRAM OF PUBLIC LAW 104-19.
- 6 (a) Repeal.—Section 2001 of Public Law 104–19
- 7 (109 Stat. 240) is repealed.
- 8 (b) Implementation.—Notwithstanding any out-
- 9 standing judicial order or administrative proceeding inter-
- 10 preting section 2001 of Public Law 104–19 (109 Stat.
- 11 240), the Secretary of Agriculture and the Secretary of
- 12 the Interior shall suspend, effective on the date of the en-
- 13 actment of this Act, each and every activity that is being
- 14 undertaken in whole or in part under the authority pro-
- 15 vided in such section unless the Secretary concerned deter-
- 16 mines that the activity would have been undertaken even
- 17 in the absence of such section. All such suspended activi-
- 18 ties shall be subject to all applicable environmental and
- 19 natural resource laws. The Secretary concerned may not
- 20 resume an activity suspended under this subsection unless
- 21 and until the Secretary concerned determines that the ac-
- 22 tivity (as originally commenced or as modified after the
- 23 date of the enactment of this Act) complies with all envi-
- 24 ronmental and natural resource laws applicable to the ac-
- 25 tivity.

1	(c) Secretary Concerned Defined.—In this sec-
2	tion, the term "Secretary concerned" means—
3	(1) the Secretary of Agriculture, with respect to
4	activities involving lands within the National Forest
5	System; and
6	(2) the Secretary of the Interior, with respect
7	to activities involving Federal lands under the juris-
8	diction of the Bureau of Land Management.
