A BILL

- To provide that rates of basic pay for Members of Congress be determined as a function of efforts to eliminate the Federal deficit.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Congressional Pay for
- 5 Performance Act".

6 SEC. 2. DEFINITIONS.

7 For purposes of this Act—

1	(1) the term "Federal deficit" has the meaning
2	given the term deficit by section 3(6) of the Con-
3	gressional Budget Act of 1974 (2 U.S.C. $622(6)$);
4	(2) the term "deficit target", as used with re-
5	spect to a fiscal year, means the maximum allowable
6	Federal deficit for such fiscal year, as set forth in
7	the concurrent resolution on the budget for fiscal
8	year 1996;
9	(3) the term "concurrent resolution on the
10	budget" has the meaning given such term by section
11	3(4) of the Congressional Budget Act of 1974 (2
12	U.S.C. 622(4)); and
13	(4) the term "Member of Congress" means an
14	individual who holds a position referred to in section
15	601(a) of the Legislative Reorganization Act of
16	1946 (2 U.S.C. 31), as amended by section 4.
17	SEC. 3. PAY AS A FUNCTION OF EFFORTS TO ELIMINATE
18	THE FEDERAL DEFICIT.
19	(a) IF DEFICIT TARGETS ARE NOT MET.—
20	(1) INTERIM TARGETS.—If, for any of fiscal
21	years 1996 through 2001, inclusive, the Federal def-
22	icit for such fiscal year exceeds the deficit target for
23	such fiscal year by more than \$1 billion, then, effec-
24	tive as of the first day of the first applicable pay pe-
25	riod of the first calendar year beginning after the

1	end of such fiscal year, the rate of basic pay for
2	each Member of Congress shall be equal to the rate
3	in effect on the day before the date of the adjust-
4	ment under this paragraph, reduced by the percent-
5	age derived by multiplying 0.5 percent by the num-
6	ber of billions of dollars (after rounding to the next
7	lower multiple of $\$1$ billion) by which such target
8	was so exceeded, except that nothing in this para-
9	graph shall cause any rate to be reduced below zero.
10	(2) FINAL TARGET.—If the Federal deficit for
11	fiscal year 2002 is \$1 billion or greater, then, effec-
12	tive as of the first day of the first applicable pay pe-
13	riod in calendar year 2003, the rate of basic pay for
14	each Member of Congress shall be zero.
15	(b) IF DEFICIT TARGETS ARE MET.—
16	(1) Other than by eliminating the defi-
17	CIT.—Except as provided in paragraph (2), if, for
18	any of fiscal years 1996 through 2001, inclusive, the
19	Federal deficit for such year is less than, or within
20	\$1 billion of, the deficit target for such fiscal year,
21	then no change shall be made in the rate of basic
22	pay for any Member of Congress based on the size
23	of the Federal deficit for such year.
24	(2) By eliminating the deficit.—If, for any
25	of figeal years 1006 through 2002 inclusive the

25 of fiscal years 1996 through 2002, inclusive, the

1	Federal deficit for such year is less than \$1 billion,
2	then, effective as of the first day of the first applica-
3	ble pay period of the first calendar year beginning
4	after the end of such fiscal year—
5	(A) the rate of basic pay for each Member
6	of Congress shall be restored to the rate in ef-
7	fect as of December 31, 1995; and
8	(B) this section shall cease to be effective.
9	(c) Determining the Size of the Deficit.—For
10	purposes of this section, the size of the Federal deficit for
11	any fiscal year shall be as determined by the Congressional
12	Budget Office (in writing)—
13	(1) on the basis of the Final Monthly Treasury
14	Statement of Receipts and Outlays of the United
15	States Government, published by the Department of
16	the Treasury; and
17	(2) excluding any increase in tax revenues, at-
18	tributable to the fiscal year involved, which occurs
19	by reason of any provision of law enacted after the
20	date of the enactment of this Act.
21	(d) EXCEPTION.—The rate of basic pay for an indi-
22	vidual shall, for the duration of such individual's first term
23	of office as a Member of Congress, be determined as if
24	this section had never been enacted.
25	(e) SUSPENSION IN TIME OF WAR.—

1	(1) IN GENERAL.—In the event of a war de-
2	clared by Congress, rates of pay shall be restored to
3	the rates that would then be payable if, and shall be
4	subject to adjustment in the same way as if, this
5	section had never been enacted, subject to paragraph
6	(2).
7	(2) END OF WAR.—After any such war ends,
8	the preceding subsections of this section shall again
9	become effective, except that, in applying such sub-
10	sections—
11	(A) any reference to fiscal year 1996 shall
12	be deemed to be a reference to the first fiscal
13	year beginning after the date on which such
14	war ends; and
15	(B) any reference to any later fiscal year
16	shall be determined accordingly.
17	The respective fiscal years to which the deficit tar-
18	gets set forth in any concurrent resolution on the
19	budget for fiscal year 1996 shall be determined in
20	like manner for purposes of so applying such sub-
21	sections.

1	SEC. 4. ELIMINATION OF AUTOMATIC ANNUAL PAY ADJUST-
2	MENTS FOR MEMBERS OF CONGRESS.
3	(a) IN GENERAL.—Paragraph (2) of section 601(a)
4	of the Legislative Reorganization Act of 1946 (2 U.S.C.
5	31) is repealed.
6	(b) Conforming Amendments.—Section 601(a)(1)
7	of such Act is amended—
8	(1) by striking "(a)(1)" and inserting "(a)";
9	(2) by redesignating subparagraphs (A), (B),
10	and (C) as paragraphs (1), (2), and (3), respectively;
11	and
12	(3) by striking ", as adjusted by paragraph (2)
13	of this subsection".
