## A BILL

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Anti-Car Theft Im-
- 5 provements Act of 1995".
- 6 SEC. 2. DEFINITIONS.
- 7 Section 30501(1) of title 49, United States Code, is
- 8 amended by inserting before the period the following: "and
- 9 'motor vehicle' has the same meaning as the term 'pas-
- 10 senger motor vehicle' has in section 32101(10)".
- 11 SEC. 3. SYSTEM NAME AND IMPLEMENTATION DATE.
- 12 (a) Section 30502.—Section 30502(a)(1) of title
- 13 49, United States Code, is amended—
- 14 (1) by striking "January 31, 1996" and insert-
- ing "October 1, 1997", and
- 16 (2) by striking "Automobile" each place it oc-
- 17 curs and inserting "Motor Vehicle".
- 18 (b) Section 30503.—Section 30503(d) of title 49,
- 19 United States Code, is amended by striking "January 1,
- 20 1997" and inserting "October 1, 1998".
- 21 SEC. 4. DELEGATION OF AUTHORITY.
- 22 (a) Secretary of Transportation.—Sections
- 23 30501, 30502, 30503, 30504, and 30505 of title 49,
- 24 United States Code, are each amended by striking each

- 1 reference to "Secretary of Transportation" or "Secretary"
- 2 and inserting "Attorney General".
- 3 (b) Attorney General.—Section 30502 of title 49,
- 4 United States Code, is amended by striking each reference
- 5 to "Attorney General" and inserting "Secretary of Trans-
- 6 portation".

#### 7 SEC. 5. TITLE INFORMATION SYSTEM.

- 8 Section 30502 of title 49, United States Code, is
- 9 amended by adding at the end the following:
- 10 "(f) Immunity.—Any person performing any activity
- 11 under this section or sections 30503 or 30504 in good
- 12 faith and with the reasonable belief that such activity was
- 13 in accordance with this section or section 30503 or 30504,
- 14 as the case may be, shall be immune from any civil action
- 15 seeking money damages or equitable relief in any court
- 16 of the United States or a State.".

#### 17 SEC. 6. STOLEN VEHICLE INFORMATION SYSTEM.

- 18 Section 33109 of title 49, United States Code, is
- 19 amended by adding at the end the following:
- 20 "(d) Immunity.—Any person performing any activity
- 21 under this section or section 33110 or 33111 in good faith
- 22 and with the reasonable belief that such activity was in
- 23 accordance with such section shall be immune from any
- 24 civil action seeking money damages or equitable relief in
- 25 any court of the United States or a State.".

#### 1 SEC. 7. GRANTS TO STATES.

- 2 (a) AMENDMENT.—Section 30503(c)(2) of title 49,
- 3 United States Code, is amended to read as follows:
- 4 "(2) The Attorney General may make reasonable and
- 5 necessary grants to participating States to be used in
- 6 making titling information maintained by those States
- 7 available to the operator.".
- 8 (b) AUTHORIZATION.—There are authorized to be ap-
- 9 propriated such sums as may be necessary to carry out
- 10 section 30503 of title 49, United States Code.
- 11 (c) Information System.—The information system
- 12 established under section 30502 of title 49, United States
- 13 Code, shall be effective as provided in the rules promul-
- 14 gated by the Attorney General.
