A BILL

To amend title 38, United States Code, to change the name of the Servicemen's Group Life Insurance program to Servicemembers' Group Life Insurance, to authorize the termination of life insurance under that program when premiums are not paid, to provide for coverage under that program to be provided automatically at the maximum level unless the servicemember elects a lower level, and to make other improvements to life insurance programs administered by the Secretary of Veterans Affairs.

20	SEC. 7. EFFECTIVE DATE.
21	The Servicemembers' Group Life Insurance of any
22	member of the Retired Reserve of a uniformed service in
23	force on the date of the enactment of this Act shall be

- 1 converted, effective 90 days after that date, to Veterans'
- 2 Group Life Insurance.
