A BILL

To authorize the extension of nondiscriminatory treatment (most-favored-nation treatment) to the products of Bulgaria.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

SECTION 1. CONGRESSIONAL FINDINGS AND SUPPLE-2 MENTAL ACTION. 3 (a) Congressional Findings.—The Congress finds that Bulgaria— 4 5 (1) has received most-favored-nation treatment 6 since 1991 and has been found to be in full compli-7 ance with the freedom of emigration requirements 8 under title IV of the Trade Act of 1974 since 1993; 9 (2) has reversed many years of Communist dic-10 tatorship and instituted a constitutional republic 11 ruled by a democratically elected government as well 12 as basic market-oriented reforms, including privat-13 ization; 14 (3) is in the process of acceding to the General 15 Agreement on Tariffs and Trade (GATT) and the 16 World Trade Organization (WTO), and extension of 17 unconditional most-favored-nation treatment would 18 enable the United States to avail itself of all rights 19 under the GATT and the WTO with respect to Bul-20 garia; and 21 (4) has demonstrated a strong desire to build 22 friendly relationships and to cooperate fully with the 23 United States on trade matters. 24 (b) SUPPLEMENTAL ACTION.—The Congress notes that the United States Trade Representative intends to

26 negotiate with Bulgaria in order to preserve the commit-

- 1 ments of that country under the bilateral commercial
- 2 agreement in effect between that country and the United
- 3 States that are consistent with the GATT and the WTO.
- 4 SEC. 2. TERMINATION OF APPLICATION OF TITLE IV OF
- 5 THE TRADE ACT OF 1974 TO BULGARIA.
- 6 (a) Presidential Determinations and Exten-
- 7 SION OF NONDISCRIMINATORY TREATMENT.—Notwith-
- 8 standing any provision of title IV of the Trade Act of 1974
- 9 (19 U.S.C. 2431 et seq.), the President may—
- 10 (1) determine that such title should no longer
- 11 apply to Bulgaria; and
- 12 (2) after making a determination under para-
- graph (1) with respect to Bulgaria, proclaim the ex-
- tension of nondiscriminatory treatment (most-
- 15 favored-nation treatment) to the products of that
- 16 country.
- 17 (b) Termination of Application of Title IV.—
- 18 On and after the effective date of the extension under sub-
- 19 section (a)(2) of nondiscriminatory treatment to the prod-
- 20 ucts of Bulgaria, title IV of the Trade Act of 1974 shall
- 21 cease to apply to that country.
