 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Fisheries Disaster As-
 - 5 sistance Act of 1996".

1	SEC. 2. AMENDMENTS TO INTERJURISDICTIONAL FISH-
2	ERIES ACT OF 1986.
3	Section 308(d) of the Interjurisdictional Fisheries
4	Act of 1986 (16 U.S.C. 4107(d)) is amended—
5	(1) in the heading by striking "Grants" and
6	inserting "Assistance";
7	(2) in paragraph (1) by striking "award grants
8	to persons engaged in commercial fisheries, for unin-
9	sured losses determined by the Secretary to have
10	been suffered" and inserting "help persons engaged
11	in commercial fisheries, either by providing assist-
12	ance directly to those persons or by providing assist-
13	ance indirectly through State and local government
14	agencies and nonprofit organizations, for projects or
15	other measures to alleviate harm determined by the
16	Secretary to have been incurred";
17	(3) in paragraph (3) by striking "a grant under
18	this subsection" and inserting "assistance provided
19	directly to a person under this subsection";
20	(4) by amending paragraph (4) to read as fol-
21	lows:
22	"(4)(A) The Secretary may not award any assistance
23	under this subsection under a fishing capacity reduction
24	program designed to remove fishing vessels and fishing
25	permits from any New England fishery until there has

- 8 "(B) As a condition of awarding assistance with re-
- 9 spect to a vessel under a fishing capacity reduction pro-
- 10 gram described in subparagraph (A), the Secretary shall—
- "(i) prohibit the vessel from being used for fish-
- ing; and
- "(ii) require that the vessel be—
- 14 "(I) scrapped or otherwise disposed of in a
- manner approved by the Secretary; or
- 16 "(II) donated to a nonprofit organization
- and thereafter used only for purposes of re-
- search, education, or training.
- 19 "(C) A vessel that is prohibited from fishing under
- 20 subparagraph (B) shall not be eligible for a fishery en-
- 21 dorsement under section 12108(a) of title 46, United
- 22 States Code, and any such endorsement for the vessel shall
