

***In the Senate of the United States,***

*September 19, 1996.*

*Resolved*, That the bill from the House of Representatives (H.R. 3068) entitled “An Act to accept the request of the Prairie Island Indian Community to revoke their charter of incorporation issued under the Indian Reorganization Act”, do pass with the following

**AMENDMENT:**

Strike out all after the enacting clause and insert:

1 ***SECTION 1. REVOCATION OF CHARTER OF INCORPORATION***  
2 ***OF THE PRAIRIE ISLAND INDIAN COMMUNITY***  
3 ***UNDER THE INDIAN REORGANIZATION ACT.***

4 *(a) ACCEPTANCE OF REQUEST TO REVOKE CHAR-*  
5 *TER.—The request of the Prairie Island Indian Community*  
6 *to surrender the charter of incorporation issued to that com-*  
7 *munity on July 23, 1937, pursuant to section 17 of the*  
8 *Act of June 18, 1934, commonly known as the “Indian Re-*  
9 *organization Act” (48 Stat. 988, chapter 576; 25 U.S.C.*  
10 *477) is hereby accepted.*

1       (b) *REVOCATION OF CHARTER.*—*The charter of incor-*  
2 *poration referred to in subsection (a) is hereby revoked.*

3 **SEC. 2. AMENDMENT TO THE JICARILLA APACHE TRIBE**  
4 **WATER RIGHTS SETTLEMENT ACT.**

5       Section 8(e)(3) *The Jicarilla Apache Tribe Water*  
6 *Rights Settlement Act (106 Stat. 2241) is amended by strik-*  
7 *ing “December 31, 1996” and inserting “December 31,*  
8 *1998”.*

9 **SEC. 3. AMENDMENT TO THE SAN CARLOS APACHE TRIBE**  
10 **WATER RIGHTS SETTLEMENT ACT OF 1992.**

11       Section 3711(b)(1) *of the San Carlos Apache Tribe*  
12 *Water Rights Settlement Act of 1992 (106 Stat. 4752) is*  
13 *amended by striking “December 31, 1996” and inserting*  
14 *“June 30, 1997”.*
