To amend the Congressional Budget Act of 1974 and chapter 11 of title 31, United States Code, to require that reports accompanying concurrent resolutions on the budget include analyses, prepared after consultation with the Congressional Budget Office, of generational accounting information and that Presidents' annual budget submissions include generational accounting information.

# A BILL

To amend the Congressional Budget Act of 1974 and chapter 11 of title 31, United States Code, to require that reports accompanying concurrent resolutions on the budget include analyses, prepared after consultation with the Congressional Budget Office, of generational accounting information and that Presidents' annual budget submissions include generational accounting information. Be it enacted by the Senate and House of Representa tives of the United States of America in Congress assembled,

### **3 SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "Children's Right to5 Know Act of 1996".

### 6 SEC. 2. CONGRESSIONAL BUDGET.

7 Section 301(e) of the Congressional Budget Act of
8 1974 is amended by striking paragraph (10) and inserting
9 the following:

10 "(10) an analysis, prepared after consultation 11 with the Director of the Congressional Budget Of-12 fice, of the generational accounting consequences of 13 the concurrent resolution, including the projected 14 Federal deficit, at current spending levels, in the fis-15 cal year that is 20 years after the first fiscal year 16 covered by the concurrent resolution and the revenue 17 levels (including the increase required in current lev-18 els) required to eliminate the projected Federal defi-19 cit.".

### 20 SEC. 3. PRESIDENT'S BUDGET.

Section 1105(a) of title 31, United States Code, is
amended by adding at the end the following new paragraph:

24 "(32) an analysis of the generational account-25 ing consequences of the budget including the pro-

jected Federal deficit, at current spending levels, in
 the fiscal year that is 20 years after the fiscal year
 for which the budget is submitted and the revenue
 levels (including the increase required in current lev els) required to eliminate the projected Federal defi cit.".
