Mr. DICKEY introduced the following bill; which was referred to the Committee on House Oversight

A BILL

To amend title 5, United States Code, to deny Federal retirement annuities to Members of Congress convicted of any felony, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CONVICTION OF CERTAIN OFFENSES.**

4 (a) IN GENERAL.—Section 8312(a) of title 5, United
5 States Code, is amended—

6 (1) by striking “or” at the end of paragraph
7 (1), by striking the period at the end of paragraph
8 (2) and inserting “; or”, and by adding after para-
9 graph (2) the following:

1 “(3) was convicted of an offense described in
2 subsection (e), to the extent provided by that sub-
3 section.”; and

4 (2) by striking “and” at the end of subpara-
5 graph (A), by striking the period at the end of sub-
6 paragraph (B) and inserting “; and”, and by adding
7 after subparagraph (B) the following:

8 “(C) with respect to an offense described in
9 subsection (e), to the period after the date of the
10 conviction.”.

11 (b) DESCRIPTION OF OFFENSES.—Section 8312 of
12 title 5, United States Code, is amended by adding at the
13 end the following:

14 “(e) An offense described in this subsection is any
15 offense—

16 “(1) which is a felony under Federal or State
17 law;

18 “(2) which was committed while the individual
19 was a Member of Congress (including a Delegate to
20 Congress); and

21 “(3) which was committed after the date of the
22 enactment of this subsection.”.

1 **SEC. 2. ABSENCE FROM THE UNITED STATES TO AVOID**
2 **PROSECUTION.**

3 Section 8313(a)(1) of title 5, United States Code, is
4 amended by striking “or” at the end of subparagraph (A),
5 by striking “and” at the end of subparagraph (B) and
6 inserting “or”, and by adding at the end the following:

7 “(C) for an offense described in section
8 8312(e); and”.

9 **SEC. 3. REFUND OF CONTRIBUTIONS AND DEPOSITS.**

10 (a) **GENERAL RULE.—**

11 (1) **APPLICABILITY TO OFFENSES DESCRIBED**
12 **IN SECTION 8312(E).—**Section 8316(b) of title 5,
13 United States Code, is amended by striking “or” at
14 the end of paragraph (1), by striking the period at
15 the end of paragraph (2) and inserting “; or”, and
16 by adding at the end the following:

17 “(3) if the individual was convicted of an of-
18 fense described in section 8312(e), for the period
19 after the conviction.”.

20 (2) **CONFORMING AMENDMENT.—**Section
21 8316(a) of title 5, United States Code, is amended
22 by inserting “(or described in)” after “an offense
23 named by”.

24 (b) **TREATMENT OF CONTRIBUTIONS TO THE THRIFT**
25 **SAVINGS PLAN.—**

1 (1) IN GENERAL.—Section 8316 of title 5,
2 United States Code, is amended by adding at the
3 end the following:

4 “(c)(1) When payment of annuity or retired pay is
5 denied under this chapter because an individual was con-
6 victed of an offense named by (or described in) section
7 8312, to the extent provided by that section, or violated
8 section 8314 or 8415, the amount standing to such indi-
9 vidual’s credit in the Thrift Savings Plan at the time of
10 the conviction or violation (as the case may be) shall, on
11 appropriate application therefor, be refunded or otherwise
12 made available to such individual, at such time, in such
13 manner, to such extent, and otherwise in accordance with
14 such regulations as the Executive Director shall prescribe
15 consistent, to the extent practicable, with subsections (a)
16 and (b).

17 “(2) For the purpose of this subsection—

18 “(A) the term ‘Thrift Savings Plan’ means the
19 Thrift Savings Plan under subchapter III of chapter
20 84; and

21 “(B) the term ‘Executive Director’ means the
22 Executive Director appointed under section
23 8474(a).”.

24 (2) CONFORMING AMENDMENT.—Section
25 8318(d) of title 5, United States Code, is amended

1 by adding at the end the following: “The Executive
2 Director shall prescribe regulations to effectuate the
3 application of this subsection in any case in which
4 the pardoned individual is an individual with respect
5 to whom the regulations under section 8316(c) were
6 applied.”.

7 **SEC. 4. RESTORATION OF ANNUITY OR RETIRED PAY.**

8 (a) **IN GENERAL.**—Section 8318 of title 5, United
9 States Code, is amended in subsections (a) and (c) by in-
10 serting “(or by the Governor, in the case of a felony under
11 State law described in section 8312(e))” after “by the
12 President”.

13 (b) **CONFORMING AMENDMENT.**—Section 8318(a)(1)
14 of title 5, United States Code, is amended by inserting
15 “(or described in)” after “an offense named by”.
