A BILL

To amend the Organic Act of Guam to provide the government of Guam the opportunity to acquire excess real property in Guam, and to release lands from a condition on disposal by Guam.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Guam Land Return
- 5 Act".

1 SEC. 2. OPPORTUNITY FOR GUAM TO ACQUIRE EXCESS

- 2 REAL PROPERTY IN GUAM.
- The Organic Act of Guam (48 U.S.C. 1421 et seq.)
- 4 is amended by adding at the end the following new title:
- 5 "Sec. 36. (a) At least 180 days before transferring
- 6 to any Federal agency excess real property located in
- 7 Guam, the Administrator of General Services shall notify
- 8 the government of Guam that the property is available
- 9 under this section.
- 10 "(b) The Administrator shall transfer to the govern-
- 11 ment of Guam all right, title, and interest of the United
- 12 States in and to excess real property located in Guam,
- 13 by quit claim deed and without reimbursement, if the gov-
- 14 ernment of Guam, within 180 days after receiving notifica-
- 15 tion under subsection (a) regarding the property, notifies
- 16 the Administrator that the government intends to acquire
- 17 the property under this section.
- 18 "(c) For purposes of this section, the term 'excess
- 19 real property' means excess property (as that term is de-
- 20 fined in section 3 of the Federal Property and Administra-
- 21 tive Services Act of 1949, as in effect on the date of enact-
- 22 ment of the Guam Land Return Act) that is real prop-
- 23 erty.".

1 SEC. 3. RELEASE OF LANDS FROM CONDITION ON DIS-

- 2 POSAL BY GUAM.
- 3 (a) In General.—Section 818(b)(2) of Public Law
- 4 96-418 (94 Stat. 1782), relating to a condition on dis-
- 5 posal by Guam of lands conveyed to Guam by the United
- 6 States, shall have no force or effect and is repealed.
- 7 (b) Execution of Instruments.—The Secretary
- 8 of the Navy and the Administrator of General Services
- 9 shall execute all instruments necessary to implement this
- 10 section.
