# A BILL

- To amend title 38, United States Code, to improve the research activities of the Department of Veterans Affairs relating to women veterans.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

#### **3** SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Women Veterans Re-
- 5 search Act of 1996".

## 6 SEC. 2. FINDINGS.

- 7 Congress makes the following findings:
- 8 (1) Health care for veterans has traditionally9 been considered in terms of male veterans and most

1	research conducted by the Department of Veterans
2	Affairs is focused on male veterans.
3	(2) Department of Veterans Affairs researchers
4	are responsible for developing both the CAT scan
5	and the MRI technology.
6	(3) Department researchers are responsible for
7	many medical "firsts", including the first liver
8	transplant, the first effective therapy for tuber-
9	culosis, and the first artificial kidney.
10	(4) Department researchers are on the forefront
11	of the rapeutic discoveries, including aspirin the rapy
12	for heart disease, implantable insulin pumps for dia-
13	betes, surgical treatment to reduce the risk of
14	stroke, specialized drug treatment for high blood
15	pressure, and treatment options for prostate cancer.
16	(5) The primary mission of the Department's
17	rehabilitation research and development activities is
18	to develop devices to assist veterans in need of pros-
19	thetic devices, sensory aids, and mobility assistance.
20	(6) The mission of the Health Services Re-
21	search and Development Service of the Department
22	is to develop and conduct research that integrates
23	clinical needs and research inquiry to enhance the
24	quality of health care delivery to veterans.

3 (a) INCLUSION OF WOMEN AND MINORITIES IN
4 HEALTH RESEARCH.—Section 7303(c)(1) of title 38,
5 United States Code, is amended—

(1) by striking out ", whenever possible and ap-6 propriate—" in the matter preceding paragraph (1); 7 8 (2) in paragraph (1), by inserting before the 9 semicolon "(except in the case of a research project 10 which by its nature is inapplicable to women veter-11 ans) and that such inclusion is ongoing and continu-12 ous, with monitoring strategies and evaluations in 13 effect to ensure that a sufficient number of women 14 veterans are included to establish statistical signifi-15 cance"; and

16 (3) in paragraph (2), by inserting "whenever17 possible and appropriate," before "members".

(b) HEALTH RESEARCH RELATING TO WOMEN.—
Section 7303(d) of such title is amended by adding at the
end the following new paragraphs:

21 "(3) The Secretary shall foster and encourage re22 search under this section on the following matters as they
23 relate to women:

24 "(A) Breast cancer and other primarily gender25 specific cancers that may relate to the military serv26 ice of women.

1	"(B) Gynecological and reproductive health, in-
2	cluding gynecological cancer, infertility, sexually-
3	transmitted diseases, pregnancy, and post-partum
4	phenomena.
5	"(C) Human Immunodeficiency Virus and Ac-
6	quired Immune Deficiency Syndrome.
7	"(D) Mental health, including post-traumatic
8	stress disorder, depression, combat related stress,
9	and trauma.
10	"(E) Diseases related to aging, including meno-
11	pause, osteoporosis, and Alzheimer's Disease.
12	"(F) Substance abuse.
13	"(G) Spousal abuse.
14	"(H) Sexual violence and related trauma.
15	"(I) Exposure to toxic chemicals and other en-
16	vironmental hazards, including the potential risk to
17	fertility and reproductive health.
18	"(J) Cardiac care and heart disease.
19	"(K) The comparative prevalence of
20	hysterectomies and other surgeries performed on
21	women who have served in the military.
22	"(L) The physical and psychological causes and
23	effects of homelessness among women veterans.
24	"(4) The Secretary shall, to the maximum extent
25	practicable, ensure that personnel of the Department of

Veterans Affairs engaged in the research referred to in
 paragraph (1) include the following:

3 "(A) Personnel of the geriatric research, edu4 cation, and clinical centers designated pursuant to
5 section 7314 of this title.

6 "(B) Personnel of the National Center for Post7 Traumatic Stress Disorder established pursuant to
8 section 110(c) of the Veterans Health Care Act of
9 1984 (Public Law 98–528; 98 Stat. 2692).

"(5) The Secretary shall ensure that personnel of the
Department engaged in research relating to the health of
women veterans are advised and informed of such research
engaged in by other personnel of the Department.".
